SB 1383

- California's state law aimed at reducing organic waste in landfills to fight climate change
- Key focus:
 - Reducing greenhouse gas emissions and increasing recycling efforts
- Mandates specific procurement requirements, including paper products

Paper Procurement Requirements



SB 1383 requires that jurisdictions purchase paper products with a minimum % of recycled content



Documentation and recordkeeping are mandatory for compliance



Compliance ensures that paper products meet sustainable standards (e.g., 30% post-consumer recycled content)



Not all products have the same recycled content requirements. It's essential to check the specific requirements for each product type before making a purchase.

Paper Procurement Requirements

Paper products should consist at least 30 % by fiber weight of postconsumer recycled content fiber, except for those listed below	
Toilet seat covers	10%
Facial tissues	10%
Toilet paper	45%
Paper towels	40%
General purpose paper wipers	40%
Food service ware (plates, takeout boxes, napkins etc.)	40%

SB 1383 Paper Procurement Requirements

Effective January 1, 2022, SB 1383 mandates that jurisdictions—defined as cities, counties, or special districts providing solid waste collection services—must purchase recyclable paper products. This requirement applies when such products are available at competitive prices and meet performance standards. The regulation covers all paper products, including printing and writing paper. Below are examples of commonly purchased paper products by local governments.

Printing & Writing Papers

- Copy paper
- Watermark
- Note pads
- Offset

Paper Office Supplies

- File folders
- Envelopes
- Sticky notes
- Boxes &
 packaging

Printed Materials

- Calendars
- Brochures
- Magazines
- Posters
- Newsprint

Janitorial Papers

- Toilet paper
- Paper towels
- Facial tissues
- Toilet seat covers

Paper products should consist at least 30% by fiber weight of postconsumer recycled content fiber, except for those listed below

Toilet seat covers	10%
Facial tissues	10%
Toilet paper	45%
Paper towels	40%
General purpose paper wipers	40%
Food service ware (plates, takeout boxes, napkins etc.)	40%

Record Keeping

Jurisdictions must keep records verifying the post-consumer recycled content and recyclability of all paper purchases, which should include the following:

- Copies of invoices, receipts, vendor reports, or other proof of purchase that specify the volume and type of paper products procured.
- Written certification(s) confirming the recycled content of each paper product, which can be obtained from:
 - Paper vendors, such as usage reports
 - Manufacturer or vendor websites
 - Product labels, invoices, receipts, etc.
- Written documentation from the vendor certifying that the products are recyclable.
