Thank you for your comments to the City Council regarding their upcoming consideration of the termination of the massage moratorium. We are glad that you recognize the City's efforts in addressing the illicit massage issue. It has been a lot of work, but with the Council's directive on this, we have achieved a great deal of success in closing illicit establishments in our City through our enforcement actions.

Your comments that the City should continue with the moratorium will be forwarded to the Council.

I would like to suggest that you may want to review the staff report that has been prepared for this item, as that will explain the purpose of the moratorium, as well as the study that was conducted as to whether any zoning tools could be developed to further address the issue and the staff conclusions and recommendation. The report also includes a update of the enforcement activities. For the staff report, you can go to http://www.cityofsanrafael.org/meetings and look under "upcoming meetings and events", then click on the "agenda" link for "City Council, October 5, 2015" and the massage item is agenda item #5. Click on that agenda item link and it will open up the staff report. Also, we had made a presentation to the Council at their last meeting, on the same topic and update on the research at their September 21st meeting and you can watch that video by clicking here

Two important notes. First, in regards to a moratorium, a City cannot adopt a moratorium in perpetuity. A moratorium is a tool that cities have to have to allow for a temporary pause, upto a maximum of 2 years, to allow the city to study a use and see whether any changes to the zoning code are feasible and/or necessary. Second, this recommendation for terminating the moratorium does not effect the city's on-going enforcement efforts. Those enforcement efforts are on-going and currently funded through end of June 21016. The Council has heard from many people about the need to continue with enforcement to ensure these issues do not return
