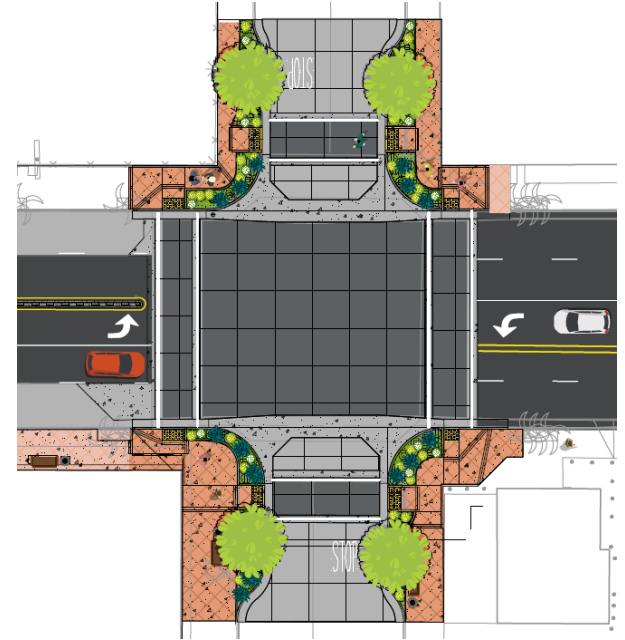

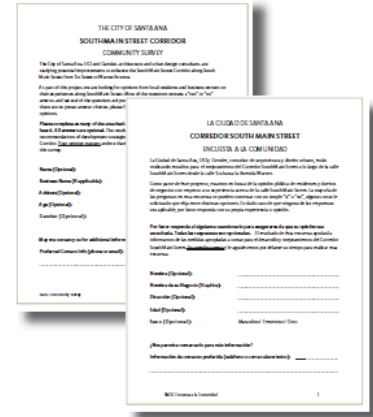

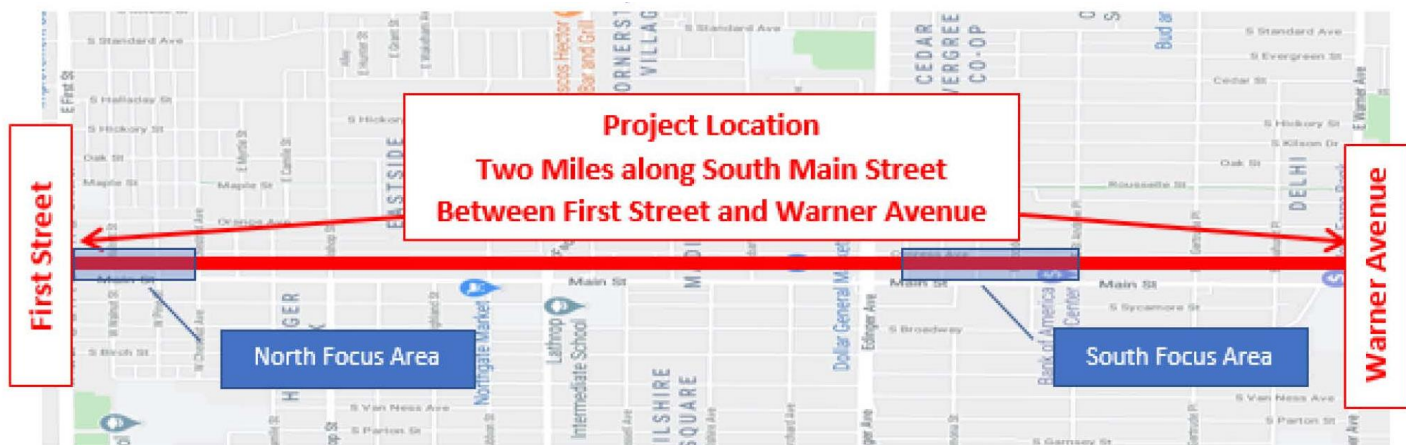

## TWO FOCUS AREAS ESTABLISHED BY VISION PLAN

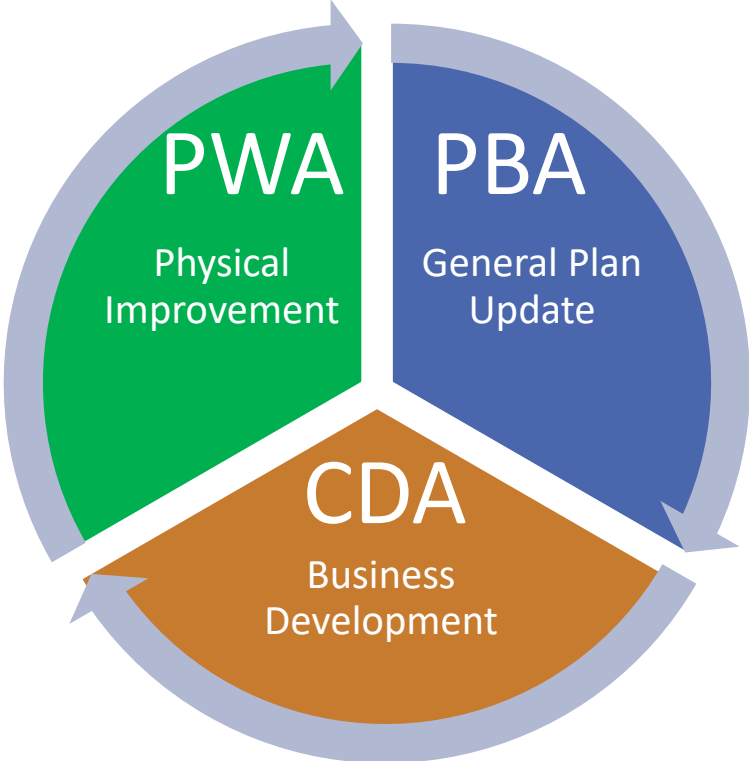
- North Focus Area:

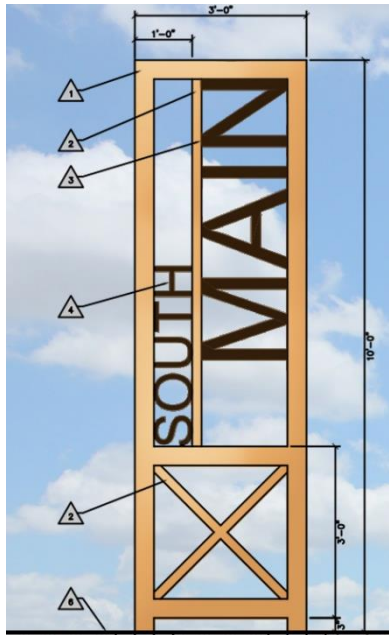

- Enhanced Crosswalks, ADA curb ramps
- Delineated Parking Spaces
- Street Trees & Landscaping
- Concrete Intersections
- Sidewalk Furniture
- Monument Signage & Banners
- Pedestrian Level Street Lighting
