this date of the requirement to obtain a City of Santa Ana "Home Occupation Permit" for
any business activity conducted or transacted out of any home residence situated in the
City of Santa Ana.

I hereby declare that in connection with my City of Santa Business License, No.
_____, issued to me on this date, I will not **"transact and carry on"** as
defined under Section 21-3 of the Santa Ana Municipal Code any business activity at the
hereinabove-referenced residence without first amending my business license to do so and
without first obtaining a valid "Home Occupation Permit".

In addition, I further declare that except as I may act in my capacity as an **"Independent
Contractor"** as defined under Section 21-3 of the Santa Ana Municipal Code, I will not
"transact and carry on" any business activity at any other residential or non-residential
location within the City of Santa Ana without first amending my business license to do so
and obtaining the appropriate "Home Occupation Permit" or "Certificate of Occupancy".
