ORDINANCE NO. NS- 2136

AN ORDINANCE OF THE CITY OF SANTA CERTAIN PROPERTY ANA REZONING LOCATED AT 303-321 SOUTH ORANGE AVENUE AND 309 EAST CHESTNUT AVENUE (MULTIPLE-FAMILY FROM THE R3 DISTRICT TO THE **R1** RESIDENCE) USE (SINGLE-FAMILY RESIDENCE) DISTRICT.

WHEREAS, Amendment Application No. 1040 has been filed to make certain changes in the zoning district designation of certain real property located at 303-321 South Orange Avenue and 309 East Chestnut Avenue as hereinafter set forth; and

WHEREAS, this Council, prior to adopting this ordinance, has reviewed the initial environmental study prepared for this project, and has approved the Negative Declaration for this project based thereon; and

WHEREAS, this Council, after duly noticed public hearing has determined that the change in use district designation proposed in the abovesaid Amendment Application is justified by the public necessity, convenience and general welfare;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA ANA DOES ORDAIN AS FOLLOWS:

1. That parcel of real property designated in Exhibit A, attached hereto and incorporated herein by reference is hereby reclassified from the R3 (Multiple-family residence) District to the R1 (Single-family residence) District.




