	Act. Any improvements or alterations to property which require building permits must be		
	submitted to the Building Safety Division separately for review/approval. This includes

7	For each manager, employee, volunteer, a fully legible color copy of one valid government		
	issued form of photo identification, two passport photographs, live scan results and the		
	original legible, completed employee application for each manager, employee or volunteer.		
8	If the Medical Marijuana Collective is a corporation, a certified copy of the Collective's		
	Secretary of State Articles of Incorporation, Certificate(s) of Amendment, Statement(s) of		
Ŭ	Information and a copy of the Collective's Bylaws. Note: Medical Marijuana Collectives		
	may not be organized or operated on a for profit basis.		
9	If the Medical Marijuana Collective is an unincorporated association, a copy of the Articles		
10	of Association. A copy of the applicant's Board of Equalization Seller's Permit.		
10	A copy of the Medical Marijuana Collective Operating Standards with a statement dated		
11	and signed by the responsible party on-site stating under penalty of perjury, that they read,		
11	understand and shall ensure compliance with the aforementioned operating standards.		
12	Make an appointment with Code Enforcement to have an inspection done.

13	A cashier's check or money order in the amount of \$12,086.00 paid to the order of the City		
13	of Santa Ana. This payment is NON-REFUNDABLE and no cash will be accepted.
