The City's goal is to ensure all Registration Applications received are complete and eligible for the Selection (lottery) Process

Background

- Measure BB (Ordinance 2864) was passed by the voters on November 4, 2014
- The Ordinance outlines a two-step process for the selection and approval of medical marijuana collectives/cooperatives
- <u>Step #1</u> Registration Application
 - Verify that specific locations submitted by the applicants meet zoning and separation requirements and are eligible for the Selection (lottery) Process
- Step #2 Regulatory Safety Permit
 - Thorough background check and review process to ensure that the applicant meets the rules and regulations contained in the Ordinance


Registration Application

Section 18-615. Zones permitted

A collective may only operate in an industrial zone (M-I or M-2) in accordance with this Article.

Section 18-616. Separation requirements

No collective shall be located within 500 feet of another medical marijuana collective or cooperative or within 1,000 feet of any school, park or residential zone.



Registration Application Submittal Checklist

- To ensure that your application is complete, the City has provided a Submittal Checklist containing all of the components of the Registration Application:
 - General Information
 - Aerial Photo / Map (Must note main entrance)
 - Owner/Lessor disclosure affidavit (Must be notarized)
 - Longitude / Latitude coordinates step-by-step guide
 - Processing Fee (Non-refundable)


Use Disclosure Affidavit

- Notarized Signature from the property owner or Lessor acknowledging that the location will be used as a medical marijuana collective if selected
- Sample notary document included in the application packet
- If there are more than three signatures required please print and use an additional page.



- You must provide the exact longitude / latitude coordinates for the main entrance (front door) of your proposed location
- 500-foot separation between collective locations will be measured from collective entrance to entrance
- Roll-up doors may not be considered the main entrance
- In multi-tenant buildings, identify the front door to the building
- Main entrances may be verified by City staff during the review period

500-Foot Entrance-to-Entrance Example





- A step-by-step guide has been provided in the Registration Application packet
 - Google Maps will provide specific coordinates
 - Zoom in to your proposed location
 - Locate the main entrance (front door) on the aerial photo
 - Right click the mouse at that location
 - Select "what's here?"
 - The Longitude / Latitude of that exact location will then be displayed in the upper left portion of the screen
 - Record those coordinates on the General Information page (section II)
 - Click on the Coordinates and then print the screen showing the point

Attachment 1 - Map Coordinates

Section 18-616 of the Santa Ana Municipal Code specifies that no collective/cooperative shall be located within 500-feet of another medical marijuana collective/cooperative. Longitude and latitude coordinates are required to be provided by the applicant to specify the location of the main entrance of the proposed medical marijuana collective/cooperative which will form the basis for the 500-foot separation requirement. Map coordinates are easily obtained from Google Maps using the following steps:


<u>Step # 1 -</u> Open Google from your internet browser and then enter the address for the property you are proposing.


<u>Step # 2 -</u> Open the resulting map and zoom in as neccessary. Place the mouse pointer on the proposed main entrance to the collective/cooperative, right click and select "what's here?"



<u>Step # 3 -</u> The map coordinates will then be displayed near the upper left corner of the screen in the following format: <u>XX.XXXXXX , -XXX.XXXXXX</u>. These will be the numbers entered in Section II of the General Information Form.

- Applications are available:
 - I. Online at: www.santa-ana.org/cannabiscollectives
 - 2. Limited number of hard copy applications are available at the sign-in table
 - 3. Planning Division public counter at City Hall (20 Civic Center Plaza)
- Once your application is complete and you are ready to submit, applications
 will be accepted at the Planning Division counter during regular business hours
- Planning Division counter staff will not be checking the applications for compliance. The staff will only log the applications in to the City's database and collect the non-refundable fee
- It is your responsibility to ensure that the application is complete
- Applications by mail, e-mail or fax WILL NOT be accepted




- The City Council established a processing fee of \$1,690 for the Registration Application
- Payment may be made by Cashier's Check, Money Order or Cash only
- Credit cards and Personal/Company Checks <u>will not</u> be accepted
- This fee is **non-refundable**



- The Registration Application Period is December 17, 2014 through January 15, 2015 at 5:00 p.m.
- All complete applications received during the application period that meet the zoning and separation criteria will be qualified for the Selection Process (Lottery) on February 5, 2015
- No preference/priority is given based on when the application is received
- Listed Primary Contact(s) will be notified if the applicant is eligible and has qualified for the Selection Process by January 26, 2015

Important Things to Consider



 The entire building must be outside of the 1,000 foot buffer zones from schools, parks and residential zones

 Eligibility maps are posted on the City's website

Important Things to Consider Continued

 You <u>may not</u> submit multiple applications at the same location

You may submit applications for multiple locations

 Property Owners may sign multiple Use Disclosure Affidavits for different collectives at the same location
