General Overview



Executive Summary

The City of Santa Ana has put their State and Local Fiscal Recovery Fund (SLFRF), together with state and federal funds for emergency rental assistance, into a comprehensive pandemic-recovery plan called Revive Santa Ana.

The Revive Santa Ana spending plan is designed to provide short-term financial and health assistance, as well as address long-term health, education, youth, and other needs in response to the COVID-19 pandemic. It includes five funding categories: public health and safety, direct assistance, recovery from the pandemic, critical infrastructure, and city fiscal health.

During the first year of the program, we have planned 56 projects, of which 32 have had expenditures. The majority of Santa Ana's programs are in expenditure category 2: Negative Economic Impacts, focusing on providing services for our residents within the US Department of Housing and Urban Development's (HUD) designated qualified census tracts (QCTs).

City Fiscal Health

Prioritize the allocation of city resources to ensure an efficient and expeditious execution of relief funds in compliance with federal guidelines while supporting the long-term priorities of the City's strategic plan.

Public Health and Safety

Provide a safe environment for residents and visitors while reducing crime and addressing the impacts of COVID-19 on our health and quality of life.

Critical Infrastructure

Ensure maintenance and preservation of City facilities and roadways to provide safe and accessible public spaces that better serve the population and visitors.

Recovery from the Pandemic

Support equitable distribution of vital public health information and resources and reduce the spread of COVID-19 resources.

Direct Assistance Programs

Provide direct financial and nutritional resources to residents, businesses and non-profit organizations that have been financially constrained as a direct result of the pandemic.

The key outcomes and goals are different depending on the specific project. Detailed goal information is included in the Project Inventory Section of this report.



Uses of Funds

The City of Santa Ana's spending categories are different from the Treasury's expenditure categories, so below are tables of the projects by City Category, as well as by Expenditure Category (EC).

The City of Santa Ana received Emergency Rental Assistance funds as well as SLFRF. The City received \$9,880,391 in ERA1 funds, of which 100% had been distributed by October 2021. On May 18, we began spending State ERA2 funds. Thus far, we have obligated \$3,092,543.37 and expended \$2,364,711.00 of State ERA2 funds for a weekly average of \$337,474 in emergency rental assistance payments. Our continual goal has been to distribute \$500,000 a week of emergency rental assistance payments. We have assisted over 300 households with back rent and three months of forward rent in order to provide housing stability for these families. Sixty-three of the 300 households had been issued eviction notices, and through the program, we have been able to prevent the eviction process and keep these families in their homes. We anticipate to fully expend the \$9.2 million in State ERA2 funds by the end of September 2022.

We continue to process and re-certify existing families by providing back rent and forward rent payments. We are prioritizing cases with eviction notices, as we continue to take applications over the phone and/or refer applicants for a walk-in appointment at one of our partner non-profits. For cases where the landlord has escalated to filing an unlawful retainer directly to the court, we work directly with the landlord and make an extended effort to keep communication open and expedite rent payments in an attempt to keep these cases from reaching the court and prevent these families from facing eviction.

Promoting Equitable Outcomes

Introduction

The City of Santa Ana is committed to making our City a place where everyone can thrive. We strive to incorporate equity and inclusion as we invest our Coronavirus SLFRF through our Revive Santa Ana spending plan. Our goal is to be a city where everyone can reach their highest level of health and potential for a successful life, regardless of background, neighborhood, or identity. We do this by engaging community voices to inform the design of policy, making inequities visible using data, and making strategic, data-driven investments in historically underserved communities to provide them with equitable access to programs and services.

A history of unfair laws and practices, in the U.S. and in Santa Ana, created significant racial and social inequities that affect our economic well-being, our neighborhoods, and our health. Hiring discrimination, laws about who could buy houses and where, and poorly-funded schools created many obstacles for people of color and low-income residents. These inequities are not random—they have been created and sustained over time and they will disappear only if we are proactive and collaborative.

Exciting progress is happening in Santa Ana! We are creating increased mobility options such as bike lanes and walking paths across the City and adding new park spaces and programming. We created a justice fund for immigrants facing deportation, and hired an Equity and Inclusion Coordinator and Vietnamese Community Liaison to partner with City departments and community members to create and implement policy and programming that highlight and build upon our communities' strengths.

Background

Santa Ana is known for its international and diverse population. As the county seat and the oldest city in Orange County, Santa Ana is a major gateway for newcomers from all over the world, particularly Latin America, Southeast Asia, and the Philippines. The various ethnic groups that constitute Santa Ana's population have helped create a rich pattern of cultural experiences and diversity. Although 77 percent of the city's population is Hispanic (based on 2020 Census), Santa Ana has one of the largest and faster growing Vietnamese-American populations in the county, representing 8 percent of the city's total population.

According to the 2014-2018 American Community Survey, Santa Ana has a large population of foreign-born residents—45 percent are foreign born compared to 30 percent countywide. During the 1990s, one in every four immigrants to Orange County moved to Santa Ana. Though immigration has slowed in recent decades, Santa Ana continues to have one of the largest foreign-born populations in the region.

Per the 2015-2019 ACS, about 77 percent of the Santa Ana population identifies as being Hispanic or Latino of any race. In comparison, only 34.1 percent of Orange County residents identify the same. The City has a smaller population of White-alone residents compared to neighboring jurisdictions.



The Asian-alone population in Santa Ana (11.6 percent) is smaller than in surrounding cities (Anaheim, 16.6 percent; Tustin, 22.2 percent; and Garden Grove, 41.1 percent). However, the census tracts in the western part of Santa Ana have large concentrations of Asian residents. The Asian population increased by 11 percent between the 2010 and 2020 census, the majority of which was Vietnamese.

COVID-19 has had a significant impact on communities of color in the United States, who account for a disproportionate share of COVID-19 cases, hospitalizations, and deaths. More specifically in Orange County, data demonstrates the hot spots for COVID-19 are in cities such as Santa Ana. To tackle these negative COVID-19 impacts, the City has prioritized bringing testing, treatment, vaccinations, communication, messaging, and education directly to the most impacted neighborhoods. As we continue to implement Revive Santa Ana, the City of Santa Ana will continue to invest in hard-to-reach populations and communities that face barriers to care because of their race, ethnicity, immigration status, and/or neighborhood.

Community Engagement

In developing the Revive Santa Ana spending plan, city staff worked directly with the community to hear their voices and include their input as part of the plan. Notice of the process of the creation of a spending plan was done through public meetings, town halls, and a community survey where residents were able to voice their opinions on what aspects of the City could benefit most from the funding. The first engagement opportunity was a community budget meeting on March 25, 2021, where community members were able to give input on the proposed spending plan. Additionally, the City launched a community feedback survey, available in English, Spanish, and Vietnamese, to gauge the community's thoughts on how the City should spend its Revive Santa Ana funding. The survey was available online and was distributed on the City's digital communications channels. Additionally, print surveys were available and shared at the City's main library and at City Hall. In total, 1,579 responses were collected. The findings of the survey were shared with the City Council.

The City Council discussed Revive Santa Ana at several public meetings, including on March 16, May 18, May 24, June 1, and June 3, 2021. Several iterations of the Revive Santa Ana Spending Plan have been shared and discussed, whose changes reflect discussions by the City Council, comments from community members, and changing guidance from the U.S. Department of the Treasury relating to how the funds could be expended.



Qualified Census Tracts

In an effort to ensure equitable spending and outcomes of SLFRF, the City of Santa Ana has evaluated each project to determine if the project will be completed within or a primary service will be provided to a Qualified Census Tract (QCT), or if the project or service will be provided to a population that is assumed to have been affected negatively by the COVID-19 pandemic.

QCTs are a common, readily accessible, and geographically granular method of identifying communities with a large proportion of residents experiencing low-income. The City of Santa Ana is committed to monitoring the proportion of funds dedicated to these areas as an initial indicator of equitable spending. While



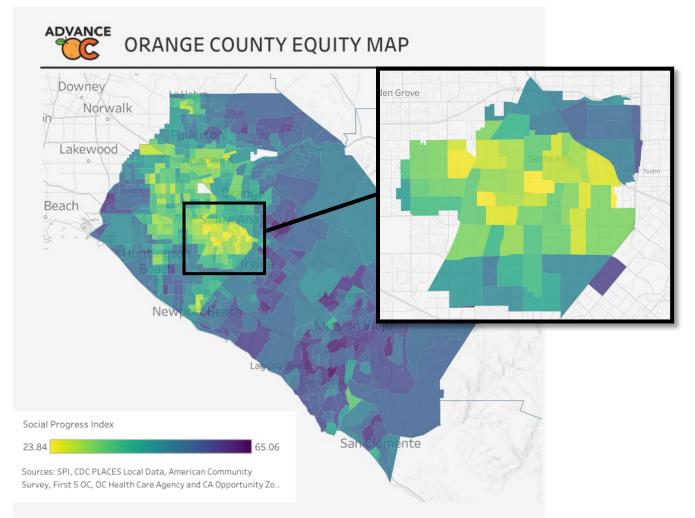
QCTs are not all-inclusive of community needs, monitoring and tracking funding dedicated in these areas allows for an efficient implementation of spending while identifying areas of need at a highly localized level.

The SLFRF Final Rule acknowledges that some populations are assumed to be negatively impacted, either through negative impacts to health or economy, or through the exacerbation of pre-existing disparities. Certain industries are assumed to be negatively impacted, including tourism, travel, and hospitality, as well as non-profits and small businesses. Additionally, the SLFRF Interim Final Rule states that certain populations are assumed to be negatively impacted by the pandemic, including low- and poverty-level households, racial and ethnic minorities, adult residents with low educational attainment, and those experiencing mental health or substance abuse challenges, among others.

Social Progress Index

The Orange County (OC) Social Progress Index (SPI) measures the relative levels of social progress for every census tract in OC using a sophisticated framework of standardized indicators. The SPI combines 50 social and environmental outcome indicators to calculate an overall score for these tracts, based on tiered levels of scoring that include measures in health, safety, education, technology, rights, and more. The SPI Scores for each census tract is displayed on a map of Orange County. Yellow indicates lower scores, while Purple indicates higher scores. As shown on the OC Equity Map below, the City of Santa Ana has some of the lowest SPI scores in the entire county.





Strategic Implementation of Existing Long-Range Plans

The City of Santa Ana recently adopted a new General Plan, Golden City Beyond. For the first time, the City included an Environmental Justice element and a focus on equitybased policies. To complement the new General Plan, a Parks Master Plan was recently completed and includes an equity analysis with recommendations for new parks and open spaces in underserved residential areas. Unserved residential areas were considered "high severity of need" if three or more of the following metrics applied to them:

• Environmental Justice Communities: Environmental Justice (EJ) Communities were identified through the General Plan process using CalEnviroScreen 4.0 data. These disadvantaged areas are disproportionately burdened by multiple sources of pollution, socioeconomic issues, and health issues. These areas also tend to experience lower rates of investment and improvement. Santa Ana has 24 census tracts identified as environmental justice communities. Addressing ways to provide residents within these communities with park resources and increased access to open space is a priority for the City of Santa Ana.



- Land Use Element Focus Areas: The City has identified five focus areas along major corridors as most suitable for new development. Focus Area boundaries are taken from the General Plan, Land Use Element (LUE).
- Below the Poverty Level: Using U.S. Census data, tracts with greater than 20% of it residents living below the poverty threshold were noted. (The overall U.S. 5-year ACS poverty rate from 2015-2019 was 13.4%).
- Majority Non-White: Census tracts with populations for which the racial majority (50% or more) is non-white or Hispanic/ Latino were identified.
- High Projected Population Density: High-density areas with 15 dwelling units per acre or more were identified based on General Plan residential land use designations and densities.

In keeping to our General plan and Parks Master Plan and to best serve our residents in an equitable way, Revive Santa Ana projects are concentrated in these underserved areas.

Labor Practices

To promote effective and efficient delivery of high-quality infrastructure projects while also supporting the economic recovery through strong employment opportunities for workers, the City of Santa Ana uses a community workforce agreement with the Los Angeles/Orange Counties Building and Construction Trades Council and the signatory Craft Councils and Local Unions. The community workforce agreement applies to multitrade construction contracts exceeding \$250,000 and specialty contracts over \$100,000 limited to a single trade or scope of work. Additionally, the City of Santa Ana's Purchasing Policy includes a local preference provision, which encourages the City to use Santa Ana- and Orange County-based vendors to procure goods, services, and professional services. Finally, regarding prevailing wages, California law requires that not less than the general prevailing rate of per diem wages be paid to all workers employed on a public works project. This applies to public works projects in Santa Ana.

Use of Evidence

The use of evidence is different depending on the specific project. Detailed evidence information is included in the Project Inventory Section of this report.



Performance Report

With so many different projects, we have a variety of performance management tools in use. The City is working on hiring a full-time Management Analyst to track performance and maintain reporting standards across the various projects. This effort should allow stakeholders to have access to publicly reported information on expenditures, performance, and delivery in order to be transparent with the community and hold the City accountable to results and continuous improvement. More detailed performance metrics are below in the project inventory.

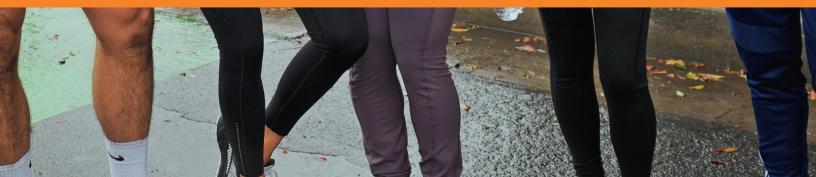

Project 221341: First Street Slope Stabilization Project

The railroad undercrossing along First Street, between Standard Avenue and Grand Avenue, consists of four dirt slopes. The dirt slopes are severely eroded, which facilitates the discharge of sediment into the street and City storm drain system during rain events. Additionally, encampments that form at the top of the slopes lead to the discharge of trash and debris. The goal of the project is to improve water quality and address stormwater pollution via the stabilization of the dirt slopes, elimination of trespassing and encampments, and installation of a stormwater treatment device. The project will also improve pedestrian safety and significantly enhance the aesthetics of this important gateway to Downtown Santa Ana. Construction of this project is anticipated to start in October 2022 and be completed in May 2023.

Increasing greenhouse gases and water temperatures caused by climate change can be harmful to wildlife and marine habitats. Additionally, the installation of fencing and hardscape is a lower energy method of improving water quality than an active treatment system downstream, for example.

- The intended outcomes of CP-CAP are to assist commercial property owners negatively and/or adversely affected by the COVID pandemic and enhance collaborative code enforcement efforts with façade improvements for shopping centers of vacant storefronts within QCTs. The program will complement and further contribute to the recovery efforts of commercial properties negatively affected by the pandemic.
- Applicants must have their improvements pre-approved before receiving final approval. Improvements approved through the program must be completed within 100 calendar days of receiving final approval from the City. Program protocol requires applicants to have an initial inspection and a final inspection to review façade improvements. During the final inspection, if passed, the applicant will receive a Notice of Completion from the City, indicating that all conditions of the application and proposed improvements have been completed. Eligible improvements include those that enhance the appearance of the commercial façade/storefront

- With an overwhelming number of non-emergency homeless-related calls flooding into police dispatch, the City of Santa Ana has brought in a non-profit, City Net, to provide an innovative response to the situation. Calls and requests for service regarding non-violent mental health or substance abuse for individuals experiencing homelessness are directed to City Net instead of the police department.
- The goal of this program was to transition calls to subject matter experts who are highly trained in their profession of homeless services crisis intervention, mental health, addiction, and medical services in order to provide the best response to those in need. The Pilot program was named Santa Ana Multi-Disciplinary Homeless Response Team (SMART).
- Multidisciplinary teams consist of homeless services outreach workers, safety coordinators, and a dedicated live call center with trained dispatchers. Teams have direct access to professionals in the fields of medical, mental, and behavioral health to provide specialized interventions in the field as needed without the need for an additional call. Teams will work across the city seven days a week from 7:00 am- 9:00 pm, responding to the community's needs for homeless services interventions.

Staff-led programs will be delivered in the Library and throughout underserved areas of the community via various Library spaces to address inequities in early education and bridge the digital divide. These programs will increase physical access to technology, improve and enhance early childhood development and literacy, support positive educational outcomes for youth, and prepare our community's present and future workforce.
- These nine programming initiatives were launched in March 2022 and are ongoing. The Library utilized SLFRF funds to purchase equipment related to the programs and anticipates all funds to be fully expended by June 2023.
- Project partners comprise of several City of Santa Ana Departments including Public Works, Finance and Management Services and Information Technology. Other partners include the California State Library, local non-profit Child Creativity Lab, and the Friends of the Santa Ana Public Library.
- Measurable outcomes include reporting that 85-90% of participants will acknowledge the benefits of access to Digital Technology programming in helping them achieve their educational and/or work skills goals and future career prospects as well as an increase in comfort and confidence in their Digital Technology skills and knowledge.

Project 221304: Feasibility of a Public Health Department

Funding amount: \$200,000 Expenditure Category: 7.1 Administrative Services

Project Overview

The COVID-19 pandemic and its aftermath have raised community and public awareness of the importance of public health agencies. This unprecedented pandemic has also raised the expectations for public health departments to address substantial local health inequities amongst jurisdictions in the County. The City of Santa Ana, like many other California jurisdictions, is considering whether the current public health delivery structure is meeting the needs of its residents and requested proposals from qualified firms to perform a feasibility and fiscal evaluation of creating its own municipal public health agency. The consultant, Health Management Associates have been analyzing current public health structures and will provide a final document analyzing the feasibility and specific steps for the creation of a public health agency for the City of Santa Ana.

The proposed scope of work includes:

1. Regulatory and Statutory Requirements Analysis

- a. What are legally required mandates (state and federal) of public health departments?
- b. What are public health regulations and what are requirements to qualify for funding?
- c. What are the requirements of the regional health district?

- b. What are the specific health issues facing Santa Ana residents and related health priorities?
- c. How did OCHCA's COVID-19 response address the needs of the City of Santa Ana?

3. Current Service Level, Cost, and Revenue Analysis

- a. What are current in-house and contracted services provided by OCHCA and related service levels (mandated and additional)?
- b. What are current service levels and services to Santa Ana?
- c. What are current costs and funding sources?
- d. What has been OCHCA's COVID-19 response?
- e. What are existing OCHCA public health accreditations?

4. Comparative Analysis and Forecasting

- a. What are examples of comparative municipal models full service vs. limited service?
- b. What are the core public health services and related staffing, facilities, and certification requirements?
- c. What is the cost, service, and revenue data from these comparable municipal models?
- d. What are the lessons learned from these municipalities' experience and relevancy to Santa Ana?





The timeline for completion is 6-8 months. A final presentation to the City Council by the consultant was delivered on July 19th, 2022. The consultants are preparing their final report.

Project Goals

The goal of this project is to comprehensively explore the operational, fiscal, and policy implications of alternative models to public health delivery for the City of Santa Ana. Core to this project's success is a comprehensive understanding of public health delivery systems. The final deliverable will include a comparative analysis considering operational, cost, and revenue projections for the three alternative models: Full Service Municipal Health Agency; Limited Municipal Health Agency; and Regional Health Strategist position. A final report weighing the pros, cons, and considerations of each model will inform and serve as the foundation for the critical strategic conversations that will help City leadership proceed in the desired direction for the residents of Santa Ana.

The signs' messaging will be changeable so that it can be quickly updated with the timeliest information.



Project 221307: COVID-19 Sanitization Project

Funding amount: \$500,000 Expenditure Category: 1.4, Prevention in Congregate Settings

Project Overview

• The COVID-19 Sanitization Project includes the application of a special disinfection solution at congregate settings, such as high-contact surfaces and street furniture at bus shelters, to reduce the risk of community transmission of COVID-19 and its variants. The project started in October 2021 and was completed in March 2022.

Project Goals

• The goal of the project is to reduce the risk of community transmission of COVID-19 and its variants.

Use of Evidence

- The City of Santa Ana was severely impacted by COVID-19 and its variants. According to data from the Orange County Health Care Agency, Santa Ana had the second highest COVID-19 total case rate per 100,000 population in Orange County of 24,858.5¹.
- A significant portion of Santa Ana residents rely on public transportation to travel around the City. Bus shelters act as congregate settings where numerous residents are within close proximity to each other and are touching the same surfaces (i.e. benches, waste receptacles, signage, etc.). According to the USEPA "Guidance for Cleaning and Disinfecting", the targeted use of disinfectants can be done effectively, efficiently, and safely on outdoor hard surfaces and objects frequently touched by multiple people².
- The project featured the application of a Quaternary Ammonium disinfection solution (EPA #1839-168) that is on the USEPA List N Tool and eliminates SARS-CoV-2 from hard, non-porous surfaces³. The disinfection solution was applied to high-contact surfaces and street furniture at every bus shelter within Santa Ana to reduce the risk of community transmission of COVID-19 and its variants. The project started in October 2021, around the time when the Delta Variant was spreading through the community, and ended in March 2022.

- Output Measures: Sanitization of high-contact surfaces and street furniture at bus shelters
- Outcome Measures:
 - Number of bus shelters sanitized
 - During the project, all 588 City bus shelters were sanitized approximately eight times each.

Due to the COVID-19 global pandemic, enhanced sanitization and cleaning of high-traffic pedestrian and bicyclist areas is needed.
- On July 20, 2021, City Council approved the spending plan for Revive Santa Ana, which will be funded by the American Rescue Plan Act of 2021 (ARPA). The spending plan included a \$2,300,000 allocation for Sanitation & Prevention Programs to increase sanitization efforts of the public right of way areas, encourage healthy activities, improve recovery, and potentially reduce the spread of COVID-19.
- Amend/revise existing contracts with qualified contractors, to quickly implement the enhanced sanitization and cleaning services of high-traffic pedestrian and bicyclist areas.
- To fund the enhanced services, existing contracts were increased by \$1,000,000 for FY 2021-22. In addition, two Public Works Maintenance Worker II positions will be advertised with a five-year limited term, for a total cost of \$1,300,000. The positions will be limited-term given that ARPA funding guidelines require funding to be exhausted no later than December 31, 2026.

2) Provide outdoor exercising opportunities for underserved communities who may have no access to parks during the COVID-19 pandemic.

Use of Evidence

The primary goal of this project provide outdoor activity while mitigating the spread of COVID-19 by creating streets for outdoor connectivity, walkability, social interaction, and health benefits, all connected to improving conditions in an underserved high-density urban environment, which does not otherwise have access to parks and open space. SLFRF funds are not being used for evidence-base interventions.

This project has no funds towards evidence-base intervention. This project is under Category 2.22, Strong Healthy Communities: Neighborhood Features that promote Health and Safety. This expenditure category does not require evidence base intervention.

Project 221390: Stormwater Channel Fencing Upgrades Phase II

Funding amount: \$950,000 Expenditure Category: 5.6, Clean Water: Stormwater

Project Overview

- The Stormwater Channel Fencing Upgrades Phase II Project includes the design and construction of new fencing and barriers along City-owned stormwater channels. The goal of this project is to improve water quality and address water pollution. This project will also improve public safety as the stormwater channels will no longer be accessible to the public. Construction is anticipated to start in August 2022 and be completed in April 2023.

- This project addresses climate change by reducing water pollution and improving downstream water quality. Increasing greenhouse gases and water temperatures caused by climate change can be harmful to wildlife and marine habitats. The reduction of water pollution helps offset these negative impacts of climate change. Additionally, the installation of fencing and barriers is a lower energy method of improving water quality than an active treatment system downstream, for example.
