COMMUNITY DEVELOPMENT BLOCK GRANT

The U.S. Department of Housing and Urban Development (HUD), Community Development Block Grant (CDBG) program is a flexible program that provides communities with resources to address a wide range of unique community development needs. The program provides annual grants on a formula basis to entitled cities and counties to develop viable urban communities by providing decent housing and a suitable living environment, and by expanding economic opportunities, principally for low- and moderate-income persons.

Eligible Activities Requirement

CDBG eligible activities include, but are not limited to, public facilities and improvements, code enforcement, economic development, housing rehabilitation, and administration. The full listing of eligible activities is available at 24 CFR 570 Subpart C - Eligible Activities.

National Objective Requirement

Programs and projects must meet the National Objective of a benefit to low and moderate income individuals. This may be established through the following methods:

- Area Benefit Census block group data demonstrating the service area is at least 51% low and moderate income.
- Limited Clientele Income documentation demonstrating that participants in CDBG programs are low and moderate income.

City of Santa Ana Consolidated Plan Priority Need Requirement

Applications for Fiscal Year 2023-2024 must meet a Fiscal Year 2020-2024 Consolidated Plan priority need. Priority needs include: Housing Opportunities, Public Facilities/Infrastructure, Economic Development, Code Enforcement, and Administration.
