6. Fireworks Safety Video acknowledgement form
7. Complete membership roster listing including:
 - o Member names (Student names and grade levels for school and educational organizations)
 - o Residence addresses for verification
 - o Total number of all members and number of those residing within the City of Santa Ana

- **The non-profit organization is a bona fide nonprofit organization organized for public, educational, scientific, charitable, fraternal, veterans' organization or religious purposes with the principal and permanent meeting place within the limits of the City of Santa Ana.**
- **At least fifty percent (50%) of the membership resides within the limits of the City of Santa Ana and the attached membership roster is accurate and complete per application checklist item #7 above.**
