NOTICE OF PASS-THROUGH COMMODITY INCREASE Effective July 1, 2023

On November 19, 2019, the Santa Ana City Council adopted Resolution No. 2019-110, which authorized annual charges to water service fees and adjustments that “pass-through” increases in wholesale water costs. The amount of the adjustment, called the Pass-Through Charge, accounts for increases in wholesale water costs needed to operate the City’s water system.

The Pass-Through Charge incorporates cost increases from the following agencies:

- Metropolitan Water District of Southern California charges and rate increases for imported water.
- Orange County Water District (OCWD) charges and rate increases for groundwater basin storage and pumping management.

The Pass-Through Charge will be effective July 1, 2023. The impact on the commodity component is presented in the table below. Please note that the pass-through increases are based directly on the cost increases that the City will incur from the two water wholesaler providers listed above.

This 30-day notice is being provided in compliance with California Government Code §53755(a) and §53756(d). If you have any questions regarding how these adjustments may impact your water service, please feel free to contact the Water Resources Division at 714-647-3320.
