City Review

- Require additional Entitlement – General Plan Amendment from General Commercial 1.5 to Industrial Flex 1.5

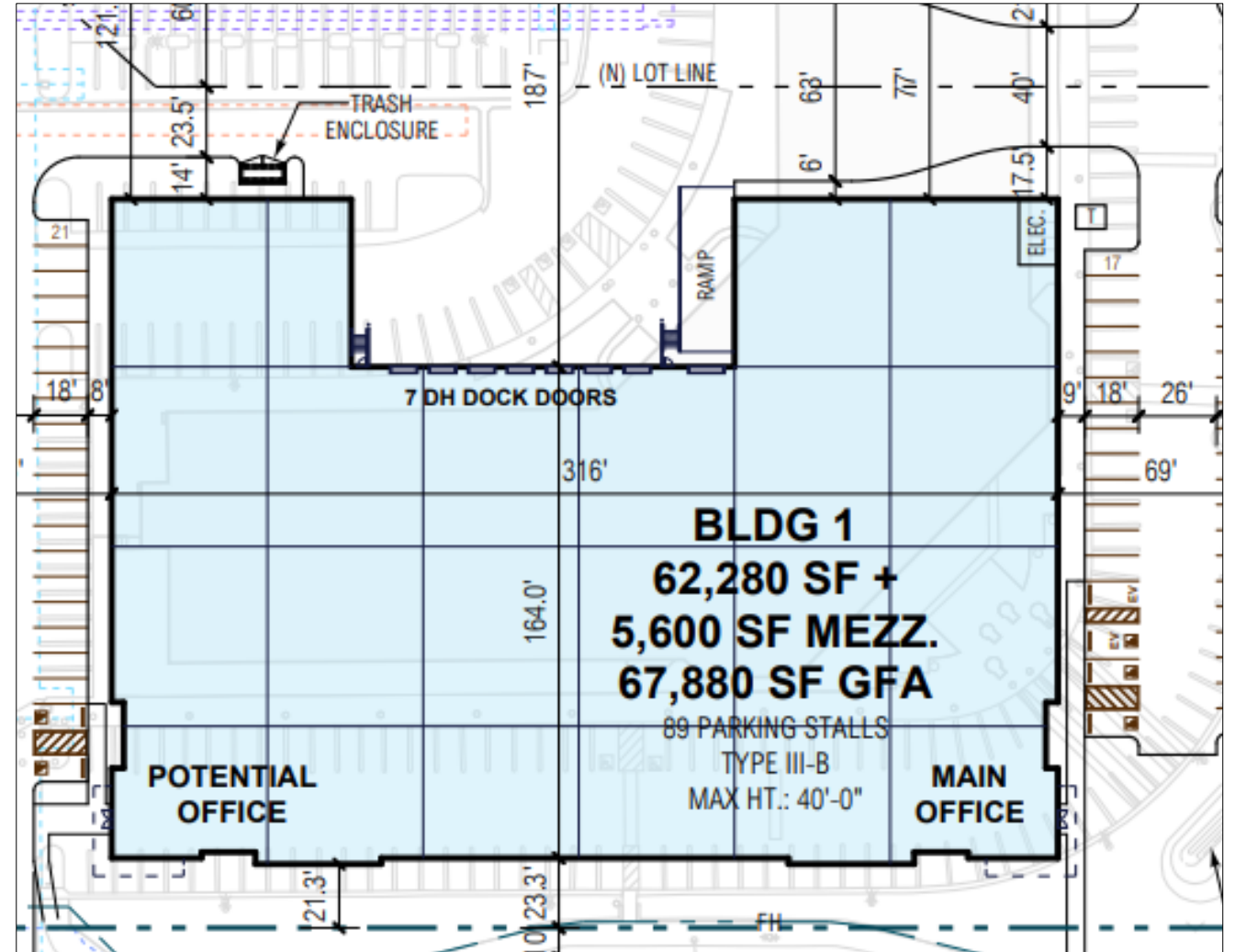

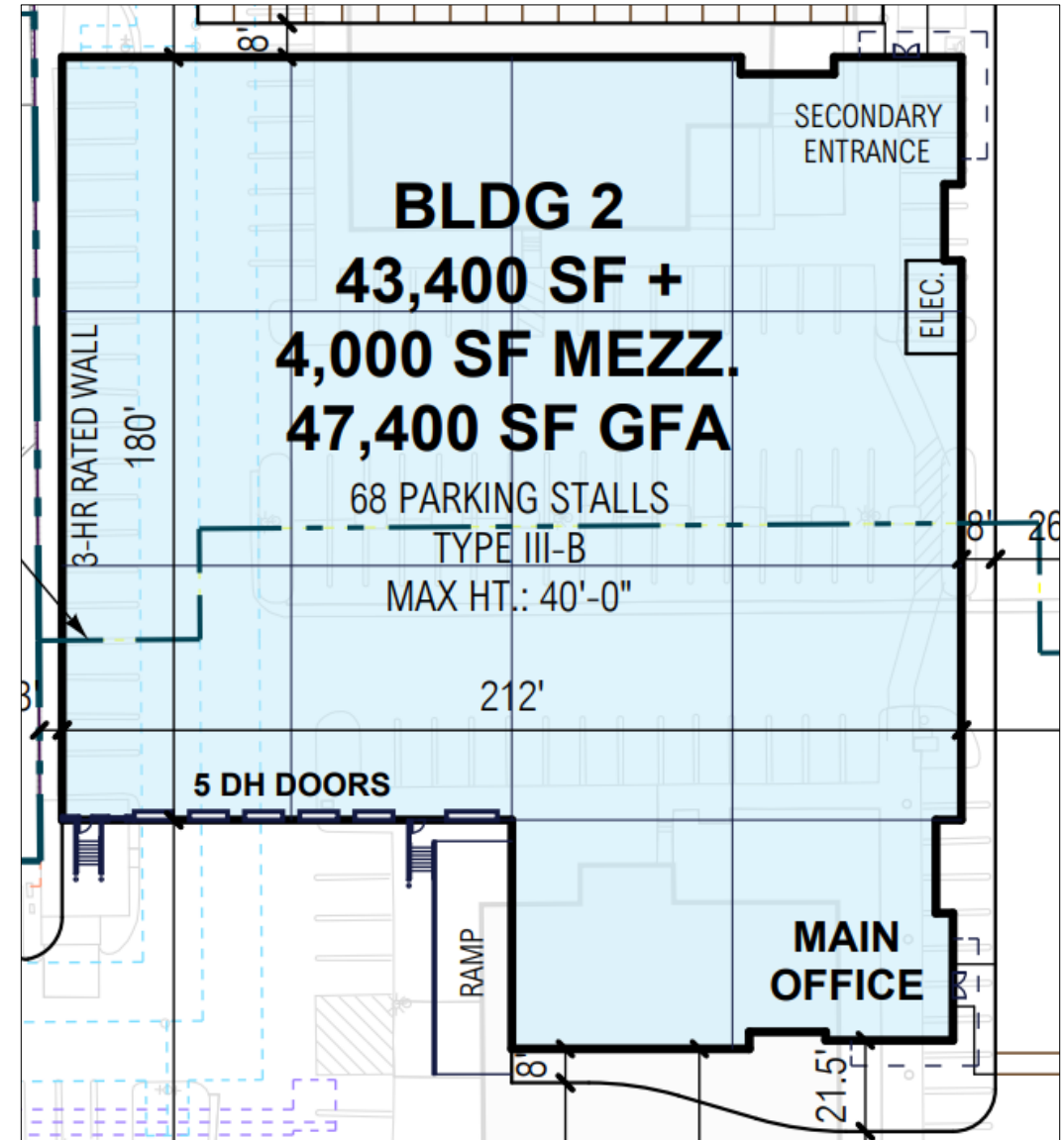

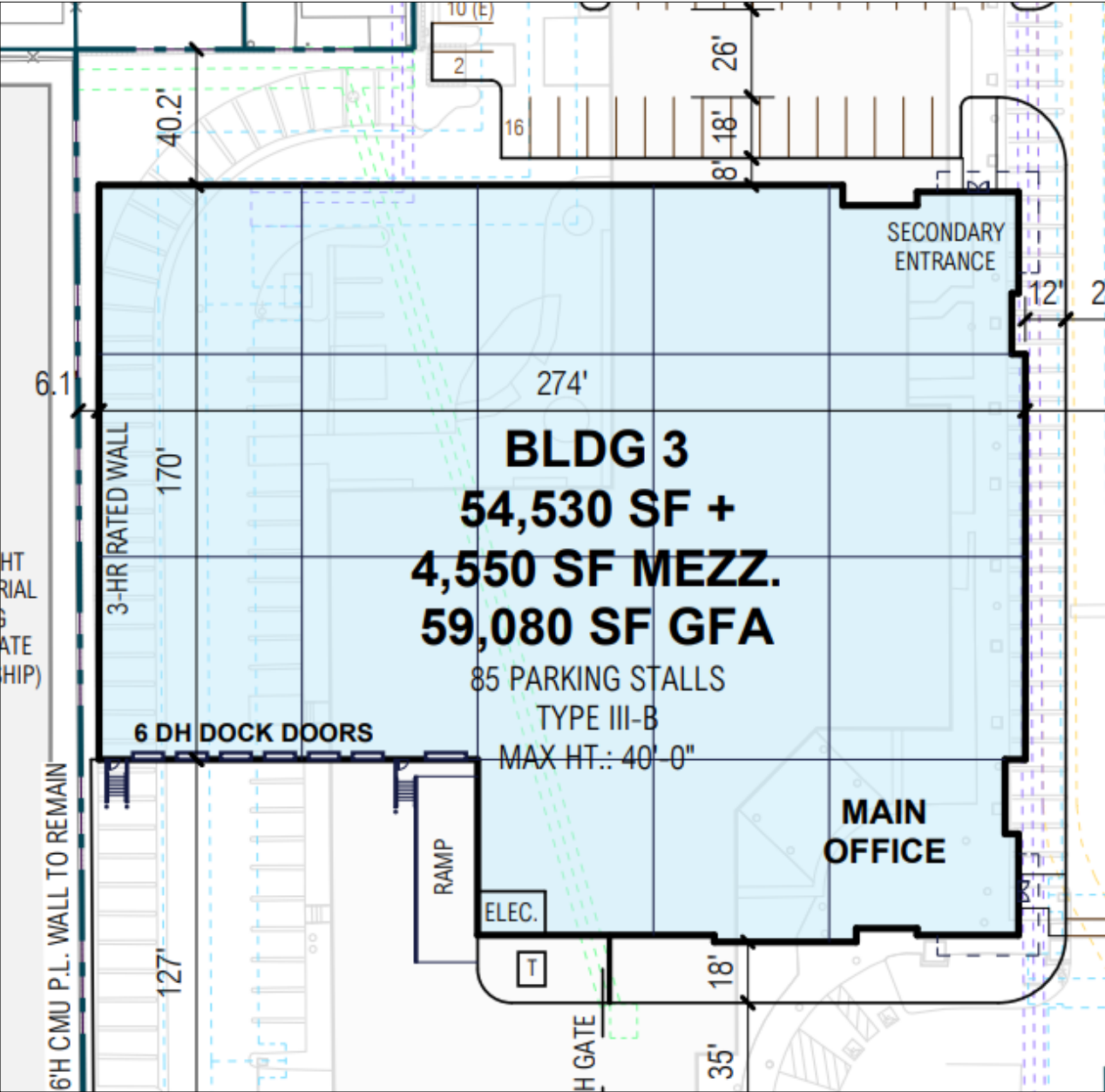

Park 55 Light Industrial Development Project

Held Tuesday October 24th, 2023 at 6 PM (in-person and via Microsoft Teams)

In compliance with the Sunshine Ordinance, a community meeting was held in person at 1251 East Dyer Road, Suite 100, Santa Ana, CA 92705 and virtually via Microsoft Teams on October 24, 2023 from 6:00 pm – 7:00 pm. Notice mailers were distributed to property owners and tenants/renters having a valid US Postal Service address within a 2,000-foot radius of the project site within the City boundary and a 300-foot radius of the subject property where the notification radius extends over the City boundary into an adjacent jurisdiction.

Two members of the community attended the virtual meeting and no members of the community attended the in-person meeting. Richard Ellison from Greenlaw Partners presented an overview of the project and the proposed changes based on City comments. Three questions were asked verbally during the comments and questions portion. These questions are documented below. While the discussion ended at 6:30 pm, all representatives from the City and Developer team stayed on the virtual meeting and at the venue until 7 pm to see if other community members showed up. No additional community members showed up virtually or in-person.

Community Questions and Comments

Question: Does the 2024 construction start date include demolition.

Response: Yes. However, note that this is an estimated construction start date.

Question: Do you anticipate rail traffic to increase?

Response: No, the project would not be served by rail.

Question: Is the requirement for clean industrial uses an option or requirement under the new General Plan land use?

Response: The Industrial Flex 1.5 land use allows for clean industrial uses that do not produce significant air pollutants, noise, or other nuisances typically associated with industrial uses, including office industrial flex spaces, small-scale clean manufacturing, research and development and multilevel corporate offices, commercial retail, artist galleries, craft maker spaces, and live-work units. The City has indicated that the Project requires a General Plan Amendment to change the land use from General Commercial to Industrial Flex. Thus, it would be required that the project provide a clean industrial use.
