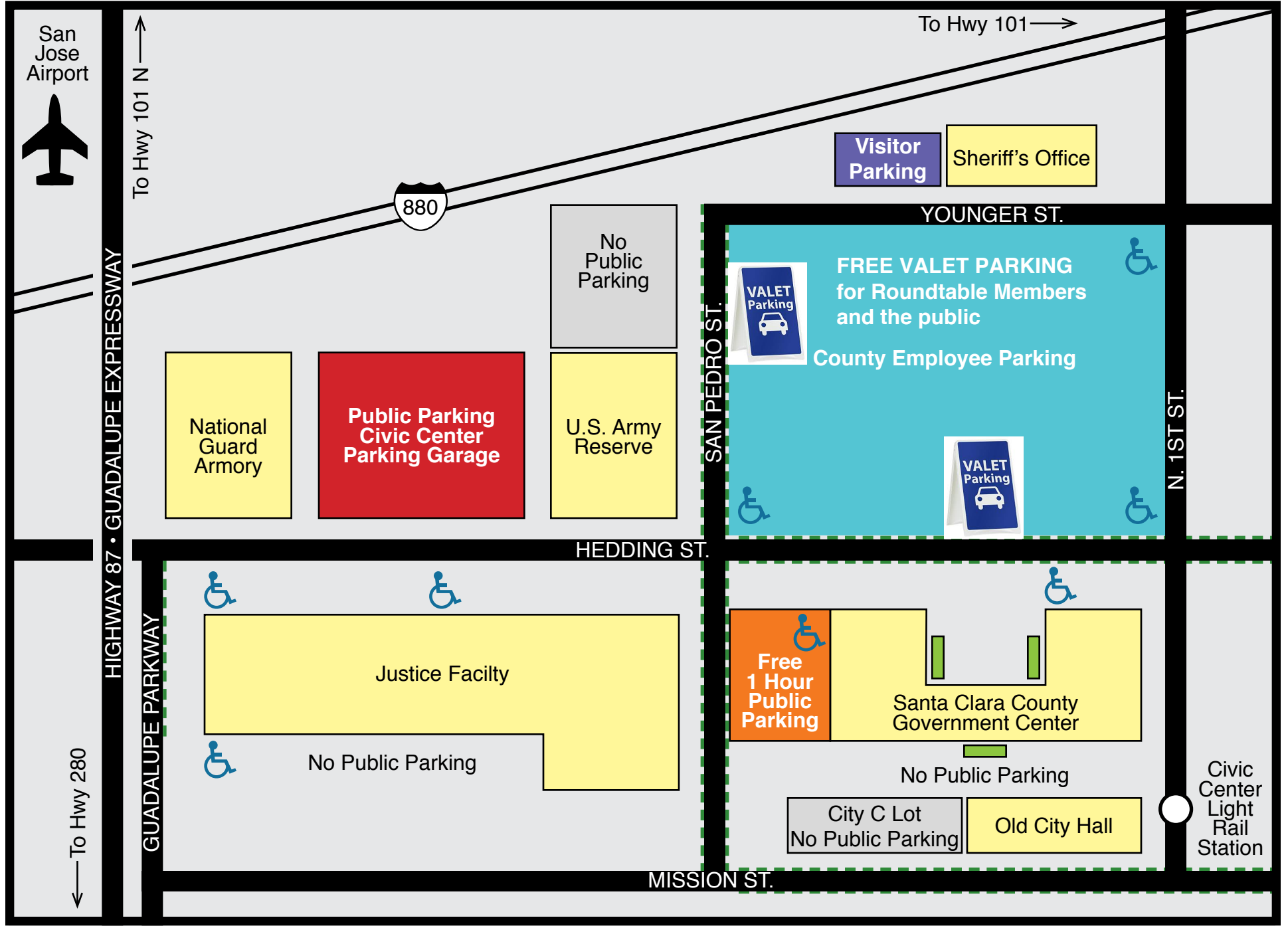


Government Center Parking

 Location for public and juror validated parking in the Civic Center area
 Open 7:00 am to 7:00 pm (no exit after 7:00 pm)
 Rates: \$1.25 per ¼ hour; \$15 maximum
 All Day Early Bird (before 9:00 am): \$11.00
 Monthly Rate General Public: \$95.00
 After Hours Service Charge: \$25.00
 2-Hour metered parking on first level. Meters take quarters only. 10 minutes per quarter.

Free 1 Hour Public Parking
 Located at San Pedro St. and Hedding St.
 Location for public parking in the Civic Center area

On-Street Metered Parking
 A limited amount of metered, on-street parking is available on streets around the County Government Center for. Parking meter time limits are vigorously enforced.

How do I get to the County Government Center?

From Interstate 880 Northbound:

- Turn right on First Street.
- Remain on First Street for a quarter mile until the intersection of First and Hedding, then turn right.

The County Government Center is in the large rust-colored building on the corner on your left. You may park at any available metered space on the street if you have the proper change. If desired, you may continue on Hedding Street for another block where there is a public parking garage on the right (across from the courthouse). You may park in free 1-hour public parking in the parking lot adjacent to the Government Center.

NOTE: Do not park in the large employee parking lot at the corner of San Pedro and West Hedding streets on weekdays before 5 p.m. Public parking is not allowed and cars will be ticketed.

From Interstate 880 Southbound:

- Take the First Street exit.
- Turn left on First Street.
- Remain on First Street for a quarter mile until the intersection of First and Hedding, then turn right.

The County Government Center is in the large rust-colored building on the corner on your left. You may park at any available metered space on the street if you have the proper change. If desired, you may continue on Hedding Street for another block where there is a public parking garage on the right (across from the courthouse). You may park in free 1-hour public parking in the parking lot adjacent to the Government Center.

From Highway 87 (Guadalupe Parkway) Northbound:

- Exit at Taylor St.
- Turn right at the exit light.
- Take an immediate left at North San Pedro, the next light.
- Cross Mission Street.

The County Government Center is at the end of the block on the right. (white building and tall rust colored building) Look for metered parking on the street or go left onto W. Hedding Street and park in the parking garage on the left. You may park in free 1-hour public parking in the parking lot adjacent to the Government Center.

NOTE: Do not park in the large employee parking lot at the corner of San Pedro and West Hedding streets on weekdays before 5 p.m. Public parking is not allowed and cars will be ticketed.

From Highway 87 (Guadalupe Parkway) Southbound:

- Exit at Taylor St.
- Turn left at the exit light.
- Take an immediate left at North San Pedro Street.
- Cross Mission Street and go down one block.

The County Government Center is at the end of the block on the right. (white building and tall rust colored building) Look for metered parking on the street or go left onto W. Hedding Street and park in the parking garage on the left. You may park in free 1-hour public parking in the parking lot adjacent to the Government Center.

NOTE: Do not park in the large employee parking lot at the corner of San Pedro and West Hedding Streets on weekdays before 5 p.m. Public parking is not allowed and cars will be ticketed.
