Hi Mayor Gibbons,

Supervisor Ellenberg asked me to share with you the communications our team sent to the business community in support of her ARPA priorities. We made this communication very brief and its pasted below. In addition to the message below, I can share the Supervisor's comments at the Board meeting included the request that the grant program should be highly flexible, focused on Covid recovery and resiliency, launched with an equity lens, and the management of the program should include a fee and go out for RFP. She requested a minimum of \$10M of ARPA funds for this grant program, however the Board will have to vote on this and advocacy is greatly appreciated.

For context, this request from Supervisor Ellenberg is the latest in a series of referrals and actions initiated to support the small business community.

- She pushed for a \$25M allocation to the Rebuilding California fund (circulated 4 times for \$100M impact) for small business loans in Santa Clara County.
- She directed the temporarily elimination of several County business fees for the remainder of 2021.
- She reallocated Covid public health notice of violation (NOV) fines into small business grants. To date; \$600,000 has been redirected into this grant program. This was really the first tranche, with the larger ARPA allocation being the second tranche.
