SUBJECT: 2022 CITY SELECTION COMMITTEE CALENDAR

RECOMMENDATION:

Approve the proposed 2022 calendar as provided in Attachment A.

BACKGROUND:

The City Selection Committee (CSC) appoints representatives to regional bodies as needed, i.e. when seats are vacated or terms end. For the 2022 year, the term start dates that the CSC must appoint for are as follows:

January: SVRIA (1 representative and 1 alternate), Measure A (2016 Housing Bond) Citizen's Oversight Committee (1 representative)

June: ABAG Regional Planning Committee (1 representative), EOAC North County (1 representative)

July: ABAG (2 representatives and 2 alternates)

The dates for these terms have been verified with their respective agencies.

To strike a balance between efficiency of meetings and timeliness of appointments relative the start of new terms, the President has determined that appointing in January for terms beginning January-April and appointing in April for terms beginning May-August is optimal. There are no terms beginning September-December this year, so the usual third meeting of the year is not needed. This schedule attempts to address concerns raised by a Board member in response to the initially scheduled seats up for appointment by the CSC in January, which has since been revised.

The CSC has the following options to consider on this matter:

- 1. Approve the proposed 2022 calendar as provided in Attachment A and as recommended by staff.
- 2. Approve a calendar with alternate dates.
- 3. Take no action and leave meeting scheduling up to the discretion of the Chair.

Honorable Members of the City Selection Committee,

As opportunities arise for Directors of the Cities Association to volunteer on Committees, I would like to express an interest in being a member of the Measure A Bond Oversight Committee.

Prior to being elected to the Milpitas City Council I served on the Milpitas School Board for 8 years, there I learned about budgets, state oversight and compliance. I also served on the Planning Commission for 4 years. My experience on the Planning Commission has given me valuable insight in land use policy and nomenclature. This background knowledge has given me a better lens in the decision making process on the dais.

We are one of the very few cities that has taken a proactive approach to providing below market rate housing even before Measure A was approved by the voters and enacted. Our city is also one of the recipients in Measure A funding for planned affordable housing. Recently we approved a 100% affordable residential unit housing project. In addition, since our last housing Element 5 years ago, any new housing developments must provide 15% affordable housing. We are currently discussing a no in-lieu fees ordinance to ensure that affordable housing is provided by Developers.

I also serve on the VTA Board and we identify surplus land to provide affordable housing. Serving on the board can also be a way to collaborate and identify housing opportunities.

Our city housing policies are in line with the concept of providing affordable housing and I feel that serving on this committee would be a great opportunity for me to give my input and to learn all there is to know about affordable housing for our diverse population in Santa Clara County.

As part of the three-city agreement, my service on the SVIRA board is scheduled to end on June 30, 2022. I believe it is in the public interest for my service on the SVRIA board to continue, hence my expression of interest today to the CSC for a "re-appointment" term that would run through 2025. The current Cities Association appointee to the SVRIA, Lisa Matichak, has indicated a desire to not seek re-appointment. I have seen Councilmember Matichak serve admirably on the board and I appreciate her many contributions to SVRIA.

A little bit about SVRIA. We refer to ourselves as the "Mighty JPA." Over the past decade, SVRIA has built a County-wide digital radio communication system for use by and among emergency responders, including those in all 15 cities, the County, and special districts and agencies. The funding to build this system, approximately \$15 million, came from the JPA members, in large part the cities that comprise the Cities Association. The primary purpose for the SVRIA's county-wide all-digital communication system is during large-scale events or emergencies, such as Super Bowl 50 or the Gilroy Garlic Festival shooting, where first responders must be able to communicate directly, regardless of which agency they're responding from. The need for such an integrated system was apparent on September 11, when multiple responding agencies were unable to communicate with each other. Significant credit for the success of SVRIA goes to County Supervisor Mike Wasserman, who has been involved with SVRIA since its inception. With Supervisor Wasserman's forthcoming departure from the Board of Supervisors (and therefore the SVRIA board as well), I believe that SVRIA board continuity is more important now than ever before.



My policy goals for SVRIA are simple. Now that this critical infrastructure has been built and implemented across the County, it must be maintained and protected, all at a reasonable cost to our JPA members. On behalf of the Cities Association, my pledge is to ensure that SVRIA continues to focus, along with our partners at Motorola, on robust system maintenance including myriad hardware and software requirements. I pledge to continue focusing on the physical security of our communication tower system, and to advocate with Sacramento for stronger legislation to deter the illegal use of signal jamming technologies. Finally, I pledge to keep a close eye on SVRIA's budget to ensure our JPA members get the best value for their taxpayer dollars, and to ensure integrity of our JPA's internal financial controls.

Having served as an Alternate Board Member of the Silicon Valley Regional Interoperability Authority in 2021, I would like to apply to serve as a **Board Member of SVRIA in 2022**.

I am a long-term resident of several communities in Santa Clara County and currently am a Councilmember serving the Town of Los Gatos. I have both a **professional and community service background** that I think could be helpful to the SVRIA. Some of my qualifications follow:

CURRENT LEADERSHIP

- Santa Clara County Emergency Area Operations Council (EAOC), serving as representative of the West Valley/South County cities
- Leadership, Los Gatos-Monte Sereno Emergency Communications (ARES/RACES) – For many years (since obtaining my Amateur Radio license in the aftermath of the 1989 Loma Prieta earthquake), I have worked to improve emergency communications in the face of new disaster challenges. I regularly serve as an instructor in our "Ham Cram" that is open to Santa Clara valley residents and has helped several hundred participants to obtain their FCC Amateur Radio license and trained them in operating procedures.
- CERT Member Working with the Los Gatos Police Department and Community Emergency Response Team (CERT), I've participated in numerous county-wide and town-wide drills and exercises, serving as a Network Control operator and Santa Clara County emergency communications liaison.

PROFESSIONAL AND COMMUNITY SERVICE

- Partner Deloitte and Ernst & Young (Retired) Working with municipalities and private corporations in strategic planning, I've focused on risk assessment and risk mitigation. I worked on a large-scale public-private partnership with UCSF, Santa Cruz, and Berkeley and corporations in the health care arena.
- Professional and Community Service Background I've led strategic planning efforts that have required deep understanding of financial analysis and some have resulted in the Town of Los Gatos achieving substantially greater participation in emergency response, increased funding, and short and long-term improvements in emergency preparedness. Recently, I've also organized and conducted 10 neighborhood community Zoom sessions, including the Red Cross and CERT, in emergency preparedness especially in the face of current wildfire threats.
