What is Secure Storage?

Secure Storage of Firearms

Secure storage means locking guns in a secure place such as a gun safe or using safety devices such as trigger or cable locks.

The most secure way to store firearms, as recommended by the American Academy of Pediatrics, is to store them

- unloaded,
- locked,
- and separate from ammunition.

Why is Secure Storage important?

Secure storage of firearms has been shown to reduce

- Suicide
- Stolen weapons
- Accidental shootings
- School shootings



Gun Violence Background Data

Gun Sales and Gun Violence have Increased

- ❖ A 2018 survey found:
 - 20 million firearms in California
 - 25% of California households own firearms
- COVID epidemic fueled a 66% surge in gun sales in California in 2020.

Gun Violence Data - State

From "California Household Firearm Storage Practices, 2019", California Department of Public Health

- 2,954 Californians killed due to a firearm (54% suicide, 42% homicides)
- 2,960 hospitalized
- 4,215 treated at the emergency department with a non-fatal firearm injury

The Cost of Gun Violence – Santa Clara County

Emotional cost

- 88 lives were lost to firearm homicide from 2012-2016
- 164 lives were lost to firearm suicide in 2020
- 100 people were injured by firearms from 2012-2016

Financial Cost

Firearm injuries in San Jose cost \$442 MILLION annually

Access to a Firearm Triples the Risk of Suicide

90% of suicide attempts with a gun are lethal whereas only 4% of suicide attempts by other means results in death.

Suicide among youth happened in the decedent's home 65% of the time, with 57% of the firearms owned by a family member.

In Santa Clara County from 2015-2020

- Firearms were the #1 cause of suicide deaths for every age group
- White men ages 45-64 make up the highest number of suicide deaths over any other group
- Suicide death rate of males is 3-4x that of females

Reducing Lethal Means for Suicide

Research indicates that suicide is an impulsive act:

- 1) the interval between deciding to act and attempting suicide can be as short as 5 or 10 minutes
- 2) people tend not to substitute a different method when a highly lethal method is unavailable or difficult to access.
- Research confirms that safely storing firearms reduces suicide risk by putting time and distance between a person at risk and lethal means.

Theft Enables Increased Gun Violence

- Gun owners who do not safely store their firearms are more likely to have their guns stolen.
- Unsecured weapons in homes and vehicles are fueling an epidemic of gun thefts across the country.
- Nationally survey data suggests that approximately 380,000 guns are stolen from individual gun owners each year.
- An analysis of more than 23,000 stolen firearms recovered by police between 2010 and 2016 found that the majority of these weapons were recovered in connection with violent acts such as murder, kidnapping, and armed robbery.

Accidental Death and Injury

Children know where guns are in their home

- In a national study, more than one third of adolescents said they could access a loaded household firearm within 5 minutes.
- Although 70% of parents reported that their adolescent could not independently access a household firearm, more than one-third were contradicted by their child's report.

Unintentional shooting deaths by children increased 30% from 2019 to 2020.

Risks to Children and Schools from Unsecured Firearms

- ❖ 5.4 million children in America live in households where at least one gun is unlocked and loaded.
- ❖ 75 percent of school shooters under age 18 acquired the gun(s) they used from their home or the homes of relatives or friends.
- Every day in this country,
 - one small child unintentionally shoots him/herself after finding an unsecured firearm in their home, or a friend's or relative's home.
 - two older children, mainly teens, commit suicide using an unsecured firearm from their home or a relative's home.



Public Support for Secure Storage

Public awareness of gun violence has increased, and so has public support for secure storage.

Secure storage ordinances are passing with little to no public dissent.

NOW is the time for your city to pass a secure storage ordinance!

Secure Storage Ordinance Map

8 cities out of 15 cities in our county have passed a secure storage ordinance.



Sample Secure Storage Ordinance Text

County ordinance

Sec. B19-17. - Prohibition on keeping firearms in a residence unless in locked container, disabled with a trigger lock, carried by an authorized user, or in immediate control or possession of an authorized user.



- (a) Except when carried on the person of an individual in accordance with all applicable laws or when in the close proximity and control of a person who is authorized to carry a firearm in accordance with all applicable laws, in the unincorporated area of the County no person shall keep a firearm in any residence unless the firearm is stored in a locked container or the firearm is disabled with a trigger lock. This provision does not apply to the storage or use of a firearm outside of a residence.
- (b) Each day that a firearm is improperly stored shall constitute a separate violation of this Section.
- (c) The first violation of this Section shall be an infraction punishable by a fine not to exceed \$500.00.
- (d) All additional violations of this Section beyond the first violation shall constitute an infraction punishable by a fine not to exceed \$1,000.00 punishable by a fine not to exceed \$1,000.00 Meeting | March 4, 2022 | Page 30 of 37

Summary

- Secure storage saves lives.
- * Reduces the risk of tragedy in our communities:
 - firearm suicides, stolen weapons, accidental shootings, school shootings.
- Only 35% of California households are storing their firearms in the most secure manner.

We can and must do better.

Joanne,

Yes, agreed, it was wonderful to reconnect and touch base yesterday. I look forward to working with you at CASCC.

Thanks as well for the email and the update from your discussion with Chair Joes. I was just about to send you a follow-up email per our discussion yesterday so we are on the same wavelength. Even though the Life Moves Challenge Grant item will be later than March, I think the below/attached is still helpful background for you to have.

As I mentioned yesterday, Joe and Supervisor Lee initiated the idea with a referral on 9/28/2021 which directed staff to develop a NOFA to establish a "Challenge Grant" of up to \$40m to fund the development of up to 16 modular, supportive interim housing sites across the county. The BOS reviewed the program guidelines and eligibility requirements on 10/19/2021; note the official name of the program is "Service-Enriched Shelter Loan Program." The BOS received a report on possible fund sources 12/7/2021, including Administration intent to allocate \$10m at FY22 Mid-Year to support the program and the initial two projects. The next step is for the BOS to consider and approve funding allocations for the first two projects (one in Palo Alto and one in San Jose) which is expected at BOS meeting in February. Note, I've attached the legislative files for all of the above should you want to take a deeper dive.

Consistent with above, Joe is working to support Aubrey Merriman and LifeMoves as they work to identify additional partnerships with other cities to advance additional sites in the County. The opportunity to speak at the Cities Association meeting would present an optimal forum to reach all the cities at once. As I said on the phone, when this item is agendized for a CASCC meeting, Joe would also like to attend and be available to answer questions following Aubrey's presentation.

I have copied Aubrey on this email. Also copied is my colleague Katherine Alexander who is the staff lead on these issues.
