## **City Selection Committee Nomination and Voting Procedures**

The City Selection Committee (CSC) will be selecting city representatives to be elected official appointees to several regional bodies at its February 9, 2023 meeting pursuant to Government Code section 50270. Nominations for the available positions were solicited in advance, and for several positions, letters intent have been submitted. Some positions did not receive nominations in advance. Nominations will also be accepted from the floor at the meeting before consideration of each appointment. Subsequent to receiving nominations for each appointment, each person nominated will have ninety (90) seconds to address the CSC. Public comment on the nominations for each appointment will be taken after the nominees address the CSC. Discussion among CSC may occur after public comment and before voting commences. Each appointment will be taken up separately.

Unless a member of the CSC is appearing remotely, voting on the nominations will take place via paper ballot. If one or more members appear remotely, then we will utilize a roll call voting process. In compliance with the Ralph M. Brown Act, all votes must be made public and identified with the person who cast the vote. Therefore, for each appointment, CSC members will list their name on the ballot and vote for the same number of nominees as there are positions. For most regional bodies, there is only one position available, so CSC members will vote for one nominee. For those bodies where there are two positions available, CSC members will vote for up to two nominees (casting two votes for one nominee is not permitted). The clerk will read aloud the votes, including the identity of each member, and will record the votes in the minutes.

The nominee with the highest vote tally is selected in a vote-for-one election and the top two nominees are selected in a vote-for-two election. However, in each instance, a person needs to obtain a minimum of eight (8) votes in order to be selected since action by a Brown Act body requires the consent of a quorum. Therefore, for a vote-for-one election, if no person obtains eight (8) votes in the first election, a runoff will be held among the top two nominees (including additional tied persons).

Vote-for-two elections will have slightly more complex rules if there is not a clear selection of the top two nominees receiving more than eight (8) votes. If there is only one nominee that receives eight (8) or more votes, that person is selected, and a runoff will be held among the next top two nominees (including additional tied persons). If there are no recipients of at least eight (8) votes, a runoff will be held among the top three (including additional tied persons). If there is a tie for second place, but the first-place nominee received at least eight (8) votes, a runoff will be held among those tied nominees, with the top vote getter being selected so long as they receive at least eight (8) votes.

A maximum of three rounds of voting will be held for each appointment, after which if not all winners are identified, the remaining selection(s) will be made by lot by drawing names out of a vessel (such as a hat) among those still under consideration.

It has been an honor to serve for the past five years as Alternate to the Cities Association's previous appointee, Glenn Hendricks. During this time, I have attended roughly half of ALUC's public hearings as a voting member.

Each county is required by State law to have an ALUC. The County of Santa Clara has five airports and the Santa Clara ALUC has adopted a Comprehensive Land Use Plan (CLUP) for each. CLUPs specify maximum building heights and densities within specified radiuses around each airport, with a primary goal of ensuring safety of people on the ground and that noise within the CLUP boundaries does not exceed certain thresholds. A city wishing to adopt or amend its land use plans or zoning codes within the boundary of a CLUP is required to apply to the ALUC for a so-called determination of consistency, which is the responsibility of the Commission<sup>1</sup>.

During the past five years, I have developed expertise on ALUC. I also have a deep appreciation for what it does not do. This allows me to help ALUC stay focused on its core function. For example, ALUC is not responsible for:

- Operations within an airport, which is the jurisdiction of each airport's governing agency
- Airplane flight patterns, air traffic control, and/or airplane noise, which are the jurisdiction of the FAA

- Any air pollution arising from airport operations, which is the jurisdiction of BAAQMD

If appointed, my commitment to the Cities Association is that the ALUC will quickly and diligently handle applications for consistency determinations, and to always be mindful of the important safety goals that come with adherence to the CLUPs.

I will be happy to answer any questions regarding my application and I appreciate the consideration of the City Selection Committee of it.

Dear Cities Association Selection Committee Members,

I am humbly writing to request your re-appointment to represent you and the cities of Santa Clara County on the Bay Area Air Quality Management District (BAAQMD) Board.

The board is highly technical and it requires more than a year to come up to speed and be a high functioning board member. I was appointed to the last 2 years of Rod Sinks 4-year term and have now been on the board for 2 years. After serving on the sub committees of Mobile Source, Stationary Source, Legislative, and Technical Advisory, I am now quite knowledgeable and able to perform at a high level on this board.

Additionally, Santa Clara County has had a lot of turnover amongst its 4 representatives on the board. Rich Constantine and I were new 2 years ago, Rich left the board last year and was replaced by Sergio Lopez, and Cindy Chavez left the board last year and was replaced by Otto Lee. Margaret Abe Koga is the only representative with more than 2 years of experience on the board. I believe it is important at this time to limit further turnover of the representation from Santa Clara County.

I include below my qualifications by which I was originally appointed. During the Cities Association deliberation, technical background and skills were the main arguments made by committee members for my appointment:

1) I grew up as in the Bay Area in the 70s with bad asthma from the high particulate count pollution. I still feel my chest tighten from diesel fumes, cigarette smoke or wood burning. I believe strongly in BAAQMD's goal to "reduce and eliminate health problems from air quality."


2) BAAQMD is the next step to Silicon Valley Clean Energy (SVCE). I am a founding Board member and the 2nd chair of SVCE. I am proud of how SVCE has moved the needle on climate change in our County by being the first to offer 100% carbon free electricity and now through innovative programs to decarbonize through electrification of both the mobile and built environment. BAAQMD has a lot of money from the State to also drive de-carbonization through similar kinds of strong programs. I look forward to bringing my knowledge of de-carbonization programs from SVCE to BAAQMD.

3) I am a long time champion of our environment and addressing global warming through activism with the Sierra Club. I formed the Los Gatos team to get the then Mayor to sign on to the Mayors Climate Protection Team to begin work on reducing greenhouses gases (GHGs). I also served in the Club's Chapter Executive Committee for many years in several roles. A BAAQMD appointment would enable me to continue working toward a cleaner environment.

4) I am particular interested in several of the BAAQMD sub-committees and look forward serving on them. These include: Mobile Source, Stationary Source, Climate Protection, Community and Public Health, Technology Implementation Steering Committee.

5) BAAQMD is a very large time commitment both to come up to speed and to devote time to the meetings, preparing thoroughly for each meeting, and travelling to San Francisco post-COVID. I am committed to investing the time to be an effective BAAQMD Board Member by coming up to speed quickly, engaging early, and contributing fully.

Dear City Selection Committee Members,

I am a Council Member for the City of Palo Alto and respectfully seek the honor of your appointment to the Bay Area Air Quality Management District.

I earned my BS in Biochemistry because of a deep curiosity and respect for organic life, a desire to promote health, and an interest in understanding the impact of our environment. I was raised in a home that cared deeply about the air we breathe – my father was a professor of Public Health and interacted frequently with the American Lung Association; in fact, his first doctoral student became their president. As an adult, I became a patent lawyer and have litigated life science patent cases starting 35 years ago.

More broadly, my background with respect to environmental and climate issues includes:

- a. After coursework in environmental law at Georgetown Law School, I performed pro bono work early in my legal career for the Natural Resources Defense Council related to disposal of toxins.
- b. After I moved to California, I performed pro bono work for the Earth Environmental Tithing Trust.
- c. In 2016, I ran on protecting the environment and climate action during my campaign for the State Assembly. I was honored to earn an endorsement from the Sierra Club and the California League of Conservation Voters (now California Environmental Voters). I also earned endorsements from the California Environmental Justice Alliance and environmental leaders including former Congressman Pete McCloskey and former State Senators Byron Sher and Fran Pavley.
- d. In November 2022, I ran for the Palo Alto City Council and was the only candidate endorsed by both the Sierra Club and the League of Conservation Voters. As a Council Member, I will be serving on the City's S/CAP Committee and the Joint Palo Alto/Santa Clara Valley Water District Recycling Committee.
- e. On a personal note, I have driven an EV since 2015 and my husband drives a plug-in hybrid. In fact, in 2017 I wrote a blog entitled "Two in a Tesla" about driving across the country with my daughter in an EV at a time when people seriously wondered if it could be done. It's hard to imagine now, but people would walk up to us at charging stations, tell us they'd never seen an EV before, and ask questions like, "does it have trouble going uphill?"

I am eager to use my knowledge of chemistry and biology, background with environmental issues, and experience evaluating expert opinions and data to address issues before the BAAQMD Board. I have litigated patent cases in courts across the country, primarily related to biotechnology and medical devices. A big part of that was analyzing the views of competing expert witnesses. My years of experience analyzing technical reports and competing views, would be a useful asset in this role.

In addition, I will be serving simultaneously on Palo Alto's Sustainability and Climate Action Plan Committee, which would create natural synergies with the work of BAAQMD. 

I have had the opportunity to serve as the MTC appointee for the last two years where I have worked hard to represent the transportation interests of all the cities in Santa Clara County, fought for our County's fair share of State and Federal transportation dollars, advocated for ways to improve our regional transit system and advance capital projects.
