I request consideration for appointment to the Santa Clara County Emergency Operational Area Council (EOAC), Seat 5. When I was first elected to the Campbell City Council, I attended the California Specialized Training Institute course on California's Standardized Emergency Management System. This was a resident one-week course on emergency management with both lectures and role playing. Subsequently, I was appointed to serve on Santa Clara County's Emergency Preparedness Council. I served for 14 years, with several years as Chair. After the 911 attack in Washington, DC, I was appointed by the National League of Cities to serve on the Special Working Group on Homeland Security. We met for many months, considering security of the United States, and we spent considerable time reviewing better solutions for radio interoperability. I also served as Chair of the National League of Cities Public Safety and Crime Prevention Committee, as well as Chair of the California League of Cities Public Safety Committee. I served on the Board of Directors of the League of California Cities and the Board of the National League of Cities.

Currently, in my new term of office, I represent the West Valley Cities on the Silicon Valley Regional Interoperability Authority. My professional background is in health care, and I hold a Doctor of Pharmacy degree, and a Master of Public Administration degree. I served on active military duty for two years in the US Army, and then served in the US Army Reserve. I was fortunate to hold senior leadership positions, and I retired as a Brigade Commander.

I believe my training and experience in emergency preparedness would be beneficial in serving on this council, and the leadership responsibilities I have had at both regional and national policy levels allow me to contribute to the success of the EOAC.

Honorable members of the City Selection Committee,

I would like to apply to be re-appointed to serve on the **Santa Clara County Emergency Operations Area Council** as a representative of one of the West Valley/South County cities. I have found that participation on the EOAC, during the relatively short two-year term, has been particularly beneficial to the work that I do as a leader in emergency communications in the West Valley. Having gained important experience, I will also focus additional attention on South County preparation and response in the next term, should I be re-appointed.

I am a long-term resident of various communities in Santa Clara County and currently am a Councilmember serving the Town of Los Gatos. I have both a **professional and community service background** that I think could be helpful to the EOAC. Relating to the Purpose of the EOAC, some of my qualifications follow:

- *To enhance planning and preparedness for large-scale emergencies;*
 - **Leadership, Los Gatos-Monte Sereno Emergency Communications (ARES/RACES)** – For many years (since obtaining my Amateur Radio license in the aftermath of the 1989 Loma Prieta earthquake), I have worked to improve **emergency communications** in the face of new disaster challenges. I regularly serve as “Net Control” on local and areas emergency drills. I am also an instructor in our “Ham Cram” that is open to Santa Clara valley residents and has helped several hundred participants to obtain their FCC Amateur Radio license and trained them in operating procedures.
- *To create effective partnerships in emergency planning, preparedness, training and exercise within the Operational Area;*
 - **CERT Member** - Working with the Los Gatos-Monte Sereno Police Department and Community Emergency Response Team (CERT), I've participated in numerous **county-wide and town-wide drills and disaster preparation exercises**, and I work to improve the infrastructure for emergency response.
- *To consolidate activities of cities and special districts to participate more efficiently in planning for future emergencies and disasters;*
 - **Alternate Board Member SVRIA** – I've participated in board meetings of the Silicon Valley Regional Interoperability Authority in **delivering radio and data communications connectivity** between communities in the face of incidents, emergencies, and disasters.
- *To provide access to public-private partners to participate in emergency planning and preparedness; and*
 - **Partner Deloitte and Ernst & Young (Retired)** – Working with municipalities and private corporations in strategic planning, I've focused on **risk assessment and risk mitigation**. I worked on a large-scale public-private partnership with UCSF, Santa Cruz, and Berkeley and corporations in the health care arena.
- *To develop broad-based emergency preparedness and funding priorities and recommendations.*
 - **Professional and Community Service Background** – I've led strategic planning efforts that have required deep understanding of financial analysis and some have resulted in the Town of Los Gatos achieving **substantially greater participation in emergency response, increased funding, and short and long-term improvements in emergency preparedness**. Recently, I've also organized and conducted 10 neighborhood community Zoom sessions, including the Red Cross and CERT, in emergency preparedness especially in the face of current wildfire threats.



PROFESSIONAL SUMMARY

Matthew Hudes is a Councilmember serving the Town of Los Gatos. For 13+ years, Matthew has served Los Gatos in numerous roles in addition to the Town Council: Working with the Los Gatos Police Department and Community Emergency Response Team (CERT), he has worked to improve emergency communications in the face of new disaster challenges. He has served as Member of the Finance Commission, Senior Services Commission, Chair of the Planning Commission, Planning Commissioner, Chair of the Historic Preservation Committee, member of the General Plan Committee, the Housing Element Advisory Board, and others.

Currently, Matthew serves as CEO of a biotechnology consulting firm, having retired as U.S. Managing Principal, Biotechnology for Deloitte and played a similar role at Ernst & Young. He also started and grew a software/bioinformatics company in Los Gatos.

Dear Members of the Selection Committee:

My name is Jonathan Weinberg, and I am the Vice Mayor of the City of Los Altos. I was honored to be selected last year as the Cities' Association's appointed representative to the Emergency Operational Area Council (EOAC) for the North County Cities. I submit this letter to express my interest in continuing to serve our community in that role for the next year.

The EOAC plays a critical role in preparing our communities for all kinds of emergencies, whether related to intentional bad acts, inclement weather, or acts of God. At our last meeting, much of the agenda and presentation focused on how the County and cities in Santa Clara County reacted to the series of storms in December and January. It was important for each of the EOAC members to understand the impact of the storms on our communities, especially the dangers posed to at-risk communities. Learning what responsive tactics worked (and what tactics could be improved) makes our cities stronger, and the sharing of this information makes all our cities better able to protect our residents, businesses, and property.

I have previously served as the City of Los Altos' voting member of the Silicon Valley Regional Interoperability Authority (SVRIA). The SVRIA operates the leading inter-agency communications network in support of emergency operations throughout the County. Like the EOAC, the SVRIA's mission is to protect the public by supporting our first responders and providing them the tools they need to perform excellent service in the event of an emergency. The issues and concerns of the EOAC and the SVRIA often overlap. My experience with both the SVRIA and the EOAC makes me a well-suited candidate to continue to serve as the North Cities representative to the EOAC.

Additionally, Los Altos is in the process of building a new emergency operations center for our city. Since October of 2020, I have met with city staff, volunteers, HAM radio operators, and other stakeholders to learn about disaster preparedness and emergency operations. What began as an interest in a Los Altos project has grown into a desire to contribute to our regional, collaborative, County-wide efforts to be prepared.

There is no question of whether we will suffer a disaster – the only question is when. It would be my honor to serve as the north cities' representative to the EOAC to contribute to our common efforts to keep our shared communities safe, secure, and prepared.
