1. Welcome/Review of the Meeting Format

Roundtable Facilitator Steve Alverson welcomed the members of the public and reviewed the meeting format. He noted that a video recording of the meeting and additional resources can be found on the SCSC Roundtable website.

2. Call to Order and Identification of Members Present

The SCSC Community Roundtable was called to order at 1:01 PM by Chairperson Mary-Lynne Bernald. Roundtable members identified themselves. A quorum of the members was present.

3. Presentation on the South Flow Ad Hoc Committee Process

SCSC Roundtable Member Glenn Hendricks provided a presentation of the history of the South Flow Ad Hoc Committee including an overview of how concerns related to aircraft noise in the South Bay have been handled with the establishment of a Select Committee on South Bay Arrivals. The San Jose City Council hosted the Ad Hoc committee for a six-month period, and drafted a set of recommendations as a deliverable.

4. Presentation on the Select Committee on South Bay Arrivals Process

Ms. Zanardi provided an overview of the Select Committee on South Bay Arrivals, how it was established, the number of independent committee members and alternates, and a review Congressional review process. Further, Ms. Zanardi provided an overview of the public comment process and the number of comments received (in both written, and in-person comments). Ms. Zanardi stated that the Select Committee report was written specifically to be in "plain English" and that regional consensus was made on all recommendations provided. Roundtable members asked questions regarding locations on the internet to view the report, video from the Select Committee meetings, and if there was a way to check the status of the recommendations. Steve Alverson clarified that links to the Select Committee materials have been provided on the SCSC Roundtable website.

5. Update on the FAA's Review of the Select Committee on South Bay Arrivals Recommendations including FAA Responses to Questions on the PIRAT TWO STAR Procedure

FAA representative Ms. Faviola Garcia indicated that she was not prepared to provide an update on the FAA's review of the Select Committee on South Bay Arrivals Recommendations. FAA representative Ms. Thann McLeod provided an overview of the PIRATE TWO STAR. Ms. McLeod clarified that as of late April this new procedure had been published, however, in mid-May the FAA had to lower the altitude at the PIRAT waypoint from 15,000 feet above mean sea level (msl) to 10,000 feet msl due to conflicts with departing aircraft climbing through 15,000 feet. Ms. McLeod noted that the FAA had not made a formal decision on how to rectify the conflicts on PIRAT TWO STAR, and that the FAA had no further updates for the Roundtable at this time.

6. FAA Response to Questions on the LOUPE FIVE Procedure

Ms. McLeod provided an explanation of the LOUPE FIVE Instrument Departure Procedure. Specifically, Ms. McLeod explained that there is not a standard loop size for any one procedure, and that it depends on surrounding air traffic and pilot/controller techniques. Ms. McLeod also stated that the width of the turn was considered in the environmental evaluation for the procedure.
