1. Welcome/Review of the Meeting Format

Roundtable Facilitator Steve Alverson welcomed the members of the public and reviewed the meeting format. He provided an overview of process for providing public comment and stated he expects everyone to remain cordial and respectful. 2. Call to Order and Identification of Members Present

The SCSC Community Roundtable was called to order at 1:03 PM by Chairperson Mary-Lynne Bernald. Roundtable members identified themselves. A quorum of the members was present.

Chairperson Bernald provided an overview of the agenda, topics/items to be discussed, and introductions were provided for Congressional Representative staff members, FAA representatives, the SFO airport representative, and a guest speaker with the UC Davis Air Quality Research Center.

3. Briefing on the 2020 UC Davis Aviation Noise and Emissions Symposium – Sandra Hall, UC Davis

4. Briefing on FAA's Work on the SUNNE ONE SID (aka OAK 120° Departure Down the Bay) – Steve Alverson, Roundtable Facilitator

Steve Alverson provided a presentation on the FAA's SUNNE ONE Standard Instrument Departure (SID) procedure development process, and gave an overview of the procedure.

ACTION: Member Enander's motion to ask the FAA to define and provide a visual aid for the procedure review process, and specifically stating how the Roundtable fits into the process, and further, requesting that the Roundtable ask the FAA for clarification on how the question by members and the public can be relayed to them and how the questions fit into the procedure development process was seconded by Member Matichak and passed unanimously by the Roundtable.

5. Briefing on Business and Commercial Supersonic Aircraft Noise Regulations – Steve Alverson, Roundtable Facilitator

Steve Alverson gave a presentation on the FAA's proposed development of business and commercial supersonic Aircraft Noise Regulations, including background information on emerging markets for these aircraft types, and design breakthroughs for quieter supersonic technology. Information was also provided on specific companies and agencies involved with supersonic aircraft development.

ACTION: Member Hendricks' motion to authorize the Roundtable Chair to write letters to the FAA, and Congressional/Senate representatives about the topic of supersonic flight requesting that the FAA and representatives put in place better noise standards, that relate to aircraft noise heard on the ground noise, and that are defined to be more accurate standards using more effective metrics for measuring (not DNL or CNEL) and for the Roundtable to continue monitoring the progress of this topic was seconded by Member Enander and unanimously passed by the Roundtable.

6. Strategic Plan and Work Program Ad Hoc Committee Report – Lisa Matichak, Ad Hoc Committee Chair

Member Matichak provided an update on the Ad Hoc Committee's progress, noting that they met five times between the last Roundtable meeting and the current meeting. An overview of the Work Plan outline was provided noting that a priorities list was developed.
