1. Call to Order and Identification of Members Present

Technical Working Group (TWG) Chairperson Anita Enander called the Legislative Committee meeting of the SCSC Community Roundtable to order at 1:00 PM PST. SCSC Roundtable Facilitator Steve Alverson conducted a roll call for committee members present. A quorum of the Committee members was present.

TWG Chairperson Enander provided a summary of the Ground Based Augmentation System (GBAS) procedure at the San Francisco International Airport (SFO) and an overview of what was presented at the SFO Roundtable Technical Working Group meeting (slides from SFO Roundtable provided). Further, discussion was had by members as to possible questions to ask SFO regarding GBAS.

TWG Direction to Staff: The TWG suggested that ESA should communicate with SCSC Roundtable Chairperson Mary-Lynne Bernald about how to provide the public with information regarding GBAS. Further, it was suggested that with SCSC Roundtable Chairperson Bernald's approval, the SCSC Roundtable staff send notification to the public for a solicitation of comments and questions regarding GBAS, with a deadline for submittal of questions by December 20, 2020 (Updated to 12/23/2020 to provide more time). Then with ESA's assistance, the TWG Committee Chairperson, and SCSC Roundtable Chairperson will work together to consolidate and clean up the questions prior to sending out to SFO by December 31, 2020. Responses to the questions are anticipated to be provided by SFO at the January 27, 2020 SCSC Roundtable meeting. TWG Members also suggested that SCSC Roundtable staff (upon approval of SCSC Roundtable Chairperson Bernald), reach out to City Managers to let them know that the topic of GBAS will be included on the agenda for the next full SCSC Roundtable meeting.

It was agreed that the TWG should prioritize the topic of GBAS over the topic of the FAA's environmental review in the near term.
