# 1.1 9:00 a.m. Steve Biagi – Building Maintenance Quarterly Report

Present: Steve Biagi, James Burgett, Eric Akin, Brittany Wood, Brittany Dark, Drew Messenger, Verna McClennan

Steve Biagi, Building Maintenance personnel, came to County Court to give his quarterly report. Steve noted that there is another heat issue is the new edition of the courthouse. Long is the company that does work on this heating system and currently is unable to make it to Sherman County to look at the system due to I84 being closed from Troutdale to Hood River due to the snow and icy weather. Long plans to be here on Monday, January 22, 2024 to work on the heat issue.

Steve said that everything else seems to be fine in all other buildings as far as he knows.

#### 1.2 9:15 a.m. Eric Akin – Veteran Service Officer Quarterly Report

Present: Eric Akin, James Burgett, Brittany Wood, Brittany Dark, Drew Messenger, Verna McClennan

Eric Akin, Veterans Service Officer (VSO), came to County Court to give his quarterly report. Eric reported the following:

- 61 in-office meetings with Veterans
- 8 meetings with Veterans out of the office; including a few house calls.
- 300 + phone calls
- A Veteran started a Veteran's Help group in Arlington which meets once a month that Eric is attending. Group has met twice. About 10 Veterans are attending.
- Veteran's Day meal program- served about 300 meals. Still have two invoices that have not been turned in yet.

• Approximately 125 Veterans in Sherman County; mostly Vietnam Era Veterans which puts them in their late 60's – 80's.

Eric continued a discussion on transitional housing for Veterans which he started during his last quarterly report. Eric gave handouts which highlights Clackamas and Lane Counties programs. Eric stated that there are grants available for Veteran housing. Commissioner Bird stated that she will reach out to Mid-Columbia Community Action Council (MCCAC) and Center for Living (CFL) to get contacts for Eric. Commissioner Bird thought that MCCAC and CFL might be able to give Eric some direction on how and who to contact about getting the process rolling on getting a project like this started.

County Court told Eric that they appreciate all his hard work and enthusiasm in helping the Veterans of Sherman, Gilliam and Wheeler Counties.

# 1.3 9:30 a.m. 9:36 a.m. Undersheriff James Burgett - Sheriff's Office Report

Present: James Burgett, Brittany Wood, Brittany Dark, Drew Messenger, Verna McClennan, Georgia Macnab

Undersheriff James Burgett came to County Court and gave the Sheriff's Office report. Some of the highlights from the report are as follows:

- 110 Concealed handgun licenses were issued to residents
- 194 Concealed handgun licenses were issued to non-residents
- 53 Civil papers were processed or served
- Deputies wrote 2358 citations most common offense was speeding on Hwy 97 including Moro and Grass Valley
- Deputies handled 854 calls including major crimes, thefts, unattended deaths, animal complaints and motor vehicle accidents

Detective Travis West turned in his resignation and his last day will be January 26<sup>th</sup>, 2024. The Sheriff's Office does have a deputy position advertised and the position will continue to be open until filled.

February 9th the Sheriff's Office will be holding a conceal carry class.

James wanted to let County Court know that Bruce Olsen is amazing, the quality of his work is outstanding, and everyone notices all the effort he has been putting in to making the Courthouse yard look great. County Court also acknowledge that Bruce does a great job on the landscaping of the County grounds.

# 1.4 10:00 a.m. Georgia Macnab - Planning Quarterly Report and CEDS projects

Georgia presented her quarterly report which included highlights about:

- Avangrid Klondike 1, CUP tower replacements on pause at owners request
- Rosebush solar project Sent letter to ODOE
- Biggs TA, final approval on updated site plan approved
- Avangrid O&P Building upgrades Baseline waiting for app/permit to sign off

- Floodplain maps should be ready this year.
- Kent Water Tank Do they need a building permit for putting in the water tank since it is above 6 feet? There was a permit for the Biggs Service District Water Tank.

Georgia and County Court went over the CEDS list from last year for the County. Georgia stated that the City of Moro and the City of Rufus are both working on their CEDS list. Julia stated that the school board has discussed the hoax bomb threats that schools, hospitals and government building have been receiving and they have decided to update their policies with the help of Undersheriff James Burgett.

Julia stated that as part of the schools' safety program they have been getting staff trained.

Julia also mentioned that the school in is the strategic planning process. There will be many phases to this process and right now that are on Step 1 Identity Work – figuring out who we are as a district.

County Court told Julia that they appreciate everything that she is doing and all the updates on Facebook.

Dana Pursley-Haner, EMS Director, came to County Court to give an overview of the types of calls received, types of insurances and what is/isn't paid through insurance. For example there was 19 calls in December 2023 and only 13 of those calls were billable. Out of those calls that are billed, only a portion of each bill gets paid and the rest gets written off.

Dana was going through 2023 billing with County Court to show the bills, what gets written off and then what costs for EMS are going up. Dana is hoping to suggest increases in some of the EMS charges during the budget process for 2024/25 fiscal year. Dana also wants to increase the wages of paid volunteers to help entice people to sign up and to keep people that are signed up as paid volunteers.

Debbie Hayden, Sherman County Finance Office came to County Court to discuss the 2023 Audit Findings.

The auditors found that the finance staff does not prepare their own financial statements and instead has contracted with auditor to prepare the annual financial statements.

The auditors have noted that staff has the necessary skill and knowledge to take responsibility for these statements, but notes their experience in preparing cash basis financial statements and related disclosures is limited, Sherman County has addressed this deficiency by contracting with the auditing firm to prepare these annual financial statements. The finance staff works diligently in preparation of its annual audit providing all reports and documentation immediately upon request. The final audit report is reviewed thoroughly before approval by the Sherman County Court.
