A quorum was present. No news media was present.

Present: Sara Schmitt

Sara Schmitt is one of Senator Merkley's Office Representatives who is replacing Dan Mahr. She came to County Court today to meet everyone face-to-face, to get updates on some projects and to hear how things are going.

First off, Sara asked for updates on the following projects:

- Biggs Service District Water System Water is running and project is wrapping up.
- Grass Valley Sewer Still gathering funding for this project.
- Solar Trailers Project is complete. Some trailers probably could be moved to other locations at this time.
- Hemp Facility Fire in Grass Valley A total loss, will not be rebuilding. Owners are still in the process of thinking of another use for that property.

Sara mentioned that health care places and work force housing came up in the last town hall with Senator Merkley and was wondering if there have been any updates. County Court told Sara that we do have the Sherman County Health Clinic in the County, but otherwise folks have to travel to The Dalles or beyond to see doctors. County Court also stated that Sherman County is still in the need for work force housing.

Sara asked County Court what is going well in the County. County Court listed the following big projects that they are proud of:

• Biggs Service District Water Project

- New Fair arena is completed
- Fiber to the homes in town
- Solar trailers
- Proud of this community and individuals in it

County Court told Sara that Mike McArthur, with CREA, is trying to set up a town hall for the community on the topic of solar. This is to be a non-bias panel of experts from the Department of Energy and other experts around the state. The idea behind the town hall is that so many solar companies are contacting residents in Sherman County right now and County Court and CREA would like residents to be well informed as so much has changed in the last 20 years since the last town hall in Sherman County on this topic.

Sara also asked County Court what things they would like to be bragging about in two years. Some of their answers are listed below:

- Infrastructure sewer and water improvements for the cities
- New housing developments
- EV charging stations around the county
