# 1.1 9:00 a.m. Kristen Stuart, Sherman County Museum Director Meet & Greet/Update

Present: Kristen Stuart, Michelle Colby, Andrew Danies

Kristen Stuart came to County Court to introduce herself as the new Sherman County Museum Director and to give a quarterly update.

- Oregon Trail Marker (a rock) is currently on HWY 206 and needs to be moved by this fall. The question is whether to move the rock to a new location and have a kiosk installed that talks about the rock or should the rock be moved to the Sherman County Museum. Kristen will get more information including a bid for the kiosk and the asphalt for two parking spaces.
- An EV Charging company has contacted the museum about leasing ground at the museum to add EV charging stations. This would include 9 parking spaces, 4 charging stations each with two chargers and one that is ADA accessible. This company is wanting a non-binding letter by August 9<sup>th</sup> to submit with their bid to receive an ODOT grant. The issue that the museum has is that it doesn't have 9 parking spaces to dedicate to EV charging stations. Kristen is wondering if the senior center parking lot could also be used. This is a question that she will ask.
- 3<sup>rd</sup> Annual Harvest Fest July 21<sup>st</sup> that the museum will take part in.
- 300+ animal traps from around the world exhibit is being put together.
- November 3<sup>rd</sup> is the Museum's fall meeting and it will be held in Wasco.

Present: Michelle Colby, Andrew Danies

Michelle Colby, MCEDD, came to County Court to give her quarterly report. Here are some of the highlights:

- Introduction: MCEDD Welcomes Andrew Danies as Deputy Director. Danies joined MCEDD in June.
- MCEDD's Environmental Protection Agency (EPA) Brownfields Grant: In April, Sherman County submitted
  an application to MCEDD for a project that aims to expand a senior housing development in the City of
  Moro. MCEDD's Brownfield advisory committee approved the application, and on-site work will begin once
  the EPA approves the site-specific Sampling and Analysis Plan (SAP); a response from EPA is expected in
  July. The initial assessment will determine the level of contamination at the site, and next steps will be
  determined based on the initial assessment.
- Staff worked with Sherman County Emergency Management Services Director, Dana Pursley-Haner with an application for an emergency portable generator. Staffed reviewed program guidelines and eligibility for another potential grant.
- Staff continues to assist the Grass Valley Market to wrap up their Pacific Power grant. Grant resulted in the installation of an electric vehicle (EV) charging station. Staff is in the process of helping navigate the grant close out process. The EV charger is operational and easily accessible. Owners have placed signage on the building being visible traveling from both directions on Highway 97 (Main Street) through the city.
- Sherman County Bus Shelter (Barn) project. MCEDD is on contract to provide grant administration of
  Oregon Department of Transportation (ODOT) Statewide Transportation Improvement fund (STIF) grant
  awards. Staff has reached out to learn more about the project and visit the project location with Sherman
  County Transportation Coordinator, Kelsi Phillips. Staff is getting acquainted with MCEDD's administration
  contract for the project.
- Oregon Department of Transportation | Carbon Reduction Program | Small Urban and Rural Program. In
  preparation to offer grant administrative assistance-guidance staff received a grant status update from the
  Oregon Department of Transportation representative about the Sherman County grant. Sherman County
  was awarded grant funds for an electric vehicles pilot project. Project components include charging
  infrastructure, implementing and testing of electric vehicles to the county fleet.
- Sherman County Housing Assistance Program: Two housing projects were closed out with grant funds disbursed: one was a rental housing development grant project in the Moro area and the other a housing rehabilitation grant project within City of Wasco city limits. As directed by County Court, staff drafted an approval letter with conditions for a new construction housing grant recipient within city limits of Grass Valley; this was approved by the County Court in April. Staff has received a few inquiries with no applications received. There are three open housing projects: two new construction housing and one rehabilitation housing project. The budget for the program shows that there is approximately \$58,000 not committed to projects yet.
- Organizational Support:
  - Staff arranged regular monthly meetings with representatives from the four incorporated cities (City of Rufus, City of Wasco, City of Moro and City of Grass Valley). Meetings focused on getting acquainted with city staff, discussing projects and needs. City personnel have been outstanding in their attendance and very supportive of continuing to meet regularly.
  - Little Wheats Day Care. Staff assisted with drafting the 2024-2025 budget estimates-forecast and offered guidance with the grant application to Sherman County for early learning funding.

- We learned that the USDA grant MCEDD staff helped submit for Sherman Veterinary Associates was awarded! The grant will support purchasing large animal equipment, another mobile vet truck, some specific training, and to support providing educational opportunities in the community.
- Sherman County Medical Clinic. Staff engaged in information gathering with a Sherman County
  Health District Board of Director. Project needs include but not limited to fostering a more resilient
  facility, looking into solar and battery storage and other energy efficiencies.
- Sherman County Historical Museum complex. Staff continues to conduct online grant prospecting
  research as time allows. Project of specific interest is to secure funds to construction an addition to
  the museum complex to allow for a dedicate area for genealogy research among other things.
- City of Grass Valley: City of Grass Valley was notified the city is being awarded 2 million from the federal community grants process. The funds are for the new wastewater facility project. Staff is participating in the community grants training for grant recipients. The city must apply for these funds to receive them and there are several requirements to access the funds.
- City of Wasco: A section of City of Wasco's wastewater line collapsed under Main Street (Oregon Highway) in May. Staff facilitated a meeting between the City and Business Oregon regarding funding options to address the immediate expenses and replacing the last of the existing old wastewater pipes which are collapsing/backing up. City of Wasco submitted an intake form and is being asked by Business Oregon to complete a full application for loan funding assistance.

#### On the Horizon:

- Sherman County PubTalk: MCEDD has grant funds to support a series of entrepreneurship networking events known as PubTalks. The last event in Sherman County was November 2022 at the Dirty Cowgirl. MCEDD is looking to hold two events in the next year within Sherman County. This work is funded by a Business Oregon Rural Opportunities Initiative grant.
- Other MCEDD staff is working with Sherman County Emergency Management in considering a joint application with Wasco and Hood River Counties for the Oregon Department of Energy's County Energy Resilience Program, where Oregon counties can apply for up to \$50,000 to support development of an energy resilience plan.
