Ken Nichols, with Avangrid Renewables, came to County Court to see if an agreement could be reached concerning the Rural Renewable Energy Development Zone (RRed) tax abatement. Consensus of

County Court is to have Avangrid go through the process of obtaining a land use approval first and then come to County Court to make any requests.

County Court felt that the normal process needed to be followed and to allow the Planning Commission to do their job as they would with any other application. During the course of the permitting process, if the application is denied, the applicant has the right to appeal to County Court. County Court felt that if they approved any agreement beforehand, it would appear they were supporting the project, if an appeal was sought.

3.0 Discussion Items

3.1 Property Owner Notice

Moro City Council sent out letters to property owners about a Public Hearing beginning at 7:15 pm on July 2, 2024, in the City Council Chambers of the Moro City Hall. The purpose of the hearing is to consider a Conditional Use for a non-farm dwelling, and Variances for Lot size and Front and Side yard Setbacks on behalf of Justin and Amy Huffman. The Huffman's own property legally described as Tax Lots 1600 & 1700 of Sherman County Assessor's Map 01S 1718AA. The property is located on the undeveloped portion of Hood Street in the City. These land use actions, including the Conditional Use and Variances in Setbacks is required because the property is Planned and Zoned Agricultural (A) and as such required larger lot size and setbacks than what would be required in a residential zone. However, this land has been platted and while unserved by City Utilities, are legally developable once service are available.

A copy of the original approval and all other information related to this proposal is available for review at no cost at the City Hall, and copies of the application and all other information concerning the application, can be supplied at a reasonable cost.

County Court does not have any concerns with this notice.

3.2 Commissioner Reports and Updates

Judge Dabulskis – Attended an Employee meeting; an AOC Board meeting; MCEDD Executive Board meeting; a Roberts Rules of Order webinar; a County Resiliency meeting; a meeting with Dan Bubb; a Regional Solutions Advisory Committee meeting; an AOC Legislative Days; LCDC Solar Rulemaking/Community Benefits meeting; an East Cascades Works Budget Committee meeting; and a Regional 911 Budget Committee meeting.

Mattie's Hump will open July 10th for harvest and then close again for about one week per ODOT.

County Court asked if the pending Mobile Food Unit ordinance includes anything about land use. Judge Dabulskis is going to look into this.

Commissioner Bird – Attended an Employee meeting; North Central Public Health meeting; SWCD meeting; Mid-Columbia Center for Living meeting; Mid-Columbia Community Action Council meeting; North Central Public Health interviews; Mid-Columbia Housing meeting; CAPECO meeting.

Commissioner Bird met with BPA representatives in Grass Valley. Commissioner Bird asked County Court if they have any questions for BPA. County Court would like BPA to come talk at a future meeting (with Drew Messenger present) and have question/answer session.

Commissioner Miller – Attended a Fair board meeting; a Lower John Day Area Commission on Transportation (LJDACT) meeting; and the Avangrid National Training Center Grand Opening in Sherman County.

3.3 Kent Water Update

Liz Mills sent Commissioner Bird a text with a Kent Water Update. The water tank should be delivered about July 10th. Water will need to be trucked in for tests to be ran and for the tank to be certified. Commissioner Bird is going to help get things set up with the Road Master and to do the hauling of the water and possibly purchase water from Larry von Borstel.

Liz stated that there are expenses that keep popping up that they did not expect that will make this project go over budget.

The County Court consensus was that the County will pay for the expenses that go over what has been ear marked for the Kent Water project to finish up the project.

3.4 Grass Valley Property

Commissioner Bird and Judge Dabulskis have both had conversations with a resident who would like the County to vacate a road near the cemetery in Grass Valley. The adjoining landowner does not want the road vacated. Commissioners did note that people do use the road to go to and from the cemetery. The County Court consensus was to leave the road as is and not to vacate the road.
