Dear Sherman County Resident:

This will be the fifteenth year that a portion of the funds generated from the wind tower projects is dedicated as an incentive to residents to live and invest in Sherman County.

On July 15, 2009, the Sherman County Court approved an ordinance establishing the **Sherman County Resident Incentive Program**. The purpose of this ordinance is to encourage and promote residency in Sherman County that will, in turn, facilitate economic development and stability. The County Court will review this program annually with the hope of maintaining it for many years to come.

To qualify as a recipient in this program, applicants must live in Sherman County at least one year and be over 18 years of age. Only **ONE** resident from each household may apply and applications will have to be submitted each year in order to qualify. To receive your 2023 Resident Incentive payment, complete the enclosed application in full and return it to the following address no later than **August 31, 2023**:

Applicants will be sent a postcard within 10 days confirming that their application has been received and approved. Qualifying residents will receive a check on or before December 15, 2023. If your application is rejected, you will be notified in writing and given instructions on the appeal process. Residents who have qualified but move out of the county before payment is sent are no longer eligible and will NOT receive a check.
