### **Construction Progress Continues on Sherman County Courthouse Addition**

It has been a great summer so far on the Sherman County Courthouse Addition. The structural steel is complete and it is exciting to begin seeing what the new campus will look like. Roofing is in progress and the exterior sheeting will be done shortly with brick work to begin by the end of August. Meanwhile, interior framing is nearing completion and rough-in of mechanical and electrical components is underway. Crews are expecting to begin hanging sheetrock in mid-August followed by interior finishes throughout the fall months.

On the existing Courthouse, final engineering and design work is being done to prepare the building to receive the new cupola which is currently under production. Once the engineering is complete, crews will begin the work of adding the necessary structural elements in anticipation of the cupola's arrival onsite.

The project team is well pleased with the high quality work that is being done by Kirby Nagelhout and their team of subcontractors. Now that the exterior is being buttoned up there will not be as much progress evident to those passing by, but rest assured that everyone is hard at work on the inside.

**FOOD** - Stock up with groceries/supplies in the weeks leading up to the event.

**TRAFFIC** - Be prepared for the likelihood of prolonged travel time. Have a supply of nonperishable food, water, medications, etc., in your car.

**COMMUNICATION** - Back-up plan, in case the cell towers are overwhelmed.

**FIRE** - This event is happening during fire season. No parking or driving on dry grass, no campfires or other open flames, etc.

### **Bats & Rabies Three Steps to Protect Your Family**

- Never handle bats AND be sure that your kids understand the importance of this.
- Make sure your pets are up-to-date on their rabies vaccine.
- 3. Use screens in all open windows.

Bats play an important role in the ecosystem, especially in controlling insects and aiding agriculture, and they pose virtually no danger to people who do not handle them, however a small percentage can carry rabies. If you find a bat during daylight hours, it is most likely unhealthy and should be avoided.

Rabies is a viral disease that affects the nervous system after exposure to a rabid animal. Exposure is usually through a bite, but saliva contact with broken skin is a possible route of entry. Effective treatment is available, but must be given soon after exposure. The rabies virus is invariably fatal once symptoms appear. Please seek medical attention immediately if you've been bitten or had contact with the saliva of a bat.

If contact does occur, DO NOT dispose of the bat, as it should be tested for rabies. A rabies treatment must be considered for anyone having saliva contact with a bat that tests positive for rabies, or if the bat is unable to be tested.

While a bite is obvious contact, contact between a person and a bat can also be considered a possible rabies exposure if a bat is found in the presence of: An unattended child, a sleeping individual, or anyone unable to rule out possible contact.

If contact has occurred, please call an Environmental Health Specialist at North Central Public Health District at 541-506-2600 for instruction and coordination of services immediately. Each occurrence is unique, and not all situations require testing.

If you find a dead bat on your property and you're certain no human or pet contact has occurred, please take extra precaution when disposing of the bat:

- Wear heavy gloves, or preferably scoop up the dead but with a shovel while wearing disposable gloves.
- Bury the bat at a depth of at least 1 ft. under the surface or dispose of it in the garbage receptacle.
- If you place it in the garbage, please consider the safety of others and ensure that no accidental contact will be made with the dead bat, by double bagging it in plastic garbage bags.
- Wash your hands thoroughly and dispose of the gloves.





### Sherman County Board of Property Tax Appeals

Do you have an interest in the tax assessment process, and a willingness to attend training sessions? Do you have working knowledge of real estate and/or finance?


The Sherman County Court needs people who are interested in serving on the Sherman County Board of Property Tax Appeals (BOPTA) for the 2017-18 term. These positions are open to <u>nonoffice-holding residents</u> of the county. A nonoffice-holding resident cannot be: a member of the county governing body, a member of the governing body of any taxing district within the county, an elected official within the county, a person employed in or hired by the county or any taxing district within the county, a former county assessor, or any appointee acting in the place of the assessor that held the office or was appointed during the tax year subject to appeal to BOPTA, or a person previously employed in or hired by the office of the assessor during the tax year subject to appeal to BOPTA.

Board members hear petitions for reduction of the real market, maximum assessed, specially assessed, and assessed value of property placed on the roll by the county assessor as of January 1, 2017. The board will also consider requests to waive penalties assessed for the late filing of real and personal property returns.

An initial training session is required for new members and for those members returning after a break in service. Board members are required to attend training approved by the Department of Revenue at least every other year unless no petitions are filed. The BOPTA board generally meets for one or two sessions during the year between February and June. The one-year term ends on June 30, 2018.
