#### 1.0 APPOINTMENT SCHEDULE

# 1.1 JEFF KASER – MID COLUMBIA PRODUCERS – RE: ROOFTOP SPACE LEASE AGREEMENTS FOR TELECOMMUNICATIONS EQUIPMENT

Mid Columbia Producers in interested in buying out Sherman County's rooftop lease contracts because access to elevators is becoming so restricted due to food safety. Elevators are considered potential bombs and MCP would like the county's equipment off of their facilities. Jeff asked if there are other suitable sites in the county. Commissioner Smith said that a tower can replace most anything. The only place there isn't another option is Kent. Jeff said that Verizon will be installing a stand-alone tower in Kent in the future.

Commissioner Smith said that Frontier TeleNet is a concern since they have equipment on two of the elevators. Judge Thompson recommended that Jeff contact Rob Myers to discuss TeleNet's situation because emergency communications is a part of this. Jeff said that they don't want to cause any interruption of service; this isn't something that has to be done immediately, but we do need to move forward and find a resolution.

Judge Thompson said that he will see Judge Perry and Rob Meyers on Monday, and will try to get a meeting set up in the near future. He said that Frontier TeleNet is investigating better ways to connect to fiber optics; to install it through the county. It is very expensive, but a necessity if we want to get new businesses into the county.

Judge Thompson asked Jeff if he was working with ODOT on the Biggs Interchange Project. Jeff said that they had, and he has concerns about having the road closed for three months. Judge Thompson said that he met with Brad DeHart recently and the project may start later than planned. If it does start later, it may impact only one harvest rather than two.

# 1.2 DAVE PETERS – COLUMBIA CASCADE HOUSING – REGIONAL HOME REPAIR PROGRAM APPLICATION

Present: Cliff Jett, Georgia Macnab, Jaclyn McCurdy, Rene` Moore.

Dave said that this new program is different those administered by Cascade Housing in the past in that they are a grant, rather than a loan. A municipality needs to sign the IGA if they want to participate. Funds will be dedicated to the City of The Dalles and allocated to the other participating municipalities as well as The Dalles.

The Court chose not to take any action at this time. Their concern was that if the county gets involved with the regional agreement it would affect our option to apply as an individual entity at a later date. Input from the city representatives present at this meeting indicated they aren't in support of the regional agreement.

Lee Langston: Just got off the phone with Three Dogs Plumbing about a proposal to replace the remaining unimproved sewer line from the Courthouse to the street. The Court told Lee to have them send an estimate.

# 1.3 GEORGIA MACNAB – PLANNING DIRECTOR – COMPREHENSIVE ECONOMIC DEVELOPMENT STARTEGIES (CED) UPDATE; RV PARK RESTROOM FACILITY UPDATE

Present: Don Beall and Karl Richter.

The CEDS list needs to be updated so MCEDD can be in sync with the Federal timeline. The Court wants to keep Wasco Annex and Workforce Housing as they are, increase Giles French to \$70,000.00, and delay Strategic Plan until the cities finish their plans near the end of the year.

The invoices and contracts for the RV Park restrooms were reviewed. Don will talk with Debbie to explain his invoices. A portion of his charges are as the General Contractor of the project and part relates to the original contract with Kiwi for the plumbing portion. Don will prepare a new contract, as there in not one on file with the County. Total cost for the fixtures and water heater is approximately \$4,300.00.

Some sort of pad is needed in front of the ADA doors for wheel chair access at the restrooms. No funds are authorized for this at this point.
