Historic Sherman County Courthouse Cupola Returns

The long anticipated return of the Cupola atop the 1899 Sherman County Courthouse, took place on March 29th as workers from Kirby Nagelhout Construction installed a replica of the structure that was removed over 50 years ago due to having been damaged by weather events, and the passage of time. In the weeks to come, restoration and painting of the outside courthouse trim will take place, allowing the building to take on an appearance very similar to that depicted in the William A. Raymond 1905 Lewis and Clark Exposition photo, which will itself be on display after the renovation is complete. Regarding other project related developments, work continuing in the courthouse with the upstairs electrical rough-in nearly complete and sheetrock-related work well underway. Painting and installation of the ceiling grid, along with trim work and floor covering, will continue until late April when major parts of the upstairs and a portion of the renovated downstairs will be ready occupancy. With installation of the Cupola now complete, landscaping related work will resume in early April, which will include final reshaping of the lawn area, planting of landscape vegetation, modernization of the irrigation system, and installation of steps and sidewalks. The final phase of renovation will take place in May and June when the spaces including and adjacent to the office of the County Clerk will undergo renovation.

The project team appreciates the continued interest and patience displayed by Courthouse patrons and community members during this busy and exciting time. Finally, Sherman County has scheduled the dedication of the renovated facility for Friday, September 7th with many details to follow in the weeks and months to come

One of the AEDs will be placed in the gym at the school; the other AED will accompany the Athletic Trainer wherever he goes with the team, whether it is a home event or an away event. If there is a cardiac arrest out on the baseball diamond, or on the football field, precious time will be saved because the AED will be on the sidelines with the Athletic Trainer.

Huskey's 97 Market Earns Kudos for Healthy Corner Store Project

Carey Hughes of Huskey's 97 Market in Moro, has earned praise from Silvan Shawe of the Gorge Grown Food Network (GGFN), regarding participation in the Healthy Corner Store Project. Huskey's 97 was part of a three store pilot program in the Columbia Gorge, working to improve access to healthy food in underserved areas.

At Huskey's 97, GGFN assisted in stocking over 850 pounds of fresh locally grown fruit and vegetable from 9 farms and the Wahtonka Community School Garden, including peaches, onions, cucumbers, peppers, carrots, apples, and pears.

"Carey and her staff were an absolute pleasure to work with, and I very much appreciate her commitment and the lengths she goes to ensure her customers have access to healthy food. She was by far the most engaged of any of the store owners, and will continue to work directly with PrairieFish and other local farmers. - •Bolster the local economy by driving more business to locally owned stores and small farmers
- •Strengthen relationships between neighbors and project partners
- •Reduce diet-related disease and malnutrition
- •Support school garden programs by providing an outlet for them to sell produce through

Hughes says "I'm happy that my customers are able to have access to fresh fruit and vegetables. Everyone from children to seniors are benefiting from VeggieRx here in Sherman County, and with the support of the Healthy Corner Store Project, we are able to have more variety and fresh locally grown produce at a good price for our customers."

Support for this project comes from The Knight Cancer OHSU Institute Partnership Community Program, which is designed to build sustainable collaborations with Oregon communities by providing grants and other resources to foster development community-identified prevention, early detection, treatment, and survivorship projects. Fire Fighters and Life Saving Techniques

On March 10th and 11th, 2018, members of North Sherman Fire Department and South Sherman Fire Department, took part in an intense training that focused on search and rescue and live fire training. In Search and Rescue, firefighters were taught how to locate trapped or missing individuals. Firefighters learned various techniques on how to remove a trapped individual from a burning structure, while keeping themselves and the person safe. In live fire training, firefighters were taught how to combat live active fire in several hundred degree temperatures. Firefighters also learned several different techniques to attack and extinguish fire. The burn trailer prop is propane based with several different props, and provides dense smoke for a more realistic environment.

Several months ago the District re-evaluated its risks on various types of fires within the District. The risk evaluation showed that no fire agency in the County had a fire apparatus equipped with Class B foam. Class B foam is used exclusively for fuel fires such as gasoline, diesel, ethanol, or other combustible liquid fuels. The new apparatus gives the District the ability to fight flammable liquid fires throughout the County. The District was able to obtain the apparatus needed through a surplus sale.

Primary Election Set for May 15th

The final day to register to vote or change party affiliation for this election is Tuesday, April 24. Registration cards postmarked by this date or submitted online no later than 11:59 pm on April 24 are valid registrations for this election. State voters' pamphlets will be mailed by April 25. Ballots will be mailed between April 26 and May 1. An absentee ballot can be requested if you will be away from home and would like to receive your ballot at a different address. The Independent Party of Oregon has opened its primary election to voters who are not members of a party for the May 2018 election. The Democratic Party of Oregon and Oregon Republican Party primaries will be only for voters registered with their party.

To receive a ballot for the Independent Party of Oregon, print out and complete the form found at the link below, sign it, and return it via email, mail, fax, or in person to your county elections office as soon as possible, but no later than 5 p.m. on April 24, 2018. This will not change your voter registration.

Your voted ballot must be received on or before 8:00pm on Election Day or it will not be counted. Postmarks do not count. The ballot return envelope can be stamped and mailed or dropped off at any official county drop site across the state. If a voter casts their ballot after the Wednesday before an election, the ballot should be left at an official drop box site to ensure it's counted. Our white drop boxes are labeled "Official Sherman County Ballot Drop Site" and are located near the following offices:

Changing Attitudes: It's not a 'rite of passage.'

Each April since 1987, the National Council on Alcoholism and Drug Dependence, Inc. (NCADD) has sponsored Alcohol Awareness Month to increase public awareness and understanding, reduce stigma, and encourage local communities to focus on alcoholism and alcohol-related issues.

Alcohol and drug use by young people is extremely dangerous both to themselves, and to society, and is directly associated with: fatalities, violence, suicide, educational failure, alcohol overdose, intimate relations, and other problem behaviors, even for those who may never develop a dependence or addiction. Adolescence is a time of heightened risk-taking, and as alcohol and drugs enter the picture, parents are faced with a unique set challenges. Parents often forgive underage drinking as a "rite of passage." They can simply sit back and hope their kids will "get through it," or they can change their attitude, and take an active role in learning about alcohol and drugs and help their kids do the

It can be daunting to talk with children about drinking and drug use, but it is well worth the effort parents put into it. In fact, research has shown that kids who have conversations with their parents and learn a lot about the dangers of alcohol and drug use, are 50 percent less likely to use these substances than those who don't have conversations. Here's opportunity when parents can reinforce that using alcohol is not a 'rite of passage.' In fostering "changing attitudes" parents can help kids understand that drinking isn't a way to feel or be independent, "cool," or to fit in socially. Young people can learn that alcohol is not necessary for having a good time and non-use of alcohol is a healthy and viable option. We can learn to respect another person's

decision not to drink alcohol.

"Alcohol and drug use is a very risky business for young people," says Andrew Pucher, President and CEO of NCADD, "and parents can make a difference. The longer children delay drinking and drug use, the less likely they are to develop any problems associated with it. That's why it is so important to help your child make smart decisions about alcohol and drugs."

An integral part of Alcohol Awareness Month is Alcohol-Free Weekend (March 30-April 1, 2018), which is designed to raise public awareness about the use of alcohol and how it may be affecting individuals, families, and community. During seventy-two-hour period, **NCADD** extends an open invitation to all Americans, young and old, participate in three alcohol-free days and to use this time to contact local **NCADD** Affiliates and other alcoholism agencies to learn more about alcoholism and its early symptoms.

Camp Rufus Sign Dedication

Wednesday, April 18 at 11:00am in Moro, Oregon the Sherman County Historical Museum will be dedicating the sign that tells the story of the military training site Camp Rufus. December 1944 to April of 1945, during WWII, a Combat Engineer Battalion, Heavy Pontoon Engineers along with an Engineer Maintenance Company totaling around 1,000 men camped along the Columbia River west of Rufus, Oregon. The weather in Rufus closely resembled that of the actual weather and river conditions which helped with the experimental construction of pontoon bridges for the proposed bridging of the Rhine River during WWII. The Kaiser shipyards in Portland, Oregon, made the newly developed parts of the bridge and all of the information about this project in Camp Rufus was carefully guarded. During WWII the Ludendorff Bridge over the Rhine River was saved and not completely destroyed but soon failed and the pontoon bridges were needed to cross the river during the war. This history will now be displayed and shared at two locations after generous donations to have these signs built. One sign is outside of the Sherman County Historical Museum and the other along the Biggs/Rufus Highway near Rufus, Oregon. Thank you to Nell Melzer, Dell Peake and Dick Tobiason for taking on this Camp Rufus project and preserving of Sherman County history.

- PLASTIC plastic bottles with a neck, plastic tubs 6 oz. to 5 gal, plant containers 4 inches & larger.
- METAL aluminum cans, tin cans (flattened), clean aluminum foil & foil baking pans, empty aerosol cans (discard cap).

Second Sort:

• All glass bottles & jars - rinsed. No lids.

Third Sort:

• Corrugated cardboard - flattened.

All items should be clean & rinsed with lids removed & flattened if possible.
