

Sherman County Courthouse Facility Final Stages

The long anticipated conclusion of the Sherman County Courthouse Addition and Renovation Project is scheduled to occur in early August. The final stages of construction include completion of all landscaping, electrical work, heating and cooling system installation, and painting. Newly commissioned artwork, as well as historic photographs, will also be on display.

Sherman County is grateful for the support and patience displayed by the residents of Sherman County throughout the construction process. The understanding of those neighbors living near the courthouse in tolerating prolonged periods of traffic disruption, noise, and dust is especially appreciated. Sherman County Receives Grant

Sherman County has been awarded a \$10,000 grant from the Preserving Oregon Grant Program offered through the Oregon State Historic Preservation Office. These funds are dedicated to rehabilitation work on properties listed in the National Register of Historic Places and were used towards the repair of the wood and metal trim elements of the original courthouse and the restoration of its unique striped paint scheme. Through historical research and microscopic paint color analysis, the design team was able to identify the original paint scheme and match the two colors that were used. This project along with the replacement of the cupola transformed the exterior of the historic courthouse to look much like it did when it was first built in 1899. The Preserving Oregon Grant helped make that possible for Sherman County to complete.

2018 General Election News

The 2018 General Election will be held Tuesday, November 6 conducted by mail. As a reminder to electors interested in becoming a candidate for city office, the filing deadline is Tuesday, August 28. Candidates must file at their local city hall. Please contact your city recorder/ administrator for office hours and other details. Nonaffiliated and minor political party members interested in partisan office Commissioner must file a certificate of nomination on or before August 28 at the clerk's office.

The final day to register to vote or change party affiliation is <u>Tuesday</u>, <u>October 16</u>. Voter registration cards postmarked by October 16 or an online registration submitted no later than 11:59pm are valid. For online registration or to update your voter

Ballots will be mailed between October 17 and 23. It's important to update your voter registration if you have moved or changed your mailing address. The Postal Service cannot forward ballots. An absentee ballot can be requested if you will be away from home and would like to receive your ballot at a different address. Your voted ballot must be received on or before 8:00pm on Election Day or it will not be counted. <u>Postmarks do not count!</u>

Substation Fire & Post Fire Resources

On July 17 the Substation fire began in Wasco County and with the help of high winds, crossed over into Sherman County rapidly becoming the top priority wildfire in the nation. With the significant threat to farms and ranches along with Level 3 evacuations in many areas, it became apparent that everyone had to do their part to help deal with the effects of this devastating fire.

A group of "Sherman County Alumni" lead by Jamie Whitley put together a donation site at www.gofundme.com/substationfirerelief in order to help raise emergency funds for those who had to pay for housing and travel, lost wages, fought on the fire lines and took time away from work or any other fire related expense that caused a hardship.

I received a call from Jamie asking for assistance finding help to distribute funds in a responsible way throughout the county and to seek further donations. I made several calls for donations and quickly set-up a group of dedicated "can-do" minded volunteers. A \$2500.00 donation from the Eastern Oregon Coordinated Care Organization (EOCCO) was received after a single call. The Greater Oregon Behavioral Health, Inc (GOBHI) created a deductible donation site at www.gofundme.com/substation-fire-relief-deductible and matched all donations from their employees at 100%.

Kevin Campbell, the Executive Director of GOBHI, had \$4600.00 in Visa gift cards delivered to me the day the evacuation order was lifted back to Level 2. I was able to get those cards in the hands of our volunteer group and then sent out Facebook posts and other communications to spread the word. These funds started helping those in need that very day.

To date we have raised roughly \$15,000.00 and have distributed approximately \$12,600.00 in gift cards. The level of generosity, teamwork and volunteer spirit is alive and thriving in those who live in and love Sherman County.

First Sort: Commingled:

- PAPER white and colored paper (staples OK) newspapers, magazines, catalogs, junk mail, phone books, paperback books, spiral-bound notebooks, shredded paper in a paper bag, cereal & cracker style boxes (liner removed), cardboard tubes, paper bags, egg cartons, milk cartons & juice boxes.
- PLASTIC plastic bottles with a neck, plastic tubs 6 oz. to 5 gal, plant containers 4 inches & larger.
- METAL aluminum cans, tin cans (flattened), clean aluminum foil & foil baking pans, empty aerosol cans (discard cap).

Second Sort:

• All glass bottles & jars - rinsed. No lids.

Third Sort:

• Corrugated cardboard - flattened.

All items should be clean & rinsed with lids removed & flattened if possible.
