1.1 9:00 a.m. Amber DeGrange, Juvenile – Vacant Office Space Discussion

Present: Amber DeGrange, Brad Lohrey, Elizabeth Mills, Isabella Mills, Julie McAlister-Wynne, Katie Woodruff, Molly Rogers

Amber DeGrange, Juvenile Director, proposed a temporary Family Resource room in the vacant Prevention Office. The room would offer a comfortable environment during interviews with children victims, as the current interview room was housed within the Sheriff's department, and was not child friendly. KIDS Center had purchased furniture, via grant funds, to be used by the County, and she would provide toys and games. She stated the room could be used for other instances as well, such as families during court hearings.

Brad Lohrey, Sheriff, supported the proposed use of the room. He stated individuals in adjoining rooms were on board with the idea, and noted it would be of no cost to the county to implement. If it did not work out, it could easily be vacated.

The Court explained the room was vacant due to the need for sound proofing, and long term availability was unknown. They liked the idea of a Family Resource room, but still wanted to follow through with having the room sound proofed.

Consensus of the Court was to approve the temporary use of the vacant Prevention Office as a Family Resource room.

1.2 9:15 a.m. Elizabeth Mills – Kent Revitalization Project

Present: Elizabeth Mills, Isabella Mills

Elizabeth Mills presented a revised Kent Revitalization project on behalf of the Kent Community, and a water analysis report for the Kent Water District. Previously, she and Shirley Decker had presented the Kent Revitalization Project to the Court, which resulted in a request to have the water study completed. Due to the time lapse, Elizabeth provided a recap of the initial revitalization project by presenting a revised proposal. The 2019 proposal included: a general clean-up of the community, Highway 97 safety, water systems improvements, road improvements, business ideas, housing needs, potential community center, creating a park, tourist attractions, high speed internet, paving of roads, and the addition of Kent to County brochures. She noted some items from the initial proposal had been addressed, and were removed from the current proposal.

The Kent Water District water analysis study contained information and quotes for improvements ranging from current system repairs, to piping new lines, adding fire hydrants and more storage. Additional quotes were provided for electrical updates, and installing a new pump at the non-working Norton Well. Commissioner Bird asked what it would take to get the Norton Well up and running; Elizabeth replied it needed electrical updates, and a new pump, which was quoted at \$14,105. Commissioner McCoy inquired whether making the Norton Well functional, would make a significant difference to the water supply; Elizabeth stated it would not, it would be a backup as it would only provide a small increase; the analysis report suggested a larger cistern be placed by the main well to increase the water supply.

Commissioner Bird questioned whether residents were able to water; Elizabeth stated they can water, but not liberally, they have to conserve. Residents are asked to monitor the meter at the pump, and stop watering if it indicates. She explained that due to the lack of water storage, there would be no way to put a structure fire out. She had spoken with South Sherman Fire District Fire Chief, Glenn Fluhr, who suggested a minimum of 100k gallons storage to provide fire protection.

The Court asked Elizabeth to research what could be done to help the water supply with \$150,000, and present the information to the Budget committee during the 2020-2021 meeting.
