A quorum was present. No news media was present.

1.1 9:00 a.m. Cindy Brown - OSU Extension - OSU vehicle

Present: Cindy Brown

Cindy Brown, OSU Extension, requested a written quote from the County, for the retired Veterans' Services Chevrolet Traverse. Due to OSU's policy, in order to purchase the vehicle from the County she would need to provide them with three comparable quotes. She will report back after the quotes have been submitted.

Judge Dabulskis inquired as to who the new Extension Agent would be; Cindy replied Jacob Powell had accepted the position, and is intended start September 16th. He will be serving both Sherman, and Wasco County.

She briefly discussed a new 4H class, 4H projects with the School, and the 2019 Fair.

1.2 9:15 a.m. 9:10 a.m. Debbie Hayden – Finance Director – PERS

Present: Debbie Hayden

Debbie Hayden, Finance Director, presented information on the Public Employees Retirement System (PERS) Employer Investment Fund, explaining the program was created to help entities pay off unfunded liability, by reducing employer contribution rates. Public Employers will be offered up to 25% in match funding, after making a lump-sum contribution into a new Side Account. Debbie presented two funding options; if the County made a \$320,000 contribution, and received \$80,000 in match funding, a \$400,000 side account would be created, and over 20 years the county would have projected savings of \$692,037.44. If a \$1.2 million

contribution was made, with \$300,000 match, a \$1.5 million side account would be created, and have a projected savings of \$2,595,140.40 over a 20 year period.

Commissioner McCoy inquired whether Debbie recommended the County take part in the program; she replied that with the program willing to match up to \$300,000, and the substantial savings the County could see, she thought it could be.

Commissioner Bird asked if the funds would be available when needed; Debbie responded he side account would belong to Sherman County, and would not be able to be used by anyone else. Although, the intention of the side account is to drop the County's rates, the funds would not be readily available.

Judge Dabulskis questioned if there was a downside; she stated her concern was with the mandatory requirement to enroll in the Unfunded Actuarial Unfunded Restitution Plan, and whether the County would be required to pay out to the Plan. However, she had learned that mandatory membership was designed to help bolster membership and cause employers to be more invested in paying for their retirees.

Commissioner Bird inquired to where the funds would come from if the lump-sum contribution was made; Debbie explained funds had already been earmarked for PERS, and the additional funding needed would come out of the SIP additional fees.

Debbie requested the Court authorize her to submit an application, to determine the County's eligibility to receive match funding.

Motion by Commissioner McCoy, second by Judge Dabulskis, to allow Debbie Hayden, Finance Director, to submit a Public Employee Retirement System (PERS) Employer Investment Fund application.

A brief discussion was held on the contract with Windwave/Inland Development. County Council was working on adding a non-compete clause, and the alternate route pricing.
