# Sherman County Sixth-Graders enter eCybermission Challenge

A group of Sherman sixth-graders took honorable mention at a U.S. Army Educational Outreach Program event for their fire protection robot prototype idea.

Allison Rolfe, Emma Goodenough and Renan Christiansen participated in the eCYBERMISSION challenge this spring, competing against teams of young scientists across Oregon. The students took on this project outside of school and sports activities. They designed, sketched, and built a prototype, compiled scientific evidence to back their claims, and interviewed local experts within the community.

"They scored just below the second place team and got great judging marks all around," said Sherman County School librarian and instructional assistant Deanna Christiansen. "This placed them in the top three with much larger schools from Corvallis and Portland metro area."

Sherman County is offering two **CASH GRANTs** to ease costs and address the demand for more livable housing in Sherman County. Act now before the money runs out!

The *New Rental Housing Development Grant* will contribute \$10,000 per new rental housing unit constructed to the developer. Funds are given as a grant upon completion of the project with a commitment to keep the property as a long term rental for a minimum of 5 years.

The *Housing Rehabilitation Grant* provides a reimbursement grant of up to 20% of eligible expenses, not to exceed \$20,000, for the rehabilitation of existing non-owner occupied stick-built dwellings.

The General Election voter registration deadline is October 13.

Upcoming City Mayor & Council Positions: Voters residing in cities will elect mayors and council members to fill expiring terms at the General Election. The filing window for these offices is no sooner than June 3, 2020 and no later than August 25, 2020. Candidates must file with their city election officer by paying a fee or by petition to obtain signatures of active registered voters residing within the city and meet any charter requirements. All petition signature sheets must be approved in writing by the city elections officer before circulating. # Eastern Oregon Opioid Solutions

Eastern Oregon is no stranger to the opioid epidemic, yet resources to address the issue are stretched thin across a vast geographic landscape.

A new program has emerged to tackle this issue: Eastern Oregon Opioid Solutions (EOOS).

Housed within a nonprofit behavioral health organization, Greater Oregon Behavioral Health, Inc. (GOBHI), EOOS is engaged in an ongoing initiative addressing morbidity and mortality from the opioid crisis region wide. In Sherman County, the program has supported the training in and distribution of naloxone, a life-saving opioid overdose reversal drug, to members of the general public, first responders and community partners. EOOS also oversees a number of educational initiatives, offers technical assistance for clinical entities establishing or strengthening treatment programs and oversees a statewide learning collaborative around medication-assisted treatment. EOOS leverages federal funding\* to create innovative solutions to combat substance misuse and overdose.

"I was initially hesitant about moving what would have been an in-person to Google Meets because this work is strongest when you are able to shake someone's hand, look them in the eye a

and give them the information and skills they need," said Kelley Butler, Opioid Response Program Associate and naloxone trainer at GOBHI. "But we managed to train 26 people across the county. That's enough to start to see a transformation in a small community."

Butler has trained a wide range of professionals, from law enforcement to emergency medical service providers, in the practical application of Narcan (naloxone). She is working directly with Amy Asher, Sherman County Prevention Coordinator to ensure every individual that is trained has access to the life-saving medication free of charge.

How To Connect With EOOS:

# Noxious Weeds Growing in Rufus and Biggs

Rush Skeleton Weed, Yellow Star Thistle, Diffuse and Russian Knapweeds and Puncturvine are found frequently on roadsides, abandoned lots, yards and pastures. All of these weeds yards and pastures. All of these weeds are listed as "A" or "B" Class in Sherman County, which means the Landowner is required to prevent them from going to seed.

Some of the weeds, such as Yellow Star Thistle, are toxic to horses and can cause a condition similar to "lock jaw", which prevents the horse from eating or drinking, eventually leading to death. Most of these species also form dense stands which help spread fires, such as the fire in June of 2018. Common rye, which is a grass that can grow 3 to 5 feet tall in dense stands, is also a fire hazard, but it is not a listed County Noxious Weed due to its abundance. Noxious Weeds are those considered to be a threat to agriculture and the economy, but fire danger should also be considered.

The first step to good weed control is identification, knowing what weeds you are dealing with, which will lead to the best methods for control. County Staff through the Weed District will be attempting to contact those individuals with known weed issues by in-person visits, phone or letter to help you identify the problems.

## Sherman County Board of Property Tax Appeals Board Openings

The Sherman County Board of Property Tax Appeals (BOPTA) has board openings for the 2020-21 tax year. These positions are open to nonofficeholding residents of Sherman County. A nonoffice-holding resident cannot be: a member of the county governing body, a member of the governing body of any taxing district within the county, an elected official within the county, a person employed in or hired by the county or any taxing district within the county, a former county assessor, or any appointee acting in the place of the assessor that held the office or was appointed during the tax year subject to appeal to BOPTA, or a person previously employed in or hired by the office of the assessor during the tax year subject to appeal to BOPTA.

Board members hear petitions for reduction of the real market, maximum assessed, specially assessed, and assessed value of property placed on the roll by the county assessor as of January 1, 2020. The board will also consider requests to waive penalties assessed for the late filing of real and personal property returns.

An initial training session is required for new members and for those members returning after a break in service. Board members are required to attend training approved by the Department of Revenue at least every other year unless no petitions are filed. The BOPTA board generally meets for one or two sessions during the year between February and June. The one-year term ends on June 30, 2021.

- PAPER white and colored paper (staples OK) newspapers, magazines, catalogs, junk mail, phone books, paperback books, spiral-bound notebooks, shredded paper in a paper bag, cereal & cracker style boxes (liner removed), cardboard tubes, paper bags, egg cartons, milk cartons & juice boxes.
- PLASTIC plastic bottles with a neck, plastic tubs 6 oz. to 5 gal, plant containers 4 inches & larger.
- METAL aluminum cans, tin cans (flattened), clean aluminum foil & foil baking pans, empty laerosol cans (discard cap).
