1.0 Appointment Schedule

1.1 9:03 a.m. Al Barton – Counseling Concerns

Al Barton started by going back to 2015 and what services were offered and are still offered. Services can be diagnosis, treatment and/or support. Mr. Barton talked about Qualified Mental Health Professional (QMHP), who they are and what they can do. QMHP can be a Licensed Professional or Licensed Clinical Social Worker. Dan Hoffman treats children and adults. Megan Stone is a Case Manager and teaches coping skills and provides supports to the qualified mental health professionals. Mr. Hoffman and Ms. Stone have offices in the old school here in Moro. Ms. Stone also sees clients at their homes. Dr. Ferber is a Psychiatrists and sees children 17 and younger. Dr. Colman sees adults 18 and older. You do have to travel to The Dalles to see a Psychiatrists. James Tuning is a Drug and Alcohol Counselor and he comes to Sherman County once a week and has an office in the old school here in Moro.

Crisis support 24/7 are able to respond to behavioral health emergencies.

Sheriff Lohrey said that his office would like Center for Living to give a certificate indicating that the client is no longer a danger to themselves or others. Dr. Gower said that she will look into this practice. If a certificate is not currently being given, then one should be.

Commissioner McCoy stated that he would like someone from the Center for Living to come at least once a year to Court and give a report. Commissioner McCoy also stated that when the new School Based Mental

Health Professional is hired and on board, he would like them to come to Court, present to Court and meet everyone.

1.2 9:48 a.m. Wes Owens, Sherman School District Superintendent - Quarterly Report

Wes Owens wanted to say thank you Judge Dabulskis for coming to the School Board Meeting on Monday and for giving the School Board legislative updates. Thank you to the board and community for all of the SIP agreements, Science Teacher Grant and college scholarships that support our school and students.

Mr. Owens stated that the Student Success Act has an 84 page manual to detail how to apply for the funds. School officials are looking forward to having conversations about where that money might be infused. For Sherman County School District, it amounts to about \$250,000 available which is huge for our small school. A survey was conducted during parent/teacher conferences and 150 responses were received. School employees are now compiling the data from the surveys. Survey results are on our website if you would like to take a look.

The Library staff want to thank you for the new windows. The North Playing Field is almost complete. In the spring, the community will be able to enjoy watching Little League games. The North Playing Field project has been a collaboration between the Athletic Foundation and the school district. Auxiliary Field is almost ready and this will be a playing field as well as an area for community members. This is the last piece of the building project.

No BOPTA appeals filed. We are working on preparations for the upcoming May 19th elections. Security plans have been approved by the state. We adopted a Risk Management Policy in August 2016. Now, our next step is to go through and adopt an Enterprise Risk Management Plan. This is just a higher level plan for our Risk Management Policy. We will start by having a couple meetings a year and work up to 3 or 4 meetings a year. They are giving us 2 to 3 years to get this Enterprise Risk Management Plan going. Representatives from finance, legal, human resources, public works, parks, police and fire will make up the team. The team will include all elected officials including legal counsel. This is a mandate by our insurance carrier.

Mrs. McDermid is using examples of a mission statement and agenda from another county and says we are just using more departments in our structure. They just want us to look around the county and identify things that could be risk factors.

This is more along the lines of things that could happen that could cause the County to be sued. This packet shows things that could happen; that have happened in other Counties. The purpose of this Plan is to reduce those risks. The first step is to come up with a mission statement and then go from there.

Paul Yoon reports that the trash in Biggs is an issue. The trash looks bad and it flies onto Highway 30 and BLM land. It seems like the trash is coming from Pilot. If Pilot could put up a fence, the trash would blow into the fence and not onto the highway. We need additional signage on Scott Canyon coming from Wasco. Giles

1.5 10:22 a.m. Cindy Brown and Jacob Powell, OSU - Quarterly Report

Present: Cindy Brown, Jacob Powell, Dan Son, Michael Held

Cindy Brown is the Positive Economic Development side and Jacob Powell represents the Agriculture side of Extension. On the 4-H side, they use the term Positive Youth Development for 4-H. Mrs. Brown attends the Sherman Prevention meetings. A lot of what they do in Extension is prevention. They provide healthy, wholesome activities to do instead of drinking and driving and doing drugs. The challenge with that is that 4-H in Sherman County is doing a good job attracting the younger kids. Especially this year, since the funding changed and now she does more with 4-H and Youth Core. They have decided to expand out to the Cloverbuds program which is 5-8 year olds. They have 16 kids in their 4-H Cloverbuds program, most all of which are from new 4-H families. Their outreach to new families is great and they will be able to bring them into the 4-H system. Last year the program added a Drama and Photography Club. They are trying to give kids a variety of options.

On the school side, extension has a really nice partnership with the school because they are working hand-in-hand with educational activities. They continue to help provide the after school programming with the teenagers in the fall and the elementary kids with the cooking programs after school. Mrs. Brown did start going to the Educational Foundation meetings because the Educational Foundation is doing the same thing to add on and to enrich the programming that the school has. The Extension program lets the kids taste test OSU food recipes, primarily fruits and vegetables to expose them to a variety of tastes.

Jacob Powell reported that he started his new position in October and has started connecting with farmers in the area. He has been attending workshops and conferences that local farmers are at and that has been a great way to connect and get to know people.

Feb 10th from 10-3 at Columbia Gorge Community College Mr. Powell will be holding a workshop to go over firefighting OSHA regulations and guidelines.

Mr. Powell is in Moro 3 days a week and The Dalles 2 days a week.

Michael Held is with Business Oregon. Mr. Held is filling in for Nate Stice today and giving the Regional Solutions Quarterly Report. Evergreen State Holdings in Grass Valley did get their temporary certificate of authenticity and they are up and running again. They have been able to work through the building code issues. The Regional Solutions Team as a whole have been monitoring the situation, especially the building code division. The other update is Grass Valley Wastewater. Carrie Pipinich from MCEDD and Nate Stice have an RFQ that they are working on to come up with a process of ranking and scoring for some engineers to look at some engineering to start scoping out what that system should look like.

Dan Son gave an update on the Lower Deschutes weed project. The Weed Department surveyed 32, 922 acres through the season. They would like to have an aerial survey done and then subsequent treatment down the road. The Weed Department would like to look into aerial spraying for Rush Skelton weeds. The department has made good headway on the Scotch Thistle and The Yellow Star Thistle. Mr. Son will be hiring for seasonal help to start in March or April.

Georgia Macnab stated that two cell tower applications have now been completed. The Repower out at Klondike will have a hearing on January 27^{th} . The Repower is to replace the blades and upgrade the equipment to extend the life of the towers. On January 27^{th} there will also be a floodplain ordinance update meeting. The last floodplain update was done in 1987.

Mrs. Macnab stated that the roof on the laundry side in the Sherman County RV Park is missing shingles and causing leaks. They have had the roof repaired a few years ago. The shingles keep blowing off.
