Aaron Geisler opened the Finnegan Bridge bids as follows:

Marcum & Sons, Redmond OR - \$484,825.59 HP Civil, Stayton, OR-\$677,694.27 Waldron and Sons, Bend OR - \$547,032.80 Legacy Contracting, Stayton, OR - \$717,869.95 Crestline Construction, The Dalles, OR - \$806,111.00 Oregon State Bridge Construction, Stayton, OR - \$685,098.00

Aaron stated that the engineers estimate for the Finnegan Bridge project was \$492,925.00.
