- Whereas it is the sense of the people of Sherman County that it is in the interest of Sherman County that Oregon begin
 negotiations with idaho to relocate the Oregon/Idaho border to make the territory of Sherman county become
 territory of Idaho,
- 2. Therefore, the people of Sherman County ordain as follows:
 One of the responsibilities of the County Court shall be to promote the interest of the County in the relocation of Idaho state borders. This responsibility includes overseeing a program to provide information to members, officers, employees, and agents of US Congress, the Oregon Legislative Assembly, the Idaho Legislature, and Federal, State of Oregon, and State of Idaho agencies, and other county governments. Also, to make requests, to any of the aforementioned, that are likely to influence border relocation negotiations to be more beneficial to the interests of the County.
