Wes wanted to say thank you to all the front line workers, emergency responders, school staff and the county for their help and support during this time.

The school is setting up education online. Online course work has been a slow and rocky process but teachers are doing their best to give the students great interactive curriculum. The school is continuing to offer "to go" lunches. Staff have been delivering chrome books and band instruments to students. Our hearts go out to our seniors who won't be able to participate in all of the senior festivities this spring.

Wes stressed that the internet is a problem for parents, students and teachers. He is asking the Court to help with this problem. Commissioner Bird and Commissioner McCoy told Wes that each community has a hotspot in it that was hooked up while the fiber was being installed. They also told Wes that Judge Dabulskis had asked Ryan LeBlanc with Sage Technologies to look into this problem and see what can be done so that the school and health professionals as well as residents can use internet. This falls under Section 8 of the Order 2020 in the Sherman County Emergency Declaration Resolution 04-03-2020.

Dr. Marta Cronin shared that Columbia Gorge Community College recognizes a serious gap in skilled workers and affordable housing in the Mid-Columbia region. Thanks to commitments from City of The Dalles, Wasco County and the College Board. Columbia Gorge Community College secured \$7.3 million to leverage \$7.3 million in state bonds. As a result, we have raised \$14.6 million for this project.

Total construction budget (not including soft costs) is \$11.2 million. The college designed its housing business model on 72-bed capacity. Escalating construction costs and the college's commitment to its funding partners to invest a minimum of \$7 million in the workforce skills center require the college to reduce housing bed capacity, together with value engineering measures identified for both the housing and skills center. The college still wishes to provide at least 51 beds, which is still economically sustainable. Under current construction budget projections (100 percent design development), the college anticipates a short fall of approximately \$2.1 million for the combined skill center and student housing projects.

The college proposes that Sherman and Gilliam counties invest a combined total of \$2.5 million in the skill center and student housing projects, enabling the college to provide housing capacity for 51 students and complete all construction as scheduled by Summer 2021. This would cover the anticipated construction budget deficit and provide nearly \$400,000 toward the initial costs of skill center instruction. In return for this investment, and in order to encourage long-term enrollment growth from Sherman and Gilliam counties at Columbia Gorge Community College, the college proposes to waive up to \$5,000 in annual tuition per student for up to 17 residents each from Sherman and Gilliam counties (34 total) for a period of 15 years. Waiver would apply to incoming high school graduates and older workers seeking new skills.
