#### 1.1 9:00 a.m. 9:58 a.m. Aaron Geisler, Finnegan Bridge Project Update

Aaron Geisler, Bridge consultant, gave an update on the Finnegan Bridge project. The project is still on schedule. Paving will start on Tuesday, July 21. Traffic will be switched over after the paving is completed.

#### 1.2 9:15 a.m. 9:08 a.m. Paul Conway, Veterans Services Quarterly Report

Present: Paul Conway, Carrie Pipinich

Paul Conway, Tri-County Veteran Service Officer, attended a transportation meeting and found out that the Veterans Department funds can no longer fund Veteran transportation. Paul did find out that there are grants available that Sherman County is not currently getting that can fill this gap. Paul told Marnene Benson-Wood about the grants and suggested that she reach out to Marla at Gilliam County who is currently receiving these grants. Some of these grants are Veteran specific and some are not.

COVID is preventing some of the outreach that Paul would like to be doing such as coffee hours.

Paul says that he is getting many calls from the mailer that he sent out. He is very happy with the results of the mailer.

Paul finished the TRIP training (Training, Responsibility, Involvement, and Preparation of Claims Portal) online in April. On July 27 Paul will take the Milestone exam which is a 6 month exam. Then 6 months later he will take the Accreditation exam.

Paul is a certified Assister for the Oregon Health Plan. Now he is also certified to do the advanced Oregon integrated eligibility which not only does the Oregon Health Plan but also does Medicaid for the elderly and disabled.

Carrie Pipinich, representing MCEDD, discussed the COVID-19 Emergency Business Grants that are currently available through MCEDD. #### 1.5 10:00 a.m. 10:02 a.m. Tina Potter, Tri-County Corrections Quarterly Report

Present: Tina Potter, Ryan LeBlanc

Tina Potter, Tri-County Corrections, gave an overview of what has been happening in her department this quarter. Tina talked about the pandemic and how it has impacted the department. Governor Brown commuted sentences for some inmates and so far none of those people are coming to Sherman, Gilliam or Wheeler Counties. Tri-County Corrections are doing things a bit differently due to the pandemic. They are doing minimal home visits. They did not have a work crew in April or May. The work crew started up in June but now they do not have a supervisor so work crew is on hold again.

Caseload is 28 funded active cases, 56 warrants and a total of 104 cases in Sherman County. They are at 55 funded active cases in the Tri-County area.

### 1.6 10:15 a.m. 10:16 a.m. Ryan LeBlanc, Sage Technologies

Present: Ryan LeBlanc, Dan Bubb

Ryan LeBlanc, Sage Technologies, handed the court a quote for engineering and project management of Phase II Ty Ridge site. This quote does not include the installation fee from Gorge Net. Phase I Erskine County Court Minutes – 7/15/2020 - 2 -

is fully installed. Gordon Ridge is fully installed. Ryan is working with a network engineer from Gorge Net to get them connected.

The systems is engineered so that RTG and Gorge Net can both be on the line for a little while. Gorge Net will have access to the trouble tickets and the huts.

There was discussion about how RTG has not kept up with parts of their contract with Sherman County. Paragraph 3 says that every year that they will submit a letter of request to renew. No letter has been received since 2011 when this contract was originally signed.

Paragraph 2 says that they will make a payment by the 10<sup>th</sup> of each month and to provide access to their custom records for account as to how many customers are on the system. Ryan has asked RTG for customer information last month and gave them until July 10<sup>th</sup> to provide that information and they have not responded.

Judge Dabulskis said that legal counsel was looking over the contract and would get back to the Court on this matter.

Both systems can operate for a few months side-by-side except in Kent and maybe the elevator in Moro. There is a need to know which RTG customers are in Kent and use the Moro elevator before they accidentally get turned off of service.

## 1.7 10:30 a.m. Dan Bubb, Gorge Net

Present: Dan Bubb, Ryan LeBlanc,

Dan Bubb, Gorge Net, led a discussion about cost for service. Gorge Net intends to offer a tiered cost of services available.

The RTG agreement has a provision that they pay the County \$6 a customer for using the system. Commissioner McCoy asked Dan Bubb what Gorge Net was offering the county. Gorge Net is offering their tower and site on Ty Ridge at no cost and the management of the system county wide and to work with Ryan LeBlanc as the project manager in turn that they can use the system at no cost.

Judge Dabulskis did mention that this internet upgrade was due to COVID-19 and the urgent need to get internet to the rural areas of Sherman County. With this in mind, it is possibly that the county will need to go out for bid for a new IFP in three to five years.

Dan said if we can come to a conceptual agreement today, we would like to start working with Ryan and get two sites completed each week for the first three weeks of August.

The Court consensus is that we will go with Gorge Net. We will not vote on it until we have a contract and counsel reviews it. Judge Dabulskis talked to Dan about managing the fiber for the use of the fiber that was just put in down at Rufus. We will continue this discussion.
