 Leave a message with the number of meals you would like and the names on each meal. We put the meals out front at 12pm, wrapped in foil with names on post-it notes placed on each plate. We provide an entrée, side dish, salad and dessert each day.
- 4. How do we pay for our meals? We have a donation box out front each day where you can leave your donation. or you can call us to purchase a meal card that we'll keep on file for you.

5. How do we know what is on the menu?

We post our monthly lunch menus online on the Sherman County website. They are also posted in the local post offices, and a copy is always taped to our front door. 6. Why does nobody answer the phone when I call?

Typically we are in the kitchen, away from the phone. We check messages each morning to gather lunch orders, but if you have a question or need a call back please leave a voicemail with your contact info and we will return your call at our earliest convenience.

In Honor of Veterans Day

In Honor of Veterans Day, we thought we would share these interesting facts about Arlington Cemetery and the Tomb of the Unknown Soldier.

Arlington Cemetery

This is really an awesome sight to watch if you've never had the chance. Fascinating. Tomb of the Unknown Soldier.

- 1. How many steps does the guard take during his walk across the tomb of the Unknowns and why?
- 21 steps: It alludes to the twenty-one gun salute which is the highest honor given any military or foreign dignitary.
- 2. How long does he hesitate after his about face to begin his return walk and why?
- 21 seconds for the same reason as answer number 1.
- 3. Why are his gloves wet? His gloves are moistened to prevent his losing his grip on the rifle.
- 4. Does he carry his rifle on the same shoulder all the time and, if not, why not?

He carries the rifle on the shoulder away from the tomb. After his march across the path, he executes an about face and moves the rifle to the outside shoulder.

- 5. How often are the guards changed? Guards are changed every thirty minutes, twenty-four hours a day; 365 days a year.
- 6. What are the physical traits of the guard limited to?

For a person to apply for guard duty at the tomb, he must be between 5'10" and 6'2" tall and his waist size cannot exceed 30.

They must commit 2 years of life to guard the tomb, live in a barracks under the tomb, and cannot drink any alcohol on or off duty for the rest of their lives.

They cannot swear in public for the rest of their lives and cannot disgrace the uniform or the tomb in any way.

After two years, the guard is given a wreath pin that is worn on their lapel signifying they served as guard of the tomb. There are only 400 presently worn. The guard must obey these rules for the rest of their lives or give up the wreath pin.

The shoes are specially made with very thick soles to keep the heat and cold from their feet. There are metal heel plates that extend to the top of the shoe in order to make the loud click as they come to a halt.

There are no wrinkles, folds or lint on the uniform. Guards dress for duty in front of a full-length mirror.

The first six months of duty a guard cannot talk to anyone nor watch TV. All off duty time is spent studying the 175 notable people laid to rest in Arlington National Cemetery.

Every guard spends five hours a day getting his uniforms ready for guard duty. Eternal rest grant them O Lord and let perpetual light shine upon them.

In 2003 as Hurricane Isabelle was approaching Washington, DC, our US Senate/House took 2 days off with anticipation of the storm. On the ABC evening news, it was reported that because of the dangers from the hurricane, the military members assigned the duty of guarding the Tomb of the Unknown Soldier were given permission to suspend the assignment. They respectfully declined the offer, "No way, Sir!" Soaked to the skin, marching in the pelting rain of a tropical storm, they said that guarding the Tomb was not just an assignment, it was the highest honor that can be afforded to a service person.

The tomb has been patrolled continuously, 24/7, since 1930.

WINTER FIRE PREVENTION TIPS

The USFA's Winter Residential

Building Fires (PDF, 1 MB) report
shows that each winter an estimated 108,400 residential building fires
occur in the United States, resulting
in 945 deaths, 3,825 injuries, and
\$1.7 billion in property loss. Cooking is the leading cause of winter
residential building fires at
36 percent followed by heating at
23 percent. Winter residential
building fires occur mainly in the
early evening hours, peaking from 5
p.m. to 8 p.m.

The NFPA and USFA recommend following these safety tips to prevent winter home fires:

- Stay in the kitchen when you are frying, grilling, or broiling food. If you leave the kitchen for even a short period, turn off the stove.
- Space heaters need space;
 keep anything that can burn at least three feet away from each heater.
- Check electrical cords often and replace cracked or damaged electrical or extension cords. Do not try to repair them.
- Never use your oven or stovetop to heat your home. They are not designed for this purpose and can be a fire hazard. In addition, carbon monoxide (CO) gas might kill people and pets.
- Do not put your live Christmas

tree up too early or leave it up for longer than two weeks. Keep the tree stand filled with water at all times.

 Avoid using lighted candles. If you must use candles, place them in sturdy candleholders that won't burn.

If you smoke, use only fire-safe cigarettes and smoke outside.

- Hear petitions for reduction of the real market, maximum assessed, specially assessed, or assessed value of property as of January 1, 2020, or as determined under ORS 308.146;
- Hear petitions for reduction of value corrected under ORS 311.208;
- Hear petitions for waiver of penalties for late filing of real or personal property returns.

The board will meet at the Sherman County Courthouse in the Commissioners Meeting Room located at 500 Court Street in the city of Moro, Oregon. A schedule of hearings for those who request to be present will be posted 48 hours prior to the meeting on the door of the Commissioners Meeting Room at the Sherman County Courthouse, Moro, Oregon.

If you have requested to be present at the hearing, you will be notified of the date, time and place to appear. All other hearings will be scheduled as time allows. We request you provide your additional appeal evidence at least seven (7) working days prior to your hearing so that we may make copies for the board members and the Assessor's office. Please mail, hand deliver or fax your additional evidence. Please do not email your evidence. If you wish to present your additional evidence at the hearing, please bring five (5) copies of your evidence with you. In order to most effectively use the time allocated for your hearing, it is best to have all evidence prepared and available before the hearing begins. Contact the Board of Property Tax Appeals clerk for information.

Executive sessions may be held during the session as authorized by ORS 192.660 to consider documents and information made confidential under ORS 308.290, ORS 308.411, and ORS 308.413.

It shall be the duty of the persons interested to appear at the time and place appointed. The meeting location is accessible to persons with disabilities. Anyone in need of special accommodations is asked to submit a request at least 48 hours prior to the meeting by contacting Kristi Brown at 541-565-3606.

AMBULANCE MEMBERSHIP FOR CHRISTMAS

Do you have that special someone who you just don't know what to get for Christmas? If you do and they live in Sherman County, think about an Ambulance Membership. Sherman County Ambulance has a membership program, which costs \$30 per household, per year. Also, you might think about getting a Membership for yourself, if you haven't already. This is a huge savings if you don't have insurance. An average ambulance call can be around \$2,500. The Ambulance Membership Program is also part of the reciprocal network with approximately 80 other agencies in Oregon. That means that if you need an ambulance in another city and they are part of the network, your Sherman County Ambulance Membership will cover that. If you do have insurance, we will still bill for the call, but if it doesn't pay the entire bill, the Membership will cover the balance. If you don't have insurance, the Membership covers the entire bill.

If purchasing for a gift, we will send you a holiday inspired gift certificate to give to your loved one.

ED'S ANECDOTES

When I was a young man, around 15 years old, my dad got me a summer job at the Portsmouth yard in Maine. That was full of adventure. The Nazis surrendered their U-Boat Fleet since the Great World War II was finally over. One of my working days at the naval base, I was employed as a helper on a maintenance task very close to where fleet type submarines tied to docks along the Piscataqua River. It was a beautiful sunny day and I noticed odd looking submarines approaching the far docking area. They were traveling on their own power and didn't look like American vessels. When they started tying up to the docks I went out for a closer look to learn these were German U-Boats with American navy personnel commanding their operations. This fired me up to be witnessing the end of Germany's part in WW II and the thought of peace at last in Europe. My first chance to check the U-Boats out was on a Saturday when I was not working. The newest of these German U-Boats was the U -3008. It was totally different from the older U-Boats and had something very unusual aboard. This thing was called a "snorkel" which allowed the sub to charge its batteries while submerged. The U.S. navy took its first trial with a snorkel removed from one of these boats I had watched on that beautiful summer day. The U-Boat became a U.S. experimental submarine USS U-3008. Snorkels were used on American fleet type subs thereafter.

Commissioner Miller will be on numerous committees ranging from local, regional, and state, as well as sit on County Court sessions that take place on the first and third Wednesdays of each month.

One of the many things Commissioner McCoy was working on before he left Sherman County is a Regional Stabilization Center. This will be a place for those in need of mental health help and to keep those same individuals out of our jails. I have taken Tom's place on this regional committee that is working hard to make this a reality. The Sheriffs from several counties along with health care professionals also make up the team.

The Governors' office and OHA has come out with a new set of metrics for handling each county's level of required COVID precautions based on that county's tests and cases. This is a positive response. One size does not fit all and each county is different. There is a saying amongst county governments "If you see one county, you've seen one county". Sherman County is currently one of the five counties listed in the low risk category, let us do what we can to keep us at this level.
