

ED's ANECDOTES

Life Story (USS Philippine CVA47 Sea) When I reached my fourth year in my Navy career we got orders to go to Yokosuka, Japan and join the seventh fleet in support of the carrier task force which included many different types of ships. Among them was the USS Philippine Sea CVA47. I hadn't seen my younger brother for several years and I learned from one of his letters that he would be aboard the CVA47 Aircraft carrier and arriving in Yokosuka around Christmas of that year. My plan was to somehow transfer to that ship without telling my brother. The captain of my ship was going on leave back to the States and the executive officer who was second in command was now in command. I knew him better than the captain. Much of the equipment he used to navigate was maintained by the electronics group in my area. Thankfully, Executive Officer Schnep accepted my request for transfer. It seemed like weeks and months went by and then on Christmas Eve I got orders to report to the USS Philippine Sea CVA47. My brother was totally surprised when I got to his Battery Shop in the late afternoon. We celebrated that Christmas in Yokosuka, Japan. Then on January 2 we left for port for North Korean waters. My brother and I were awarded three battle stars that year on the carrier and never saw the faces of the

Sherman County Weed District

Sherman County Weed District is hiring (2) Invasive Species Technicians to work on the Lower Deschutes Cooperative Weed Management Area.

Seasonal work will begin in March/April 2021 and run through October 2021. The technician's day to day focus will be to control the spread of invasive noxious weeds within the Deschutes River corridor using various integrative pest management methodologies including: herbicide, mechanical, cultural, and biological controls. Technicians will work as part of a multi-agency team responsible for carrying out day to day operations of noxious weed control, data collection and reporting, and GIS mapping.

<u>Primary job duties</u>: You will be part of a multi-agency team working on a long term habitat restoration project managing noxious weeds on the Lower Deschutes River. Daily activities will include surveying and treating noxious

weeds, measuring/mixing and applying herbicides, using ArcGIS and other mapping software for treatments and surveys of noxious weed infestations, operating an unmanned aircraft for invasive species surveys, re-seeding and revegetation, whitewater rafting, overnight camping, and performing daily/weekly updates to social media platforms.

Applicants must be capable of performing physically demanding labor in a backcountry setting for 10 hours a day, 4 days a week. Candidates will be required to properly identify targeted noxious weeds within their different growth stages. Applicant should expect to hike extended distances on steep, rough terrain while carrying backpack sprayers weighing up to 40 lbs. Rangeland work will be performed in an arid environment where fire danger is extreme, and safety paramount. Ideal candidates are willing to work in a variety of weather respective to central Oregon (high winds, extreme temperature fluctuations, rain, intense sunshine, etc.)

This is a great opportunity to receive training and experience with vegetative monitoring, IPM, noxious weed management, rangeland management, Geographic Information Systems (GIS), and working among a diverse group of public agencies, private landowners, and the general public.

4-H Youth Development

Yahoo, let's get started with the 2021 4-H year! The Sherman County 4-H Association announces that 4-H enrollments started in mid-January and will close Friday, February 12, 2021. We'll all be flexible and adapt to whatever changes come along, but do our best to offer positive youth development. In 2021, there may be fewer volunteer leaders, fewer clubs and/or fewer 4-H members, due to health-related restrictions and modified in-person programming. The Fair Board and the livestock leaders agree there will be a livestock show and auction no matter what.

4-H is a national, state and local program coordinated by state land grant universities, as an educational and outreach program to develop good citizens in our country. 4-H is for youth ages 9 to 19 (as of September 1, 2020). The divisions are: Juniors ages 9-11; Intermediates ages 12-14; and Seniors 15-19 (and still in high school).

Enrollment forms were mailed to last year's 4-H families, are available on-line at https://extension.oregonstate.edu/4h/sherman/become-member or can be picked up at the Sherman Extension Office, 66365 Lonerock Rd, Moro OR 97039. Enrollment is \$30/youth, with a discount for multiple children from one family.

4-H is "learning by doing"....a youth development program where kids get to do things usually only adults do......select, care for and raise live-

stock, take photographs for exhibition, learn how to cook a variety of foods, participate in clinics and workshops to learn more about livestock or healthy living, sew their own clothing or craft items for home, make money and keep track of records, cook outdoors and learn how to can fruit or make jerky, be part of an organization and participate in meetings virtually and in-person, and more.

OSU Sherman Extension continues to offer limited, in-person programming on Tuesday afternoons for all families with kids 5 and up. Starting last fall, these Extension Family Activities have introduced youth to a wide variety of learning experiences including camp crafts, painting canvas back packs, making chocolate and gummies from kits, science and Mars, stitchery, hand sewing, building gingerbread houses, plastic lacing, and leathercraft. COVID-19 Vaccine Update

The Sherman County Medical Clinic has received a very limited number of doses of the Moderna COVID-19 vaccine. We are required to follow Oregon Health Authority's guidance regarding Oregon's COVID-19 Vaccine Plan and Recommended Sequencing. As of 1/21/2021 the Clinic has administered 127 doses of the vaccine, and we are currently out of stock. We do not know when we will get more, as this is not a vaccine we can order more of. We must wait for the State to send us more. If you are interested in receiving the vaccine, please call the Clinic at 541-565-3325 and ask for your name to be added to the list. Once we receive more vaccine, we will be reaching out to those individuals who are on our waiting list. Please understand that that next phase of vaccine distribution will be based on the individual's age, not the date their name was put on our waiting list.

The Moderna vaccine is shipped in a multi-dose vial consisting of 10 doses. Once the vial is punctured, all 10 does must be administered within 6 hours. This creates an interesting logistical situation where we must have 10 people scheduled to get the vaccine, otherwise risk wasting a dose. In this current pandemic, wasting a dose of this vaccine is something we as a Clinic want to avoid as much as possible. This is a 2-dose vaccine, with the second dose being administered at least 28 days after the primary dose.

Our protocol regarding this vaccine is to require everyone to wait on-site for a minimum of 15 minutes after the administration of the vaccine so medical staff can watch for adverse reactions. If a person has had a previous anaphylactic reaction to anything in the past, we are requiring them to wait on-site for 30 minutes post administration.

As always, the Board of Directors invites your input, questions, and comments. Board meetings are held, typically, on the 2nd Thursday of every month. The next scheduled meeting will be on February 11th at 5:30pm in the Administration Office. Grant Awards Announced by Development League
