2.1 Mid-Columbia Community Action

The Oregon Housing and Community Services is requesting a recommendation from Sherman County regarding the Mid-Columbia Community Action Council receiving funding from the Oregon Housing and Community Services for the Emergency Solutions Grant funds. The recommendation consists of three commissioner signatures who are involved with the Mid-Columbia Community Action, but are signing for their specific counties. The ESG funds assist low income individuals and families to quickly regain stability in permanent housing after experiencing a housing crisis or homelessness. This is just a formality. MCCAC is the regional administrator of the ESG funds per Oregon Statue. \$3.1 million ESG funds has just been grant to MCCAC to help reduce homelessness in conjunction with several partners (which will help

fund shelter sites). However, this recommendation is for our regular ESG allocations at approximately \$27,000 for a two year period. Recommendation is due July 23rd.

Motion by Judge Dabulskis, second by Commissioner Miller, to authorize Commissioner Bird to sign documents on behalf of Sherman County for Mid-Columbia Community Action Council to receive funding from Oregon Housing and Community Services for the Emergency solutions Grant funds.
