During Executive Session COVID – 19 Religious and Medical Exemptions were discussed.

Motion by Commissioner Miller, second by Judge Dabulskis, to authorize a statement of "Do Not Respond' as of October 18<sup>th</sup>, 2021 to the ambulance volunteers that do not have an exemption on file or do not have record of COVID-19 vaccine on file and authorize Judge Dabulskis to sign the letters.

No: 0 Abstain: 0 It was decided that Dana would write a letter to the people that have filed for an exemption and Judge Dabulskis will sign the letters. The letter must include the following items: weekly testing to be provided and no charge at EMS building, wear a mask at all times during call, if you have or exhibit signs or symptoms of being sick, contact EMS Director, sign and date letter signifying that you have read and agree to the terms outlined and return letter to County Court.

Dana will also write a letter to those that do not have an exemption nor the vaccination and include the following in the letter: under the executive order of Governor Brown, unvaccinated individuals that have not submitted a religious or medical exception form and also do not have the COVID vaccine will not be able to perform or provide any medical care under the protocols for Sherman County Ambulance. If at any time your status changes you may return to providing emergency medical care under Sherman County protocols. Judge Joe Dabulskis will sign letters.

It was also discussed that those who have had COVID and cannot get the vaccination at this point, should work with their medical provider to get an exemption form filled out stating that they cannot get the vaccine at this time or file another exemption form.
