## Cicada Killer Wasps

Cicada killer wasps mistakenly identified as Asian giant hornets.

Across Sherman County and eastern Wasco County there have been numerous reports of invasive Murder hornets or Asian giant hornets. All of these sightings have been Cicada killer wasps, often mistaken for the Asian giant hornet. They are about the same size as the Asian giant hornet (1 inch long and 0.25 inch wide), but have some clear differences in their coloration and patterns on their abdomen. The Asian giant hornets have dark orange stripes that are smooth bands. Cicada killer wasps have higher contrasting yellow stripes that are peaked. Fortunately the Asian giant hornet is yet to be found in Oregon after being found in Washington a year ago. The Asian giant hornet is an invasive hornet that can kill honey bees and can

## New Housing Grant Programs

Sherman County Court approved two new housing grant programs to incentivize housing development in the county. These programs add to the suite of existing incentive programs already offered by the County to address the need for more, improved housing.

The new "Housing Property Preparation Grant" program addresses the problem of unsafe, blighted properties throughout the county while stimulating the housing construction market. It offers an up to \$20,000 grant to responsibly demolish unsafe housing units, clean up any environmental contaminants on the property, and prepare the lots for either housing redevelopment or sale. The program is not intended for residents seeking to redevelop houses they are living in. The "New Housing Construction Grant" will provide \$10,000 grants for newly

form large swarms. No one has died from their sting in the U.S., but compared to honey bees their sting is more painful and contains more toxins. They are nicknamed "Murder" hornets for their aggressiveness towards honey bees and will fight to the death for honey bee larva.

Cicada killers are native to Oregon and emerge around the end of June and are out for 60-75 days. Around September they return underground until the next year. Cicada killers can sting if annoyed, especially if you are near their underground nest, but usually they will leave you alone and are well mannered compared to yellow jackets. In addition, Cicada killers are solitary and do not form swarms like hornets. The females paralyze cicadas with a sting and then transport them back to their underground nest, which can take all day. The cicada is put in a side chamber where the wasp also lays eggs. Once the eggs hatch the larva will feed on the cicada. The male wasps are focused on finding a mate and will actually vomit on their own heads to stay cool in the heat. The wasps prefer Eastern and Central Oregon where sandy soils make it easy to dig their underground nests, usually 10 inches deep.

constructed housing units in Sherman County to fill in housing gaps. Single family, multi-family, stick built, or double-wide manufactured houses on a permanent foundation are all eligible. However, the units must be sold or occupied by the owner within 30 days of completing the project and cannot be used as a second home or short term rental.

Sherman County continues to offer grant programs to support rehabilitation of non-owner occupied housing properties and the development of new long term rental units. Additional terms and conditions for both grants can be found on the Sherman County website.

All housing grant decisions are made by Sherman County with the help of an appointed Housing Grant Review Committee. Mid-Columbia Economic Development District (MCEDD) is supporting the County in administering these programs. Marla Harvey (MCEDD Program Manager) is available to answer questions about the application and grant process. Potential applicants are encouraged to review the applications in

detail and reach out to MCEDD staff prior to starting their projects. Grant funds are not guaranteed.

### Drought Thoughts for Livestock

Dealing with drought can be especially challenging with livestock. It is critical to rotate livestock off of heavily grazed pastures during drought as it will take more time for grazed forage to regrow. Continuous grazing for several months will increase compaction and livestock will continue to graze the plants that are palatable to them without allowing plants to recover. Overgrazing and compaction increase pasture deterioration, evaporation, and run off when it finally rains again. Livestock can graze forage plants down to 3-4 inches without over grazing, but should then get rotated into the next pasture. Each pasture needs roughly four weeks of rest. Also consider improving livestock distribution by placing supplements and water in areas that are usually avoided. The worst plan of action is to open up all your gates and allow access to all your pastures as this will allow overgrazing and ultimately Continue on Page 3...

hurt your whole operation vs a smaller, yet more concentrated impact in one place.

It is better to feed animals hay in one pasture while the drought persists than try to graze drought stricken pastures. Be careful where your hay supplies are from, it can be an easy way to introduce new seeds that you might not want. Think about where you are feeding your animals hay, avoid feeding hay in the best pasture ground that you have. Another thing to consider is testing forages for nitrate toxicity before feeding, especially if grazing crops that you decided not to harvest due to drought conditions. Nitrate is the form of nitrogen commonly found in the soil and is taken up directly by plants and converted into protein through photosynthesis. When the plants are stressed, such as drought or a cold snap, excess nitrates build up and the plant is not able to break them down as photosynthesis is inhibited. Cloudy conditions and heavy smoke cover, such as last September can also lead to nitrate build up. Nitrate toxicity can be present in wheat, barley, alfalfa, sorghum, and sudangrass. Pastures can also be a problem if they are full of Kochia, lambsquater, pigweed, quackgrass, and thistles. Also during this drought some weeds might be increasing as those plants that were heavily grazed in the past are not able to compete. It is important to remember that Russian Knapweed can cause chewing disease in horses and goats if they eat too much of it.

## Board of Property Tax Appeals Board Openings

The Sherman County board of Property Tax Appeals (BOPTA) has openings for the 2021-22 tax year. These positions are open to <u>nonoffice-holding residents</u> of Sherman County. A nonoffice-holding resident cannot be:

- A member of the county governing body
- A member of the governing body of any taxing district within the county
- An elected official within the county
- A person employed in or hired by the county or any taxing district within the county
- A former county assessor, or any appointee acting in the place of the assessor that held the office or was appointed during the tax year subject to

appeal to BOPTA, or a person previously employed in or hired by the office of the assessor during the tax year subject to appeal to BOP-TA.

Board members hear petitions for reduction of the real market, maximum assessed, specially assessed, and assessed value of property placed on the roll by the county assessor as of January 1, 2021. The board will also consider requests to waive penalties assessed for the late filing of real and personal property returns.

An initial training session is required for new members and for those members returning after a break in service. Board members are required to attend training approved by the Department of Revenue at least every other year unless no petitions are filed. The BOPTA board generally meets for one or two sessions during the year between February and June. The oneyear term ends on June 30, 2022. If you are interested in being considered for the BOPTA board, please contact the Clerk's office 541-565-3606 no later than Friday, October 2, 2021. BOPTA pool members will be appointed by the county governing body on October 6, 2021.

#### **ED'S ANECDOTES**

My love for ship travel got me searching every summer in magazines like National Geographic. I would plan my vacations and "book" on to various vessels. One such voyage to Europe was aboard the German ship MS Seven Seas. The "Seven Seas" was a school ship at this time so the passage from New York to Le Havre, France was affordable to me. I made my way to the ship terminals in New York and like others was full of great expectations for my cruise to Europe.

When I got aboard ship the cabin was assigned to me with three other passengers. They were all quite friendly with stories about the MS Seven Seas. It was such a fine looking vessel and the first night in the dining room was a sample of how well the dining would be for seven lovely days at sea. The crew aboard the "Seven Seas" were very accommodating with our needs which made every day on board very pleasant.

One evening we had a crew member tell us about the ship and its captain. It wasn't long after World War II so my thoughts shifted when the man talking told us the captain had been a U Boat commander during the World War II years for Germany. After further researching the MS Seven Seas and its incredible history I learned that our ship was then owned by the United States government and during that war it was an aircraft carrier. It was the first ever escort carrier in our navy. Along with 16 planes on the hanger deck and 46 planes on the flight deck it went on to be awarded a battle star for its presence in Guadalcanal. She was named the USS Long Island.

# First Sort: Commingled:

• PAPER - white and colored paper (staples OK) newspapers, magazines, catalogs, junk mail, phone books, paperback books, spiral-bound notebooks, shredded paper in a paper bag, cereal & cracker style boxes (liner removed), cardboard tubes, paper bags, egg cartons, milk cartons & juice boxes.

• PLASTIC - plastic bottles with a neck, plastic tubs 6 oz. to 5 gal, plant containers 4 inches & larger.

• METAL - aluminum cans, tin cans (flattened), clean aluminum foil & foil baking pans, empty aerosol cans (discard cap).

#### Second Sort:

• All glass bottles & jars - rinsed. No lids.

#### **Third Sort:**

• Corrugated cardboard - flattened.

All items should be clean & rinsed with lids removed & flattened if possible.
