On Tuesday, May 17, 2022, the Sherman County Clerk's office will be conducting the 2022 Primary Election by mail. Candidates may file for office at the Clerk's office, 500 Court St, Moro, OR, until 5:00pm, March 8, 2022, by one of the following methods:

File by Fee: Submit form SEL 101 and pay a \$50 filing fee.

File by Petition: Submit form SEL 101 and petition to obtain signatures: SEL 121 (Nonpartisan offices) or SEL 102 (Partisan offices).

# Physician Orders for Life-Sustaining Treatment

Do you have a serious health condition? Have you completed a POLST Form? POLST is a medical order that stands for Physician Order for Life-Sustaining Treatment. It directs your care in a medical crisis. POLST orders give seriously ill people control over the treatments they do or do not want to receive in a medical crisis. POLST is for those with advance illness, such as advanced heart disease, lung disease or cancer that has spread. Or for someone who is older and frail, and may not want to go to the intensive care unit. In a medical crisis, a POLST directs emergency staff to the type of care you do or do not want. EMTs and physicians are required to follow POLST orders. #### NEW Sherman County Housing Programs Approved in 2021

Since 2018, Sherman County has had two housing grant programs that support rehabilitation of non-owner occupied housing properties and the development of new long term rental. The New Rental Housing Development Grant and the Housing Rehabilitation Grant have been successful in helping ease development costs for several property owners. In early 2021, the County added two more housing grant programs to help spur housing development.

The new Housing Property Preparation Grant program is intended to address unsafe, blighted properties in the County and stimulate the housing construction market. It offers reimbursement of 50% of eligible costs, up to \$20,000, to responsibly demolish unsafe housing units and/or clean up any environmental contaminants on a property. The program is not intended for residents seeking to redevelop houses they are living in. Additionally, the grant recipient must put the lot up for sale or start construction on a new housing unit within 90 days after the project is complete.

The New Housing Construction Grant program will provide \$10,000 for newly constructed housing units. Single family or multi-family housing units are eligible, as are stick-built units or a new manufactured home if it is double-wide or larger and on a permanent foundation.

Nancy and I did the historical research and Julie did the graphic design. We presented it to the school in October 2019 and a large poster version of it hangs in the school. It was a fascinating project and we are very proud of the way it turned out.

When asked for highlights of volunteering, this is what Janet had to say.... The SMART/SCHoLaRS reading program. I knew when I retired in 2014 that I would need something to do that would give me a sense of purpose. My lifelong love of reading spurred me to start the SMART reading program in Sherman County (actually re-start it; it had existed in the past) in 2014. After three years of learning how to organize and run that program, we decided to do it on our own and we created the "Sherman County Huskies Love Reading" program, or SCHoLaRs. I organize the adult volunteers who come in to read with selected students in grades K-3 twice a week. We also give books to kids periodically. It has been a tremendously rewarding program for all involved, I believe, and I can't wait until we can get back to doing it! Advice: If you are thinking of volunteering, choose something that you love to do and do something connected with that.

Janet added that she has lived and taught in other areas in Washington and Oregon and this county has something very special. Kids grow up here with a sense of community-mindedness and the idea of giving back is natural. We come together here to do things to help kids and others as naturally as breathing. That isn't the case everywhere and I think our students fare better in the world because of that upbringing.

Sherman County is a better place because of its many volunteers. Thank you to Janet and all of the many other volunteers that make this county great!

# Herbicides for Annual Grass Control Webinar

Thursday, October 21, 1-1:50 pm. This free webinar put on by Jacob Powell with OSU Extension Service will provide an overview of herbicides to consider for annual grass control in crops, pastures, and rangelands. In addition, he will cover his research on cheatgrass control with Zidua and Ryz Up Smartgrass in winter wheat. RyzUp Smartgrass is a plant growth regulator spray formulation containing gibberellic acid (GA3). The addition of RyzUp Smart-grass with Ziuda reduced cheatgrass cover to 12% while cheatgrass cover was reduced to 27% with Zidua alone. # AMBULANCE MEMBERSHIP FOR CHRISTMAS

Do you have that special someone who you just don't know what to get for Christmas? If you do and they live in Sherman County, think about an Ambulance Membership. Sherman County Ambulance has a membership program, which costs \$30 per household, per year. Also, you might think about getting a Membership for yourself, if you haven't already. This is a huge savings if you don't have insurance. An average ambulance call can be around \$2,500. The Ambulance Membership Program is also part of the reciprocal network with approximately 80 other agencies in Oregon. That means that if you need an ambulance in another city and they are part of the network, your Sherman County Ambulance Membership will cover that. If you do have insurance, we will still bill for the call, but if it doesn't pay the entire bill, the Membership will cover the balance. If you don't have insurance, the Membership covers the entire bill. If purchasing for a gift, we will send you a holiday inspired gift certificate to give to your loved one. However, the units must be sold or occupied by the owner within 30 days of completing the project and cannot be used as a second home or short-term rental.

All grant program applications can be found on Sherman County's website. All housing grant decisions are made by Sherman County with the help of an appointed Housing Grant Review Committee. Mid-Columbia Economic Development District (MCEDD) is supporting the County in administering these programs. Earlier this summer, Sherman County teamed up with Wasco County for Parole and Probation Services. Two local Sherman County residents, along with the rest of Wasco County's P & P staff provide these needed services.

Sherman County's Prevention Coordinator Amy, is moving on. Good Luck! The program has been successful while you were at the helm.

Ryan LeBlanc of Sage Technologies has recently been hired to manage Frontier TeleNet. Frontier TeleNet is a three county entity that owns and manages the infrastructure that supports our 911 communications backbone in Sherman, Wheeler, Gilliam and Jefferson Counties.

U.S. Congressman Cliff Bentz spent part of an afternoon in Moro to talk to our Sherman County residents last month. Several gubitorial candidates also have spent time in Moro meeting people and campaigning this past summer.

Sherman County according to the Oregon Blue Book has 1795 people living within its boundaries in 2020. We are the 2<sup>nd</sup> least populated county in the state. Our incorporated town populations are as such: Grass Valley 165 this is up 1 from 2010 and is the 227<sup>th</sup> on the list of town size in the state. Moro 340 this is up 16 and is 206<sup>th</sup> on the list. Rufus 290 up 41 and is 211<sup>th</sup>, and Wasco comes in at 425 up 15 and is 200<sup>th</sup> on the list. There is a total of 241 incorporated towns/cities in Oregon.
