- Candidate will be sent a write-in acceptance form, if elected. If acceptance form is received by deadline, Certificate of Election will be issued.
- Nominator and candidate must be a member of the same party and the same State Representative district, within the same county.

to 19 (as of September 1, 2021). The divisions are: Juniors ages 9-11; Intermediates ages 12-14; and Seniors 15-19 (and still in high school). Enrollment is \$30/youth, with a discount for multiple children from one family.

4-H is "learning by doing"....a youth development program where kids get to do things usually only adults do......select, care for and raise livestock, take photographs for exhibition, learn how to cook a variety of foods, participate in clinics and workshops to learn more about livestock or healthy living, sew their own clothing or craft items for home, make money and keep track of records, cook outdoors and learn how to can fruit or make jerky, be part of an organization and participate in meetings virtually and in-person, and more.

We've got a great bunch of volunteer leaders and board members for Sherman County 4-H, including a number of new folks. Clubs this year will be: horse, beef, sheep, swine, goat, rabbit, poultry, photography and outdoor cooking/food preservation. Due to challenges of Covid restrictions, unfortunately we will not be able to offer 4-H sewing or indoor cooking this year.

OSU Sherman Extension continues to offer "Extension Afterschool" on Tuesdays, giving youth an opportunity to experience a variety of activities. These have included science and the galaxy, building with cardboard and plastic connectors, fall and Thanksgiving arts and crafts, stitchery and hand sewing, and making pet treats and toys. Lower Deschutes Cooperative Weed Management Area Is Hiring A Weed Technician

Primary job duties include: surveying and treating noxious weeds within the Deschutes river corridor as part of a team, measuring/mixing and applying herbicides, using ArcGIS for collected GPS waypoints and data.

- Full-time seasonal position with no benefits, \$17.20/hr.
- Must be able to pass a criminal background check.
- Successful candidate must obtain their Public Pesticide Apprentice License within 1 month of employment.
- Technician must be able to hike in steep, uneven terrain with up to 50 lb. packs.
- Technician will work outside during all types of weather respective to Central OR.
- Mechanical, biological, and chemical treatments will be conducted on targeted weed infestations.

- Technician will be responsible for maintaining, servicing, and repairing equipment.
- Experience operating off-road vehicles, pulling a trailer, identifying noxious weeds, applying herbicides, and using ArcGIS is a plus.
- Should be willing to camp in the field for up to a full workweek at a time.
- Employment is funding and weather dependent; tentative start date of 3/7/22, tentative end date 10/28/2022.

This is a great opportunity to get involved in a habitat management project on the beautiful Lower Deschutes River, while gaining experience with ArcGIS, mapping, and interacting with the public

The Judge's Corner

As I write this I have my granddaughter sitting on my lap watching a kid's program on my iPad. Not sure what it is called but she explained to me how to find the page on Netflix and she chose what she is watching. This means I am multitasking. I'm working and babysitting. That could be a benefit from the crazy situation we are living with – we all had to learn how to navigate the internet, Zoom, Gotomeets and other made up words.

Speaking of multi-tasking, the Sherman County Court is preparing for budget season. The county budget is only one of the many budgets that the commissioners and I are involved in. I am part of the budget process for NORCOR, (our community jail), Biggs Service District, Frontier Regional 911, Frontier TeleNet, and MCEDD (Mid-Columbia Economic Development District) just to name a few Both County Commissioners are part of just as many budget committees.

One budget has recently received some help. The Kent water tank project just got a community grant for \$20,000 from TC Energy. TC Energy is the owner of the natural gas pumping station south east of Kent. This water tank will provide clean water for the community of Kent, and during fire season there will be a much greater volume of water available to assist the heroes that fight those fires.

When I speak of water projects I need to inform everyone that the water project in Biggs Jct. will be starting the first of March. There will be some inconvenience for us all. If you drive Highway 30, (the old highway) you will notice the enclosed area, pipe and equipment north of the road just west of Pilot's parking lot. This is the staging area. Expect delays when it starts. It should be completed late summer. The project will include a 400,000 gallon tank on the hill above Jack's, new 12 inch water main lines west of Spanish Hollow Creek, 8 inch crossing the bridge to the east and fire hydrants throughout Biggs Junction. As always, please drive safely and watch out for the construction workers.

FYI Just the other day I received an email requesting that I complete a survey on what our community is doing to combat climate change. Usually most of the unsolicited unknown emails I receive, I am hesitant to respond to due to cyber security. This one I am tempted to send a video of the 649 wind turbines and nearly 100 acres of solar panels that produce 1200 Megawatts of energy in Sherman County as a response.

I was told this morning in a meeting that there are over 90 bills introduced by state senators and twice that introduced by state representatives for this short legislative session. I am not sure if that is a contradiction to the following quote – I will leave that judgment to you!

Farm First Aid

Farm first aid training will be offered virtually from 1-3pm on Wednesday, February 2nd via Zoom. In person training will be from 10 am -12:30 pm on Friday, February 25th at the Wasco County Extension Office in The Dalles (3rd floor lecture hall, building 2, Columbia Gorge Community College). General first aid considerations for

farmers and ranchers will be covered with a focus on trauma in agricultural accidents. The training will feature Eric Lloyd with Oregon Risk Management Solutions, Inc. and Jacob Powell, OSU General Agricultural Extension Agent. Certificates of attendance will be given. Both classes cost \$15 per person, paid at the door by cash or check, or for the virtual class by credit card at this link: https://beav.es/UvL. Registration is required at the link above or if paying via mail or in person please call 541-565-3230 or email jacob.powell@oregonstate.edu Per state guidelines, masks and social distancing will be required and enforced for all attendees.

AG Wildfire Training

OSU Extension is putting on a free Ag Wildfire Training held virtually on February 16th (1-4pm) and in person on February 23rd (1-4 pm) at the Wasco County Extension Office in The Dalles (3rd floor lecture hall, building 2, Columbia Gorge Community College). This training is intended for both agricultural producers and those living in more rural areas in Sherman and Wasco Counties. Speakers include Wasco County Sherriff Magill providing an overview of the Incident Command Structure (ICS), Katie Wollstein, OSU Rangeland Fire Specialist, covering rangeland fuels and fire risk reduction. Marvin Vetter, ODF State RFPA Coordinator, will also be present and briefly talk about the new RFPAs (Rangeland Fire Protection Associations) being

created locally throughout the state. Jacob Powell will cover innovative ag fire suppression equipment, defensible space, and the use of vegetative fuels breaks, including ongoing local research with Forage Kochia. In addition, Ryan Scholz, State Veterinarian with ODA will provide an update on work being done to improve livestock evacuation. If Stranded in a Vehicle

If you are stranded in a vehicle, stay in the vehicle. Call for emergency assistance if needed, response time may be slow in severe winter weather conditions. Do not leave the vehicle to search for assistance unless help is visible within 100 yards. You may become disoriented and get lost in blowing and drifting snow. Display a trouble sign by hanging a brightly colored cloth on the vehicle's radio antenna and raising the hood. Turn on the vehicle's engine for about 10 minutes each hour and run the heat to keep warm. Also, turn on the vehicle's dome light when the vehicle is running as an additional signal. Beware of carbon monoxide poisoning. Keep the exhaust pipe clear of snow, and open a downwind window slightly for ventilation.

Watch for signs

of frostbite and hypothermia. Do minor exercises to maintain good blood circulation in your body. Clap hands and

move arms and legs occasionally. Try not to stay in one position for too long. Stay awake, you will be less vulnerable to cold-related health problems. Use blankets, newspapers, maps, and even the removable car mats for added insulation. Avoid overexertion since cold weather puts an added strain on the heart. Unaccustomed exercise such as shoveling snow or pushing a vehicle can bring on a heart attack or make other medical conditions worse.

An emergency Kit is Recommended

- Cellphone or two-way radio
- Windshield ice scraper
- Snow brush
- Flashlight with extra batteries
- Shovel
- Tow chain
- Traction aids (bag of sand or cat litter)
- Emergency flares
- Jumper cables
- Snacks
- Water
- Road maps Blankets, change of clothes

- PAPER white and colored paper (staples OK) newspapers, magazines, catalogs, junk mail, phone books, paperback books, spiral-bound notebooks, cereal & cracker style boxes (liner removed), cardboard tubes, paper bags, egg cartons, milk cartons & juice boxes.
- PLASTIC plastic bottles, #1 & #2 with a neck.
 Examples; beverages, milk jugs, shampoo, detergent, cleaners (rinse & remove caps)
- METAL aluminum cans, tin cans (flattened), clean aluminum foil & foil baking pans, empty aerosol cans (discard cap).
