Rod Asher, Weed District Supervisor, gave an overview of his quarterly report.

### Personnel

Macnab has continued to work part-time this spring to help with spraying. This may end at any time. The work load and crew level are being evaluated. A replacement may need to be found.

Holeman has been hired as the Lower Deschutes CWMA Coordinator. He has worked with us as a seasonal employee over the years and since March of 2021. Funding partners for this position (County at 36%) have been consulted and have welcomed him to the position. Holeman has done a great job keeping the program running this season.

## **Facilities**

All repairs to the Weed Shop and equipment have been completed since the October break-in and theft. Total damage was \$5,642.62. This has effected the annual budget with unexpected expenses.

The issue has been discussed at the Safety Committee meetings with the recommendation to consider cameras at the Weed Shop. Nothing has happened at this time.

#### **Equipment**

The new Road-side spray truck for County Roads was ordered June 01, 2021 and we took delivery on February 10, 2022. The truck was delivered that week to the spray truck builder in Cheney, WA, Ag Enterprises. We are waiting for the final build to take place in May, early June. The Current Road Dept. truck has been used for this spring season.

County Court Minutes - 05/04/2022

The new lawn mower for Grounds was used this fall and the bagging system proved worthwhile for picking up leaves.

Some equipment is being considered to be declared surplus – the old John Deere mower with blown engine, a 2000 Honda four wheeler and a small, 5 x 8 foot trailer. Also a small snow-thrower is being considered to give to the Moro Senior housing property for their efforts to keep their sidewalks clear. We have a larger one in-service.

We are requesting to replace one of our oldest side-by-sides (2013 Polaris Ranger) this year in the budget. The older machine will be kept and used as a back-up.

We are also applying for a grant to replace the CWMA side-by-side (2013 Kubota) and also keep the old machine as a back-up.

### Weed Board

The Board is fully staffed and continues to meet on a quarterly basis (Feb, May, Sept, Dec). Issues discussed include the weed list, product shortages and specific weed issues, among others.

# Project / Contracts

This spring has been spent spraying County roads and State highways; wind and solar farm towers, substations, roads and buildings; County properties; Cities and various private properties and businesses. The 'work-load' seems to be close to normal at the end of COVID.

#### Grounds

Mowing has started but the sprinklers have not been turned on yet due to the late winter conditions. This will probably change this week or next.

We had some large tree limbs down at DeMoss recently. They were taken care of after PP&L was contacted for limb removal on a power line. At this time we do not have a tree trimmer on 'retainer' as we have in the past.

Both parking lots at DeMoss and the Senior Center have cracks in the pavement that need attention. We will talk with the Road Department, to see if they can help. Otherwise it may need to be an outside contractor.

The rear parking lot at the Court House continues to be a problem in icy conditions, regardless of the crew's efforts. Consideration might be needed to re-surface the area, if appropriate.

DeMoss Park continues to have its issues, including the pavilion structural problems and a lack of lighting in the parking lot.

Commissioner Bird stated that CAPECO did discuss at their last meeting that they would be sending ARPA money to the Senior Center to help offset rises food costs.

In Kari Silcox's report and subsequent email, she asked County Court to give feedback on raises the meal prices by \$1.00. The meal prices have not been increased in many years, but food prices have gone up drastically in the last couple of years. County Court's consensus was to increase the meal prices by \$1.00. Meal pricing will go up to Under 60 Years old will be \$8.00 per meal and 60 years old and up will be \$5.00 per meal suggested donation.

The other idea that Kari wanted feedback on was cutting the hours of the kitchen assistant. County Court was not in favor of this at all.
