Georgia Macnab, Planning Department, reviewed the Comprehensive Economic Development Strategy (CEDS) list with the County Court; she will send it to Mid-Columbia Economic Development District for their board to officially rank the projects. Georgia reminded County Court they needed to rank the list for the top 10 projects.

Hannah Fatland, Sherman County Watershed Council, came to County Court to give a Watershed Council update.

Lower Grass Valley Canyon Weed Control

- Weed grants funded by the Oregon State Weed Board. A part of an ongoing effort to treat a variety of weeds in the uplands and riparian areas of Lower Grass Valley Canyon.
- Elimination and containment of noxious weeds to prevent further encroachment and to increase habitat.

Lower Grass Valley Canyon Upland Restoration

- 2018 OWEB funded project to address upland issues by implementing restoration practices; including water and sediment control basins (WASCBs), terrace reshapes, wildlife watering facilities/water developments, and upland/range seedings.
- Received Grant extension to allow participants more time to complete projects and to include additional participants within the watershed.

Lower Grass Valley Canyon Structural Restoration

- Recently funded OWEB project to create plans and obtain permits for the implementation of Beaver Dam Analogs (BDAs) over 5 miles of Lower Grass Valley Canyon.
- Plans will identify where and what types of structures should be placed within the creek.

Future Projects

 A primary function of the Sherman County Area Watershed Council is to provide natural resource outreach and education. However, funding is very difficult to find. The Sherman County Area Watershed Council will be looking for funds to provide natural resource conservation education to Sherman County schools and hope to have more of a presence within them in the future.

Nicole Strong representing OSU Extension discussed with County Court the retirement of Sue Mabe as the Sherman County Extension Office Secretary. The discussion included going over a draft job description and finalizing the job description to start advertising the job opening. It was decided that the County Court would assume the overall supervisory role for this position since county funds pay for this .80 position. OSU does pay .10 for the seed certification duties but that is a separate check that is only paid when duties are performed a few times a year outside of normal job hours.

Hopeful timeline: Advertise job for two weeks. Applications due by March 7th. Interviews on March 10th. Potential start date March 28th. Sue's last day is March 31st. Sue has agreed to come back and train as needed.
