# 1.0 Appointment Schedule

Kristi Weis, Sherman County Clerk, gave her quarterly report. Some of the highlights from the report were:

- Redistricting maps have been completed
- There were no BOPTA filings
- County building appraisals have been completed.

Kristi explained that there is a \$2 million dollar Election Modernization Bill and currently the state is working out the details of the money. The money could stay at the state level or possibly part of it stay at the state level and the other part be given to the counties. Kristi says that if Sherman County gets part of this money that the Clerk's Office would probably purchase cameras for the ballot boxes that are in the different areas throughout the county.

Kristi also mentioned that she will need to hire a temporary employee from April through June while her deputy clerk is on maternity leave.

Bob Thomas, Wildlife Specialist, gave his quarterly report. Bob talked about the activity that he has been seeing in the last several months which includes:

- Raccoons killed a guinea pig
- Coyotes killed fall calves
- Coyotes killed turkeys
- Bobcat killed chickens and barn cats

Bob talked about being the 'Dog Deputy' for the Sheriff's Office. Bob is not an official member of the Sheriff's Office but he does help out as needed in traffic accidents, during an arrest if there is potential for an animal to need assistance, and other like instances. Bob is working with the Sheriff's Office to get a shirt to make him look more official so when he shows up at a scene people know that he belongs there.

# Jacque Schei gave highlights from her MCEDD quarterly report.

MCEDD has posted a draft of the 2022-2027 CEDS update for public comment. It can be found on our website. The draft was presented at the annual Columbia Gorge Economic Symposium in November. Staff coordinated with Sherman County Planning and North Central Regional Solutions to plan for an outreach meeting focused on projects from communities and organizations around the County. The meeting is scheduled for late January in order to provide additional opportunity to engage with project owners in advance of the priority project list development by the County Court in February.

Staff worked with three recent applicants of the New Housing Construction Grant to file restrictive covenants per the updated terms of the program. Final paperwork for these applicants was submitted and approved for payment by the County Judge.

Continued to engage with Wasco School Event Center staff to refine the business plan, specifically documenting financial information. Staff anticipates some additional feedback to revise the plan and expects to have a final version in early January. The Center also presented details of their operations to the City of Wasco and staff provided some considerations for to support the discussion in terms of funding.

Staff talked with a resident about the future of the dance school in Wasco. The school is shutting down because they cannot sustain the organization as a private business. A group of parents is interested in setting up a nonprofit organization to continue running the dance school. Staff reviewed work required to set up a nonprofit organization, possible sources of grant funding if the school had nonprofit status and outlined some considerations the group should discuss before moving forward with setting up a nonprofit.

# 1.5 10:00 a.m. 10:12 a.m. OSU Extension Quarterly Report

Present: Cindy Brown, Jacob Powell, Mike McArthur, Audrey Rooney

Jacob Powell, Agriculture Extension Faculty, gave his quarterly report. Jacob stated that he held a pesticide course at the Sherman County Extension Conference Room on December 14<sup>th</sup>. Jacob also discussed the upcoming agriculture specific first aid class that will be held on January 19<sup>th</sup> in-person. A virtual first aid class will be held from 1-3pm on Wednesday, February 2<sub>nd</sub> via Zoom. General first aid considerations for farmers and ranchers will be covered with a focus on trauma in agricultural accidents. The training will feature Eric Lloyd with Oregon Risk Management Solutions, Inc. and Jacob Powell, OSU General Agricultural Extension Agent.

Similar to the last two years, OSU Extension is putting on a free Ag Wildfire Training held virtually on February 16th (1-4pm) and in person on February 23rd (1-4 pm) at the Wasco County Extension Office in The Dalles. Jacob Powell will cover innovative ag fire suppression equipment, defensible space, and the use of vegetative fuels breaks, including ongoing local research with Forage Kochia, Yarrow, and Flax.

Cindy Brown, OSU Extension Service and 4-H Development, gave her quarterly report. Cindy stated that a new year of 4-H has started this fall. 4-H is continuing with a smaller list of clubs in Sherman County due to the pandemic and 4-H requirements. The 4-H clubs this year will be: livestock, photography and outdoor cooking.

Cindy mentioned that she is currently taking a class on "Living with Chronic Conditions" and sees its real potential to help residents in Sherman County. Cindy asked County Court for their support in taking a training that starts this February that would qualify her to be a facilitator to hold meetings locally. Cindy did mention that in order to start facilitating meetings in the county, she would need at least one more person trained to facilitate. The Court suggested Cindy talk to Deanna Christiansen in Prevention. This training helps people gain confidence and hope. 6 out of 10 adults live with chronic conditions.
