Opened Public Hearing on USDA Rural Development, Community Facility Grant Program for funding of 2 additional broadband solar trailers for \$50,000 at 9:00 a.m.

Closed public hearing at 9:36 a.m. There were no public comments.

Brittany Wood, Moro City Administrator, did attend County Court and did ask questions regarding the mobile speed radar trailers that had been discussed at previous meetings. Brittany just wanted to know more about the radar trailers, if any were being purchased, who would move them, who would decide where to put them, etc. Commissioner Miller suggested that Brittany talk to Moro City Council members to see exactly what Moro had decided to do about the radar trailers. County Court was under the impression that Moro was going to purchase a couple of radar trailers without asking for assistance from the county.

**2.1** EMPG Grant 2022-2023

Motion by Commissioner Miller, second by Commissioner Bird, to approve the Emergency Management Grant 2022-2023 which is a federal grant for \$55,086 and matching funds of \$55,086 from Sherman County for a total project funds of \$110,172 which covers the cost of the Sherman County Emergency Services Director position and authorize Judge Dabulskis to sign.

## 3.1 Library

#### 3.2 Transit Vehicle List

The Pit Stop in Kent hopes to open soon and one of the last hurdles is to get the sewer inspection done and signed off. There are no recent records regarding the sewer for this address and that is worrisome to the owner. The owner is reaching out to see what resources are available if the sewer needs updates or a complete overhaul. The owner is trying to make sure that he is ready for whatever the inspection results are.
