
#### 1.0 Appointment Schedule

## 1.1 9:00 a.m. Fritz Bachman, Sherman County Community Corrections Quarterly Report

Present: Fritz Bachman, Verna McClennan, Audrey Rooney

Fritz Bachman, Director of Community Corrections, presented his quarterly report. Fritz stated that while much of our business at Community Corrections this past quarter has been "routine" there are some highlights to mention.

• Sherman County's supervised population remains fairly flat, between 15 and 20 actively supervised. Statewide, caseloads plummeted during COVID. The State's projection is that they will climb again. In the meantime, the overall offender population snapshot negatively impacts our budget. Numbers are not final but baseline State funding will likely decrease at least 10% without separate support for the work. There are discussions at the Legislature about whether the formula for funding Community Corrections needs to be changed.



- Wasco and Sherman County are applying for a State IMPACTS grant, primarily to target frequent utilizers with low-barrier housing to reduce use of the hospital and jail. Hood River is applying separately for the grant as well, to support shelter/housing services. A portion of this grant will fund an update to our region's Frequent Utilizer Report, covering all 4 NORCOR counties. I've used the original 2017 report extensively for grants over the years. Sherman LPSCC will be receiving the updated report once it is completed at the end of this calendar year.
- Senate Bill 48 replaces all court bail schedules with release criteria based on community/victim risk and likely hood to appear in court. This is commonly called pre-trial release. Individuals on supervision are not subject to release under pre-trial, as our sanctioning process does not involve the court unless a formal probation violation is filed. Bottom line, people on supervision who have violated will be held in jail.
- Our PO Shandie Johnson is leaving us in July, appointed by the governor to be Sherman County's Justice of the Peace. This is a loss for us but a gain more directly to Sherman County.
- With Chris Carey's retirement at the end of last year, I've selected Shawn Sorensen to be the office's Lead PO. This will support my role as director and provide more operational direction to all the POs day-to-day and when I'm not in the office.

## 1.2 9:30 a.m. Ron McDermid, Justice Court Quarterly Report

Shandie Johnson has been training on Fridays while finishing out her other job; she is working 4/10's. The plan is to swear in Shandie as the new Justice of the Peace on August 1, 2022. Shandie will swear in Ron as the pro tem Justice Court Judge for Sherman County. She will hold court appointments on August 2<sup>nd</sup> and 3<sup>rd</sup> and then she will be on vacation until August 24<sup>th</sup>. Ron McDermid will work two days a week holding appointments while Shandie is gone. Ron will be training Shandie until September 15, two days a week.

Mark Coles came to County Court to discuss the current county policy on residents purchasing rock from the county. Mark mentioned that the current policy states that the County can sell a max of 200 yards per household per calendar year at a cost of 10% higher cost than buying commercial. This is to discourage residents from wanting to purchase rock from the county. The county offered to sell rock to residents at a time when there were no local businesses. Now there are at least three local businesses, so Mark is encouraging County Court to change the policy.

- \* Commissioner Miller has not talked to Mark, Commissioner Bird, or Judge Dabulskis regarding this issue and will refrain from voting due to his brother being in this business.
- \*\* County Court did state that they will need to readdress this issue regarding county projects and special districts.

County Court thanked Mark and his department for taking care of the roads.

The County Court was asked to re-consider the current policy regarding Holiday Pay that states: "Holiday pay will be calculated based on the employee's straight –time pay rate (as of the date of the holiday) times the number of hours the employee would otherwise have worked on that day".

Employees working 4-10 hour days per week receive 10 hours pay each holiday while those working 5-8 hour days per week receive 8 hours pay for each holiday.

The County Court had asked for department heads to respond and after hearing those that that did, decided to leave the policy as is.
